



## BOX FOR SUPPLYING BUSINESS-CARDS.

Specification of Letters Patent No. 10,255, dated November 22, 1853.

To all whom it may concern:

Be it known that we, William Lewis and William H. Lewis, of the city, county, and State of New York, have invented, made, and applied to use a new and useful Means for Supplying Business or Similar Cards; and we do hereby declare that the following is a full, clear, and exact description of the construction and operation of the same, ref
10 erence being had to the annexed drawing, making part of this specification, wherein—

Figure 1, is a sectional plan. Fig. 2, is a longitudinal section and Fig. 3, is a cross

section of our apparatus.

The like marks of reference designate the

same parts.

The object of our invention is to furnish a means whereby any party can take from a case one card at a time, thereby in stores, 20 hotels or similar places, those desirous of the name and address of parties in a given business, can take one card and no more from a box at each pull of a handle attached to a slide; thus avoiding what is often done, of a 25 whole pack or a great number of cards being taken by one person out of mischief or malice.

a, are the sides; b, the front; and c, the top of a box, which may be of any desired shape or size, and of any material; we propose in some cases to make this of metal and in an ornamental form.

d, is the back which is shown movable and secured by a spring, by which the cards are placed within the box, this however may be

fitted as most convenient.

e, e, are slides taking the cross piece k, of the slide f, which slide has a motion of about one and a half inches as seen in Fig. 1. The 40 slide f, passes through the front b, terminating with a handle 3. The slide f, is drawn back by an india rubber or other contractile spring, in a recess on the under side of the slide, one end being attached to the slide, the 45 other to a cross piece 4, at the back.

1, is a lip or edge of hard metal attached to the back of the cross piece k, raised above the surface thereof about the thickness of

one card.

i, is a gate or slide near the front b, kept

down by a spring 5, or competent weight, the lower edge of this is beveled as shown. A narrow slit 6, the width of the inside of the box is formed in the front b, above the slide f.

g, Fig. 2, represents the cards within the box which are kept onto the slide f, by

means of a weight h.

The operation is that a person desirous of a card pulls the handle 3, (the box may be 60 made to show its use, by having painted or otherwise formed on the front "Take a card" and "Pull,") and as he pulls the handle and slide f, the lip 1, takes one card and forces it under the gate i, lifting the 65 same sufficiently by its inclined lower edge, pulling the card out through the mouth 6, about half way, and on letting go of the handle the spring 2, brings the slide back ready for taking another card; the card that 70 was protruded being pulled out by the fingers. The gate i, keeps all but the under card back and prevents clogging and the weight h, keeps the cards down with the same force until all are removed by the suc- 75 cessive pulls on the slide.

It will be evident that in place of the weight h, a spring may be used, and that the apparatus may be fitted so that the cards stand up on their edges instead of lying 80 horizontal, the mouth and slide in that case

being also vertical.

We are aware that various apparatus has been used for supplying cards to be printed but we are not aware of the slide f, lip 1, 85 and gate i, having been used for the purpose and as specified.

Therefore we claim—

The lip 1, on the slide f, combined with the gate i to draw out one card at a time as 90 specified, described and shown.
