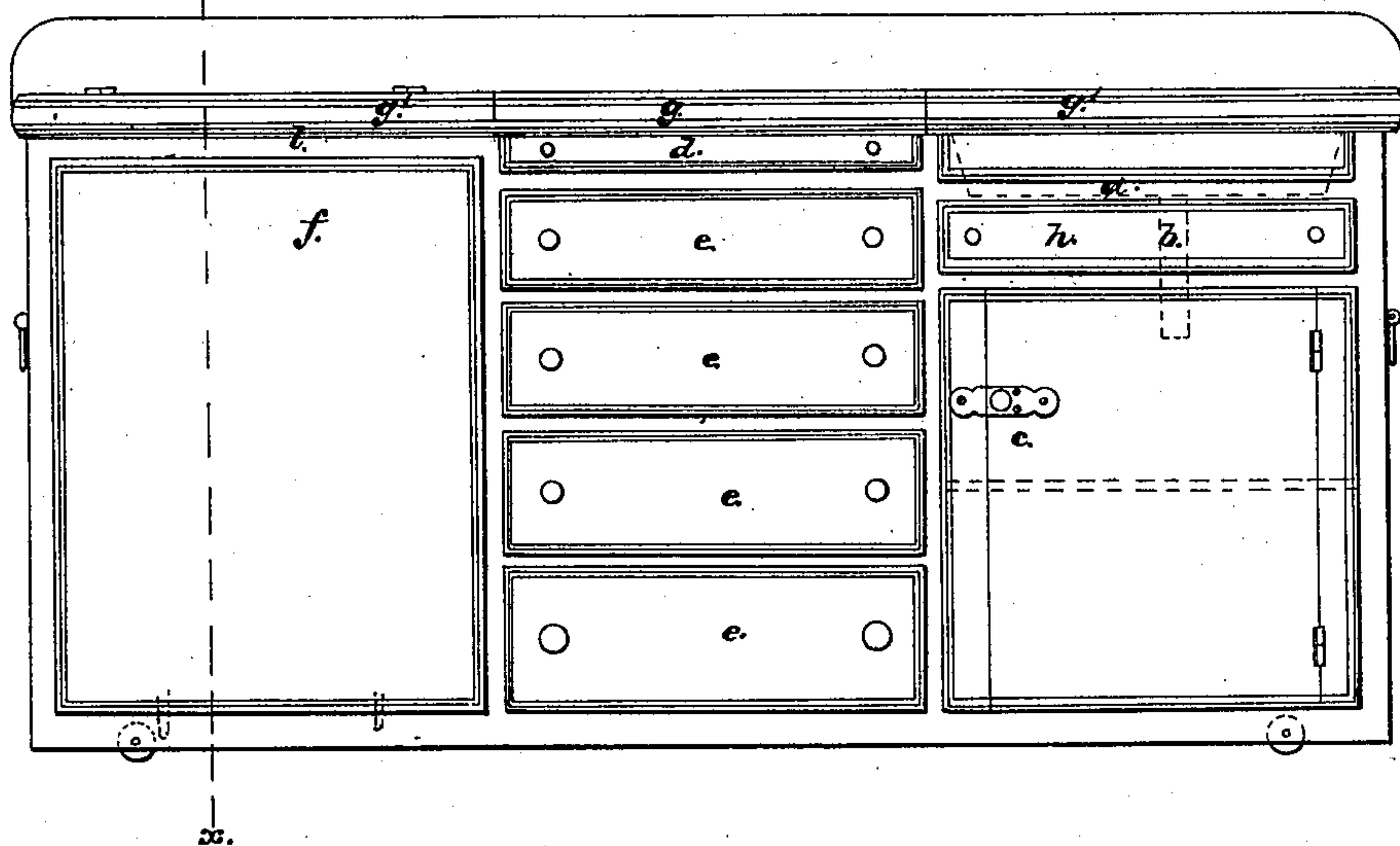

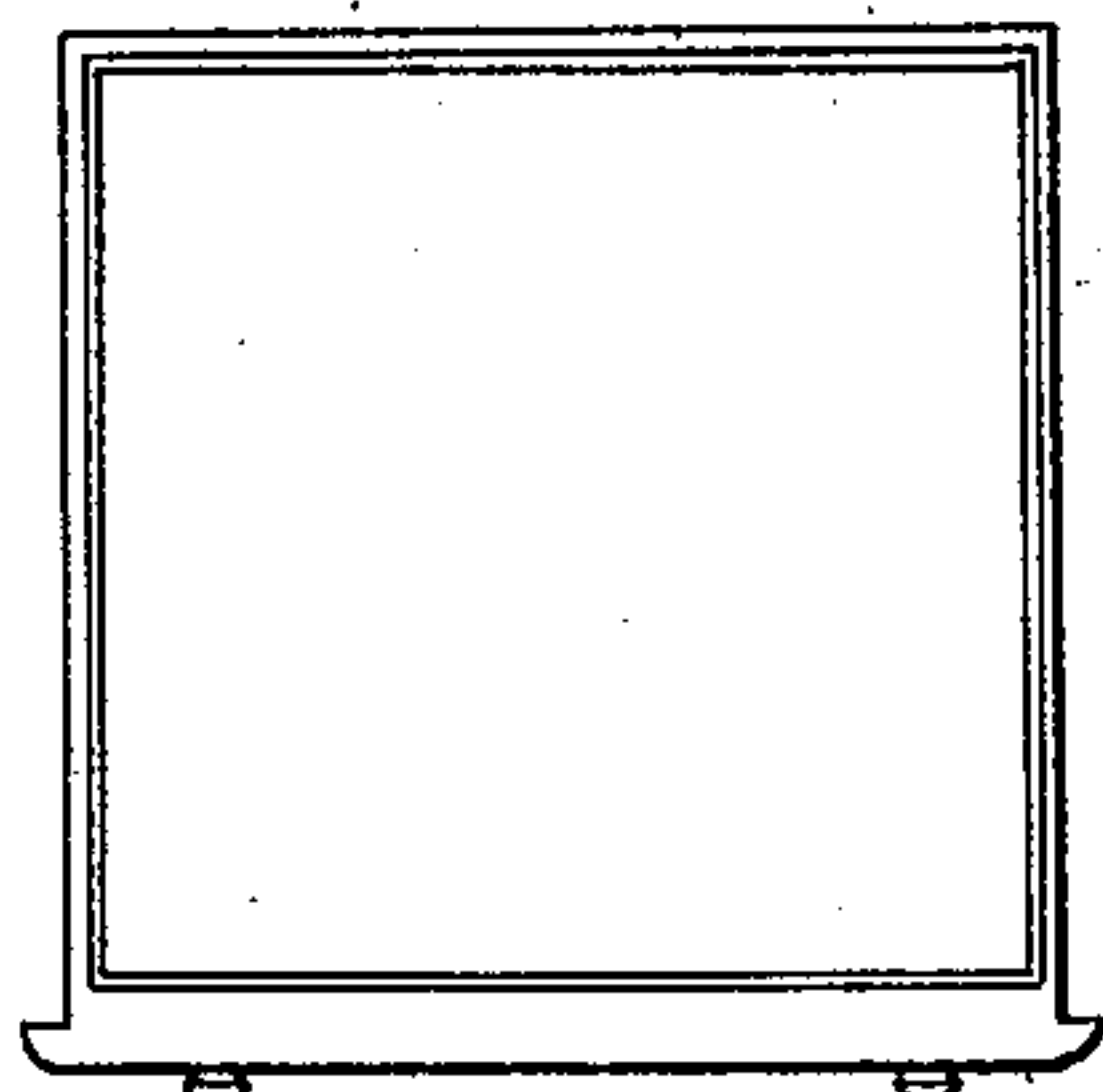

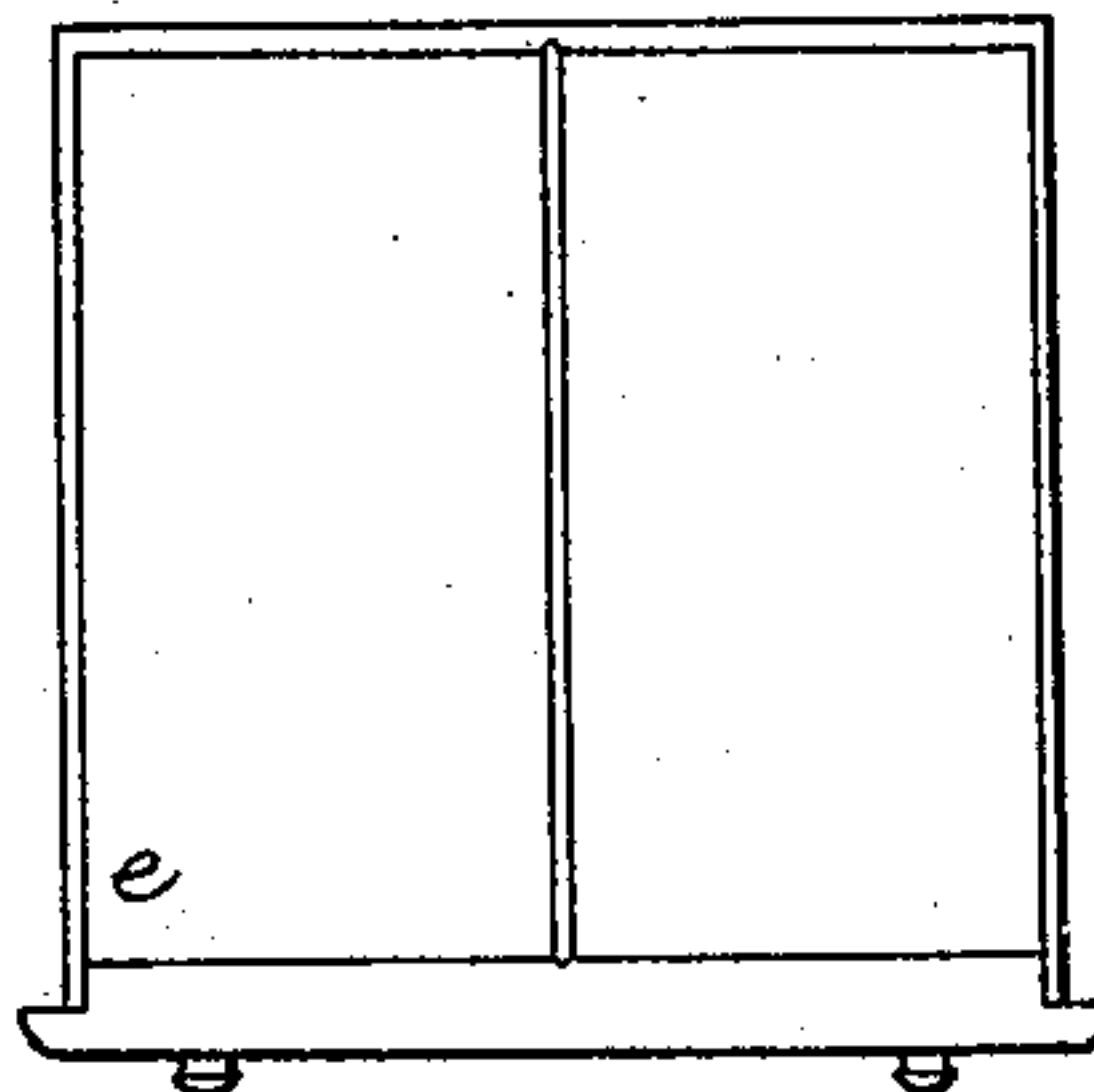

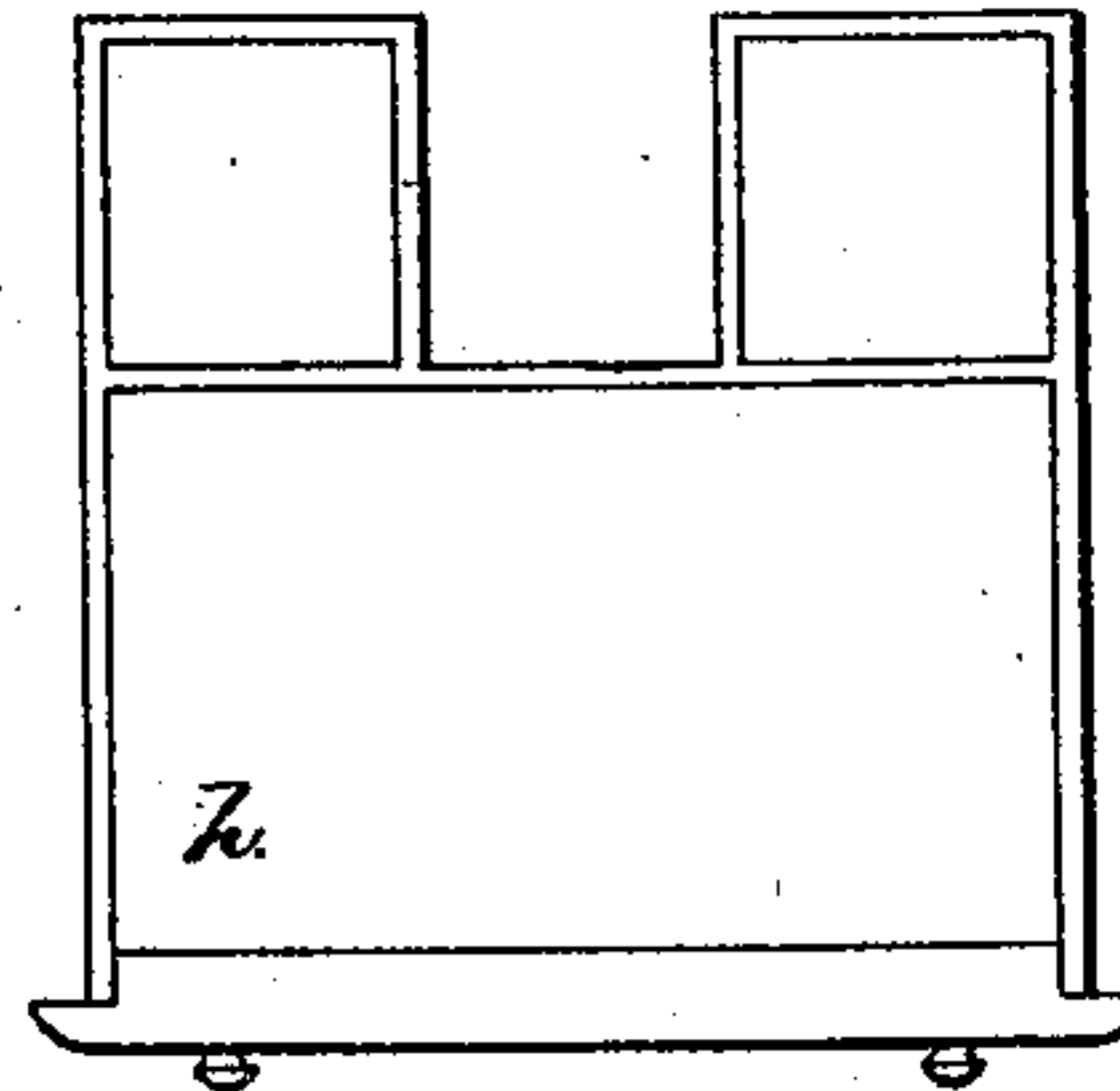
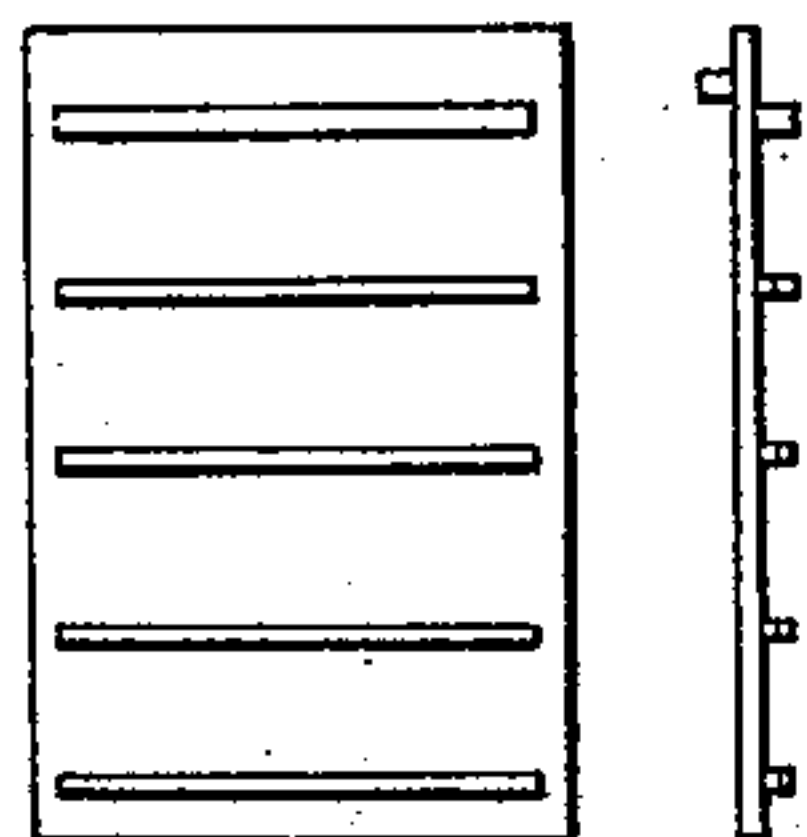


Fig. 7. Fig. 8.

JOB SHATTUCK, OF BROOKLINE, ASSIGNOR TO HIMSELF AND JOHN S. PROCTOR, OF MASON, NEW HAMPSHIRE.

IMPROVED PANTRY.

Specification forming part of Letters Patent No. 48,631, dated July 4, 1865.

To all whom it may concern:

Be it known that I, JOB SHATTUCK, of Brookline, county of Hillsborough, and State of New Hampshire, have invented a new and Improved Portable Pantry; and I do hereby declare that the following is a full and exact description thereof, reference being had to the accompanying drawings, and to the letters of reference marked thereon.

The nature of my invention consists in the combination of a sink with a closet for dishes and kitchen-stores, a closet for receiving a barrel of flour, together with several drawers, a molding-board and ironing-board, and all, when so combined and ready for use, portable or movable from place to place or from one house to another.

In order to enable others skilled in the art to make and use my invention, I will proceed to describe its construction and to state the uses of its various parts.

Figure 1 of the accompanying drawings represents a front view of the pantry. In this drawing, *a* represents the sink; *b*, the pipe for conducting the water from the sink to the closet below or to a point outside the pantry; *h*, a drawer under the sink, Fig. 6 being a top view of such drawer; *c*, a closet under the sink; *e e e*, are drawers for meal, flour, or other articles, Fig. 5 being a top view of one of these

drawers; *d*, a molding-board, which is also shown in Fig. 4; *g' g g'* is the top of the pantry, and may be used as an ironing-board. The parts *g' g g'* are hung upon hinges, and may be raised so as to expose the sink on the right hand and the top of the flour-barrel on the left hand. *f* is the door of a closet, which is designed to receive a barrel of flour for use. The door is taken out so as to admit the barrel by first removing the horizontal bar *l* and then raising the door perpendicularly.

Fig. 2 is a top view of the end of the bar *l*.

Fig. 3 represents a vertical section through the door *f* and the horizontal bar or fastening *l*.

Fig. 7 is a top view of the dish-drainer, and Fig. 8 shows a section of the drainer.

I do not claim the invention of any of the parts above specified; but

What I claim as my invention, and desire to secure by Letters Patent, is—

A movable pantry constructed in the manner substantially as and for the purpose above described and stated.
