


## IMPROVED CRUMB REMOVER.

## AMELIA B. HOFFMAN, OF ROXBURY, MASSACHUSETTS.

Letters Patent No. 60,009, dated November 27, 1866.

## SPECIFICATION.

Be it known that I, AMELIA B. HOFFMAN, of Roxbury, in the county of Norfolk, and State of Massachusetts, have invented a new and improved Instrument for Removing Crumbs from a Table; and I do hereby declare that the following is a full, clear, and exact description of the construction and operation of the same, reference being had to the annexed drawings making a part of this specification:

The nature of my invention consists in combining a crumb-scraper with a pan or receiver in such a manner

as to form one instrument to be used with one hand.

Figure 1 represents my said invention, (which I style the crumb-remover,) as it sets upon a table ready

for use.

A is the inside of the receiver, in which the crumbs are deposited after they are taken up. B is the blade or scraper, which rests upon and covers the front side of the receiver, and curving outwards, so as to present a slight concavity, terminates in a plane surface with a sharp edge in contact with the table. C is the handle by which the instrument is operated and to which the blade, B, is attached, and which passes through and turns in a hole and socket inserted in the rim of the receiver at each extremity of the blade. By turning the handle a rotary motion is given to the scraper for the purpose of emptying crumbs i to the receiver. This operation is shown in .

Figure 2, which represents the crumb-remover with the scraper turned up, exposing to view the under side

of the blade, B, and the front side, D, (beforementioned,) of the receiver.

The operation of my said invention may be described as follows: When lifted by the handle C, the blade B, being in the position delineated in fig. 1, presses against the front side of the receiver and holds it firmly balanced in a horizontal position. When placed upon the table and slid forward over the table-cloth, the blade B, (still remaining in the position of fig. 1,) scrapes up the crumbs as it proceeds, and when turned up into the position shown in fig. 2, it deposits the crumbs in the receiver. Then, being turned back to its first position, the operation is repeated until all the crumbs are taken up.

The receiver may be made in a semicircular form, as delineated in the drawing, or it may be made in any form or of any material that is adapted to its purpose, provided only that it has a straight side in front corre-

sponding to the side D, as shown in fig. 2.

What I claim as my invention, and desire to secure by Letters Patent, is— The combination of a pan or receiver A, with a blade or scraper B, in the manner and for the purpose
