




IMPROVED LOUNGE.

The Schedule referred to in these Letters Patent and making part of the same.

To all whom it may concern:

Be it known that I, WILLIAM H. COLLEY, of Leavenworth, in the county of Leavenworth and State of Kansas, have invented a new and improved Lounge; and I do hereby declare that the following is a full, clear, and exact description thereof, which will enable others skilled in the art to make and use the same, reference being had to the accompanying drawing forming part of this specification.

Figure 1 represents a side elevation of my improved lounge, showing it folded together.

Figure 2 is a side elevation of the same.

Similar letters of reference indicate corresponding parts.

The object of this invention is to so improve lounges that the head-rest of the lounge proper will also serve as a head-support for the bed.

The invention consists in hinging the upper part of the head-rest to the folding seat, so that it will swing in or out with the same, and in thereby making the said head-rest part of the extension-bed.

A in the drawings represents the frame or fixed part of a lounge.

It consists of the fixed mattress or bed-bottom *a*, back *b*, and inclined, but fixed, head-rest *c*.

B is the hinged seat. The same is hinged to the frame A in the ordinary or suitable manner, and can

be swung upon the bed-bottom *a*, as in fig. 1, or away from the same, as may be desired.

The main head-rest C is hinged to the end of the folding seat B, and will, when the device is folded together, rest on the fixed rest *c*, as in fig. 1.

The upholstered upper surface will then constitute the main head-rest of the lounge.

When the seat B is swung out, as in fig. 2, the head-rest C will swing with it, and can be elevated into line with the rest *c*, as indicated by dotted lines in fig. 2.

A bolt, catch, or other fastening, D, serves to lock the rest C in the last-named position.

The head-rest will thus be as continuous as the seats, when the apparatus is to be used as a bed.

Having thus described my invention,

I claim as new and desire to secure by Letters Patent—

The frame A, having bottom, back, and inclined fixed head-rest, all as described, combined with the hinged seat and swinging head-rest constructed and relatively arranged therewith to form an improved compound lounge and bed, as shown and described.
