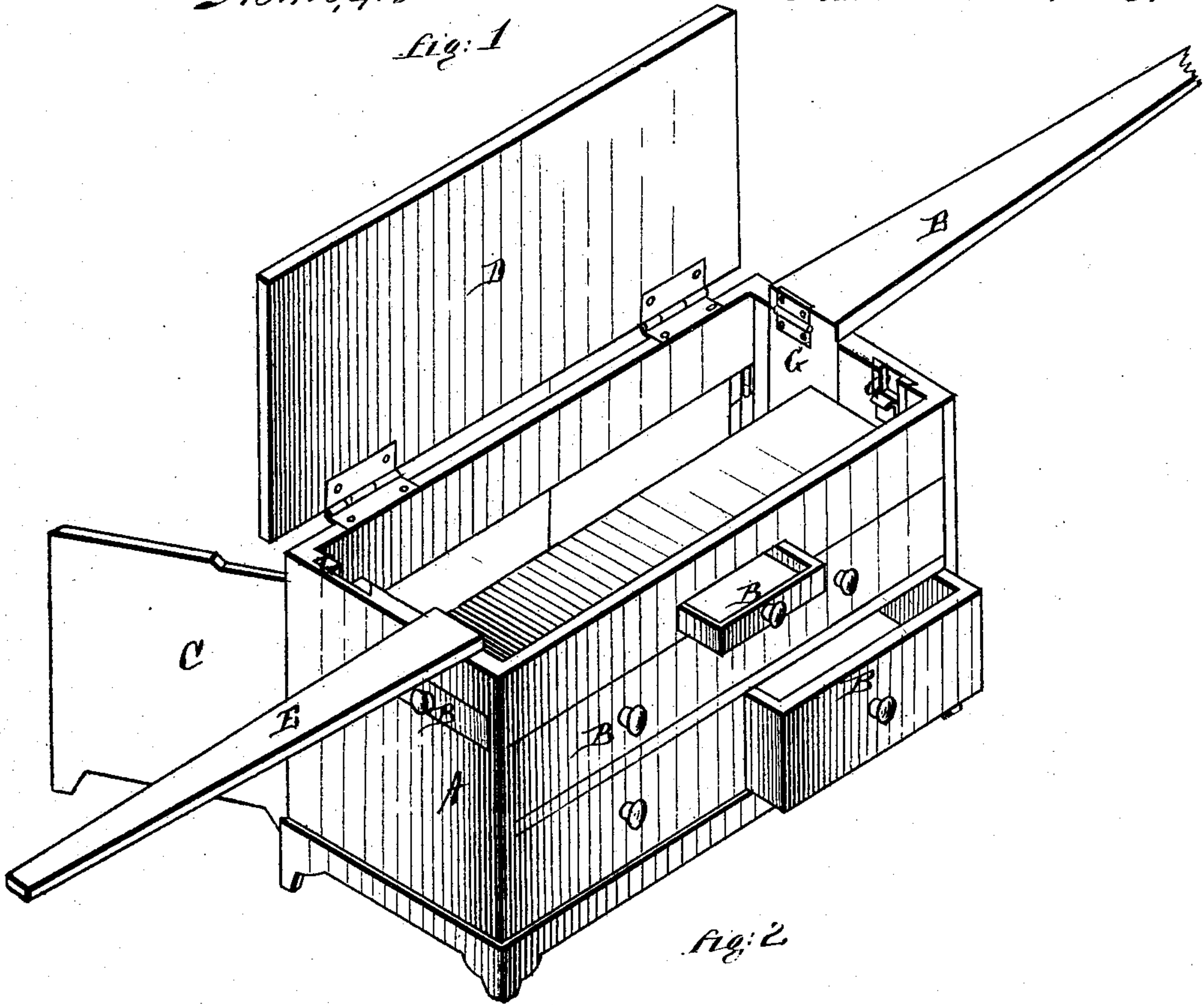

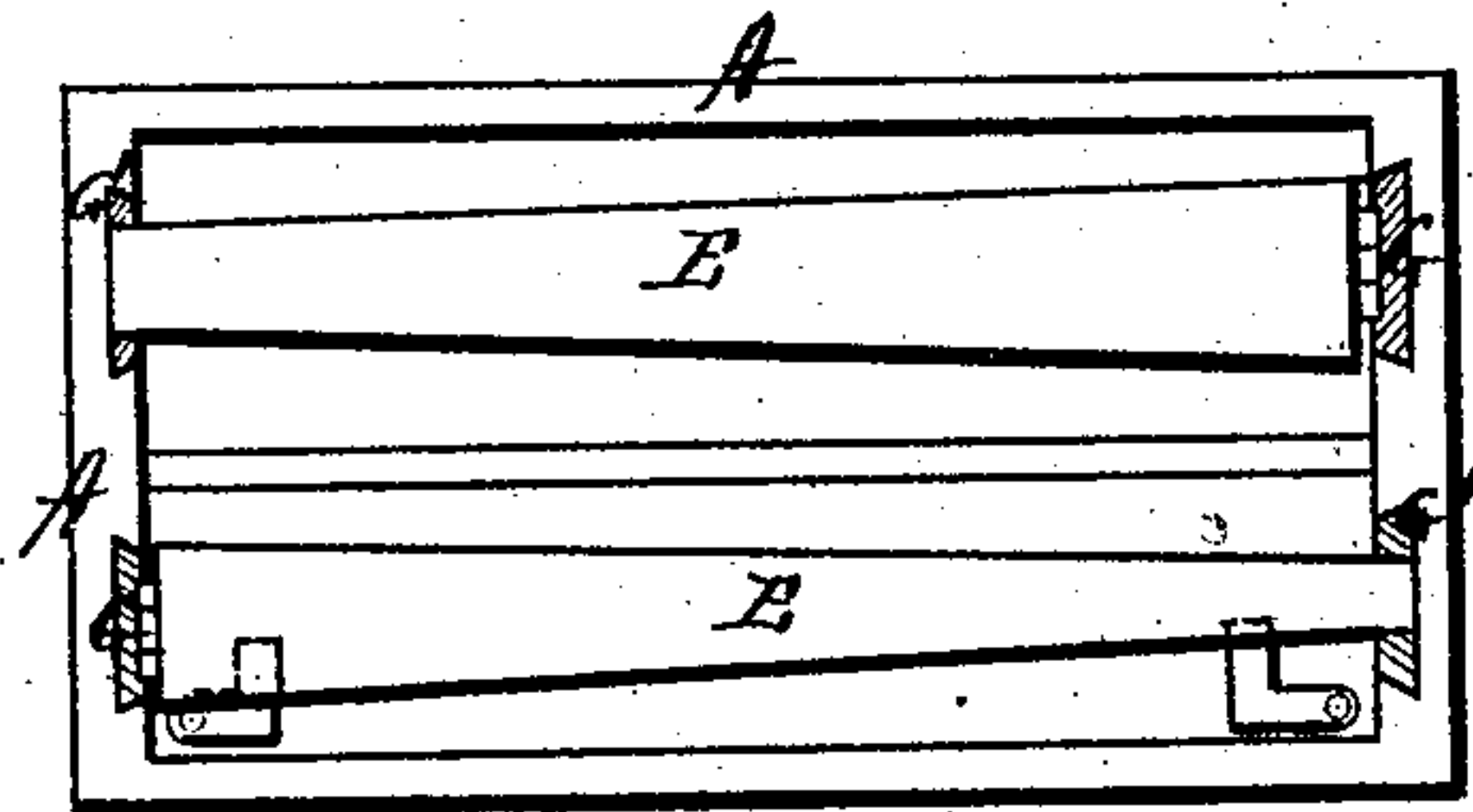
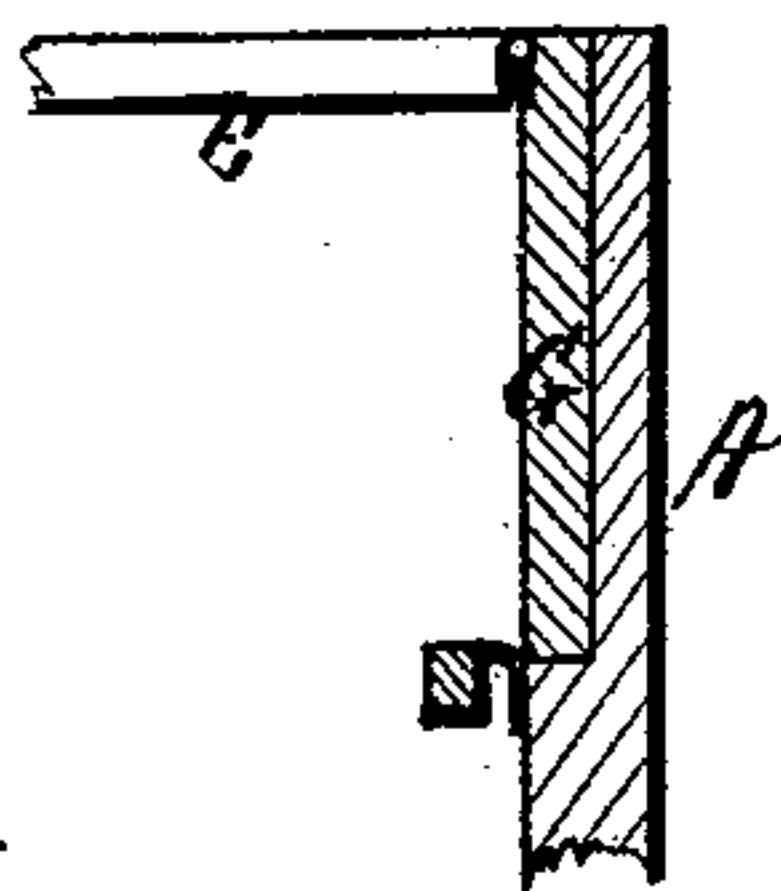

IMPROVEMENT IN IRONING-TABLE BUREAUS.

The Schedule referred to in these Letters Patent and making part of the same.

To all whom it may concern:

Be it known that I, MARGARET WHITE, of Saratoga Springs, in the county of Saratoga and in the State of New York, have invented certain new and useful Improvements in Combined Ironing-Table and Bureau; and do hereby declare that the following is a full, clear, and exact description thereof, reference being had to the accompanying drawing and to the letters of reference marked thereon making a part of this specification.

My present invention is intended as an improvement upon the combined ironing table and bureau for which Letters Patent were granted to me June 14, 1870; and

It consists in making the ironing-boards adjustable, so that they can be raised, the better to accommodate the ironer.

In order to enable others skilled in the art to which my invention appertains to make and use the same, I will now proceed to describe its construction and operation, referring to the annexed drawing, in which—

Figure 1 is a perspective view of my combined ironing-table and bureau;

Figure 2 is a plan view of the same, the lid being removed; and

Figure 3 is a section of the same.

A represents the frame, with the drawers B B, back doors C, and lid D, forming the table and bureau, constructed and arranged substantially in the same manner as described in my former patent.

E E are the ironing-boards, which in my former

patent were hinged directly to the frame A. In this case they are hinged to slides G G, which move in vertical dovetailed grooves on the inner sides of the frame.

The small ends of the ironing-boards rest upon similar slides, G', the upper ends of which are cut out so as to receive the ends of the boards, as shown in fig. 1.

These slides G and G' may be moved up and down by any suitable means, and held at any height, so as to raise the boards higher than the frame, thereby giving more room to adjust articles of dress on the large board, as well as expedite the work.

I do not confine myself to any particular means for raising, lowering, and holding the slides G G', as that may be done in various ways; for instance, by thumb-screw, spring, ratchet, or any other suitable means.

Having thus fully described my invention,

What I claim as new, and desire to secure by Letters Patent, is—

The vertically-operating adjustable slides G G' for supporting the ironing-boards at any height desired, substantially as set forth.
