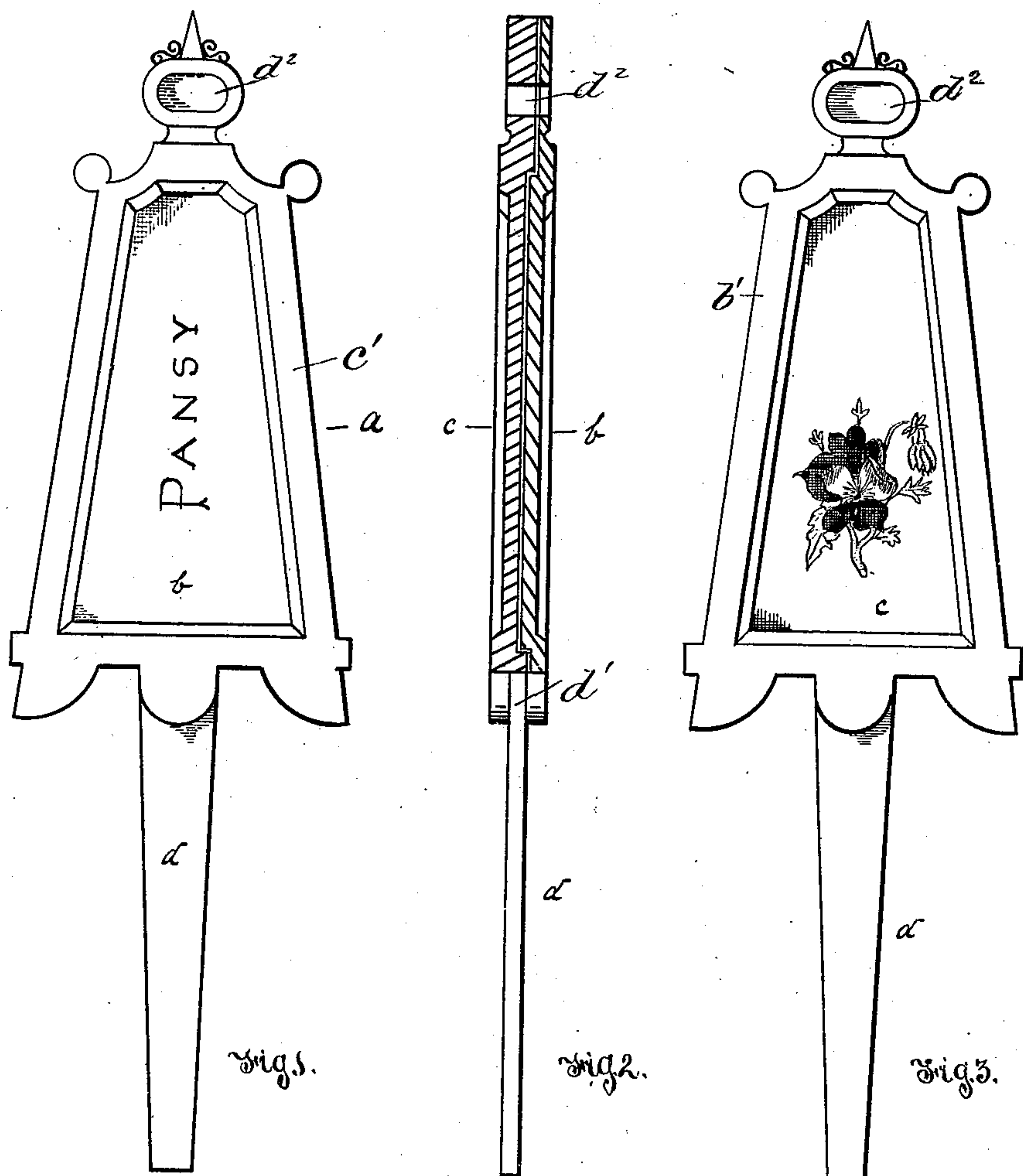

BOTANICAL LABELS.

SPECIFICATION forming part of Letters Patent No. 227,658, dated May 18, 1880.

Application filed February 9, 1880.

To all whom it may concern:

Be it known that I, CHARLES J. SCHULTZ, of Allegheny, in the county of Allegheny and State of Pennsylvania, have invented a new and useful Improvement in Botanical Labels; and I do hereby declare the following to be a full, clear, and exact description thereof.

My invention relates to the construction of that class of articles known as "labels" used for indicating the botanical names of plants, &c.; and it consists in a label-holder having a separable frame with transparent panels, said holder provided with a suspension-eye and stake-socket, whereby the same may be employed either to designate trees and plants or the spot where seeds have been planted.

In the drawings forming part of this specification, Figure 1 is a front view, Fig. 2 a sectional view, and Fig. 3 a back view, of a label-holder embodying my invention.

Like letters refer to like parts wherever they occur.

c b indicate the transparent panels inclosing the label or designating-marks. Said parts may be of glass or like transparent material, and are secured in a frame, *c' b'*, where the nature of the material demands. In case of glass, if preferred, the panels *c b* and frame *c' b'* may be formed in a single piece in manner well known to those skilled in the art of glass-working. In any case, however, whether the panel *c* or *b* and frame *c'* or *b'* be formed together or singly, an eye, *d*², for suspension, will be provided at one end, and at the other a recess or socket, *d'*, for the reception of a stem or stake.

The frame with transparent panels *b c* having been provided, the designating-marks may be either applied directly to the surface of the transparent panels, (in case of glass by any well-known means, such as etching, engraving, molding, or painting, or in case of mica by painting or printing thereon,) or they may be formed on a card or sheet to be inclosed within the frame and between the panels *c b*.

The designating-marks, which may be the name of the plant or a representation of it or its flower, or both, having been placed on the inner face of one or both panels *c b* or inclosed between the same, the frame is closed and the parts cemented together so as effectually to exclude moisture. The end of stem or stake *d* is then secured in the slot *d'* if the label is to be used to designate the position of seeds or a fragile plant, or if the label is to be used with trees or shrubs the stem *d* may be omitted.

Having thus described my invention, what I claim, and desire to secure by Letters Patent, is—

A botanical-label holder consisting of the two frames *c' b'*, having each a transparent panel, said parts being counterparts, united by cement, and the holder provided with a suspension-eye and a stake-socket, substantially as and for the purpose specified.
