


BAG OR SATCHEL.

SPECIFICATION forming part of Letters Patent No. 230,847, dated August 3, 1880.

Application filed June 2, 1880. (No model.)

To all whom it may concern.

Be it known that I, DIEDRICH WILHELMI, of the city, county, and State of New York, have invented certain new and useful Improvements in Bags and Satchels, of which the following is a specification.

The object of this invention is to supply a neat and light bag or satchel for summer use; and the invention consists of a bag or satchel, to the side, end, and bottom parts of which are made of one continuous piece of braided straw, willow-ware, or rattan, and provided with connecting end gussets having interior re-enforcing corner-pieces.

In the accompanying drawings, Figure 1 represents a perspective view of my improved bag or satchel; and Fig. 2 is a detail vertical transverse section of the upper part of the same, showing the interior corner-pieces of the end gussets.

Similar letters of reference indicate corresponding parts.

In the drawings, A represents a bag or satchel, the body B of which is made of braided straw, willow-ware, rattan, or similar material, in such a manner that the end walls, side walls, and bottom form one continuous piece, which is attached to the metallic frame C of the bag or satchel and to connecting end gassets, B', which are made of leather or other suitable material.

The connecting end gassets, B', as well as the upper parts of the side walls of the body,

are attached to the frame C in the usual manner.

The upper corners of the body B are re-enforced by rounded-off corner-pieces D, which are attached to the inside of the gussets, as shown in Fig. 2.

A bag or satchel of this construction is 40 light, airy, and of neat appearance, and especially adapted for use in summer.

Having thus described my invention, I claim as new and desire to secure by Letters Patent—

1. A satchel having the bottom, sides, and a portion of each of its ends made of braided straw, rattan, or willow, and provided with end gussets of fabric or other flexible material, and suitable jaws and handle, all substantially 50 as set forth.

2. As an improvement in bags or satchels, the combination, with a body made of a continuous piece of braided straw, willow-ware, or rattan, and provided with connecting end 55 gussets, of interior re-enforcing corner-pieces, substantially as described.
