

TRAPEZE AND TIGHT-ROPE ACCESSORY.

SPECIFICATION forming part of Letters Patent No. 232,216, dated September 14, 1880. Application filed August 12, 1880. (No model.)

To all whom it may concern:

Be it known that I, John Theurer, of Hamilton, Butler county, Ohio, have invented certain new and useful Improvements in Tra-5 peze and Tight-Rope Accessories, of which the following is a specification.

My invention relates to a device for enabling the properly skilled performer to support himself, head downward, upon a trapeze to or tight-rope, and thus perform novel evolu-

tions while his feet are in the air. By the use of my invention I am enabled to walk a tight-rope by means of my head and hands, and to perform numerous novel feats of balancing, posing, &c., upon a tight-rope, a

trapeze, or a horizontal bar. In the accompanying drawings, Figure 1 represents a performer balanced, head downward, upon a trapeze provided with my im-20 proved accessory, and Fig. 2 represents one form of said accessory.

My accessory is a head-rest adapted to form part of or be attached to a trapeze, horizontal bar, or tight-rope.

The drawings clearly show the form chosen | for depiction.

The device, when used for trapeze or bar performances, should be so constructed as to form a seat for the performer's head, and 30 should be provided with means for fixing it firmly to the bar.

In Fig. 1, A is the bar of a trapeze, and B is my improved accessory, attached thereto by means of a set-screw, E. Any other form 35 of attachment will answer, so long as it is adapted to retain said head-seat upon the bar.

Instead of being attached to the bar, the head-seat may be formed as part of the trapeze-bar by expanding or forming a part of the | 40 bar into a seat adapted to receive the performer's head.

The head-seat must have a concave curve | to the surface intended to receive the head. This concavity may be double, so as to give ! 45 the head-seat a dish form, or the curve may be i one way only and the transverse lines of the head-seat may be straight, as shown in the J side view, Fig. 2.

The material of the head-seat may be east-

50 iron or any other proper material.

For tight-rope walking the accessory must be attached to the walker's head, which is accomplished by providing the head-seat with straps, as shown in Fig. 2, and the attach-

ment of the head-rest to the rope is tempo- 55 rary—that is, a simple rope-seat is all that is required.

The performer straps the device shown in Fig. 2 to his head, and takes his position on a tight-rope with the groove C over the rope. 60 He rests his balancing-pole on the rope while holding the pole, and by a series of steps, first with his head, then with the pole, he traverses the rope.

For evolution on the rope the bead-rest would 65 be fixed to the rope, and not to the perform-

er's head.

In practice I prefer a combined device, as shown in Fig. 2, so that it will answer for sundry and various performances; but, as before 70 stated, a trapeze-bar may be prepared so as to contain within itself the essential feature of my invention, as a fixed head-rest in a trapeze.

In trapeze performance with my accessory it is desirable that the trapeze-bar should be 75 so firmly held in its supports as to prevent as much as possible all twisting or revolving of the bar.

For tight-rope operations in which the accessory is fixed to the performer's head a con- 80 cave upper surface is not absolutely essential.

I claim as my invention—

1. The combination, with the horizontal element of a trapeze or other similar gymnastic device, of a concave head-seat, formed with 85 or upon the same or attached thereto, substantially as and for the purpose specified.

2. A concave head-seat, combined with a means for attaching the same to the horizontal element of a trapeze or other similar gym- 90 nastic device, substantially as and for the pur-

pose specified.

3. The combination, with a head-piece and a means for attaching the same to the head of a performer, of a bottom groove or seat 95 adapted to engage with a rope, substantially as and for the purpose specified.

4. The combination, with a head-seat, a means for attaching the same to a performer's head, and a bottom groove or seat adapted to 100 engage with a rope, of a means for attaching said head-seat to the horizontal element of a trapeze or other similar gymnastic device, substantially as and for the purpose specified.
