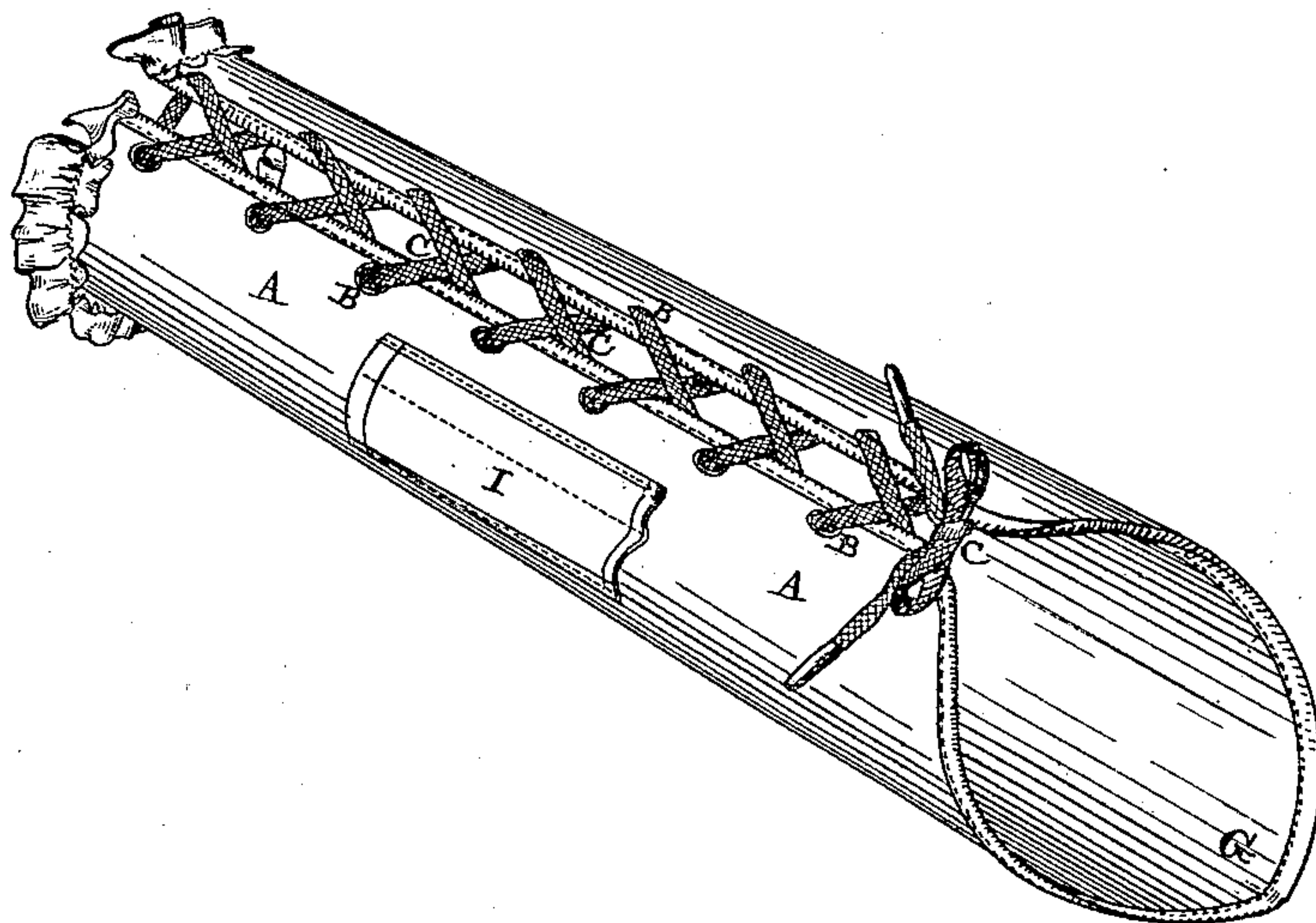

CAROLINE SPRAGUE, OF WYANDOTTE, KANSAS.

SLEEVE-PROTECTOR.

SPECIFICATION forming part of Letters Patent No. 245,753, dated August 16, 1881.

Application filed February 9, 1881. (Model.)

To all whom it may concern:

Be it known that I, CAROLINE SPRAGUE, of Wyandotte, county of Wyandotte, and State of Kansas, have invented certain Improve-
5 ments in Sleeve-Protectors, of which the following is a specification.

My invention relates to an improvement in sleeve protectors; and it consists in making an extension on the protector at the inner end,
10 whereby the protector is made to cover and protect the elbow.

It further consists in providing the protector with a pocket or pockets for carrying a pencil or other such article.

15 The accompanying drawing represents a perspective of a sleeve-protector embodying my invention.

A represents the protector, made preferably of oil-cloth, but any other suitable material
20 may be used. This protector is open along one edge, and is provided with a series of eyes B, through which is passed a lacing, C, by means of which the edges are fastened together. Instead of the lacing rubber bands
25 or any other suitable fastenings may be used for this purpose. By making the protector open down one side it may be made to fit arms of different sizes.

At the inner end of the protector opposite
30 from the open side is made the extension G, which reaches up over the elbow, so as to prevent it from coming in contact with the table

or desk. This extension answers all the purpose of having the protector made much longer and effects a considerable saving in material. 35
On the top of this sleeve is made one or more pockets, I, in which different articles may be carried. Where the protector is made for children at school the pocket will be double, so as to carry both a pen or pencil and a comb. 40
Where the protector is used by clerks a pocket for a pencil-case only will be made.

If so desired, the material may be perforated so as to allow the moisture from the arm to readily escape during warm weather, and the
45 cloth will be bound in any suitable material so as to give the protector an attractive appearance.

Having thus described my invention, I
claim— 50

1. A sleeve-protector that is open down one side and provided with suitable fastening devices, and having an extension at its inner end so as to protect the elbow, substantially as shown. 55

2. A sleeve-protector having an extension, G, made at the elbow, substantially as described.

3. A sleeve-protector provided with a pocket or pockets, substantially as set forth.
