

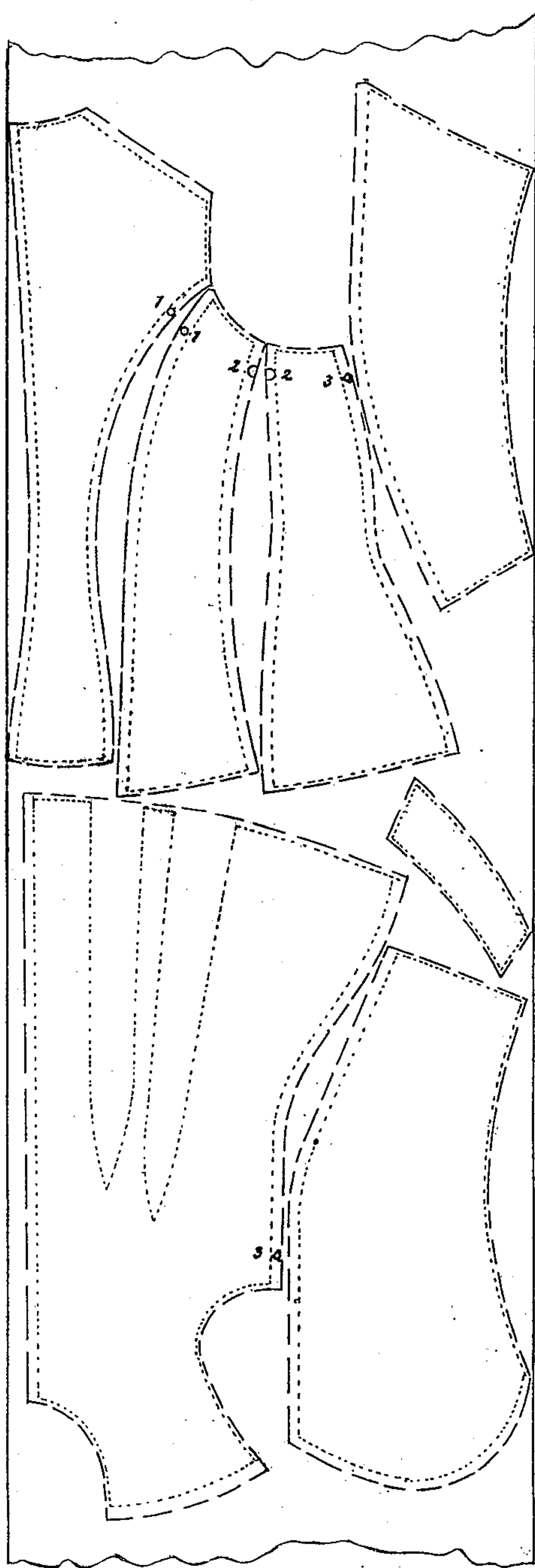

GOODS FOR DRESS-LININGS HAVING PATTERN PRINTED THEREON.

SPECIFICATION forming part of Letters Patent No. 246,536, dated August 30, 1881.

Application filed January 22, 1881. (No model.) Patented in France June 23, 1879.

To all whom it may concern:

Be it known that I, HERMAN MOSCHCOWITZ, a citizen of the United States, and residing alternately in Paris, France, and at New York, in the State of New York, have invented a new and useful Improvement in Linings for Ladies' and other Garments, of which the following is a specification.

My invention consists in printing or stamping upon muslin or other material applicable for the lining of garments the exterior lines of the pattern for every piece of the garment, as a guide for cutting the same and, when said lining is basted to the material forming the garment, this material at the same time, as well as a line in dots or its equivalent, indicating where the pieces are to be sewed together, together with suitable guiding-marks to indicate where and how the pieces are to be jointed together, facilitating thereby the cutting and making of the garment.

The accompanying drawing represents a piece or section of muslin printed in various lines and marks in accordance with my invention. The strong broken lines indicate the outer lines of the patterns where the same are to be cut. The various marks 1 2 3 are guiding-marks, showing where the different parts are to be fitted together, and are to be made of different shapes or configurations to distinguish the same from each other. The dotted lines indicate where the different parts are to be sewed together.

I do not confine myself to making broken lines to represent the cutting-lines and dotted lines to indicate the sewing-lines, as it will readily be understood that only a certain distinction between these two lines is required, and any other description of lines may be used, or the same may be printed in different colors.

It will be perceived that the dotted lines are not equally distant at all sides from the strong broken lines or with the cutting-line. This is to allow for any slight variation in the size of the person where generally required to make a perfect fit.

It is intended in practice to print or stamp the pattern as well as the dotted lines, &c., for sewing the parts together in different sizes, according to dimensions around the chest and waist, so that merchants may keep them on sale, and a purchaser, by giving the proper dimension, obtain the lining with the proper size of pattern, &c., upon the same.

The lining may be basted to the fabric or material of which the dress or garment is to be made, whereby the fabric is cut in accordance with the pattern at the same time.

By means of my invention a person of very little skill will be enabled to cut out and sew together a dress or other garment with unerring accuracy in very little time.

I am aware that patterns of dresses and other garments have been printed on paper, linen, or other materials, and therefore do not claim this, broadly; but

What I claim as my invention, and desire to secure by Letters Patent, is—

As a new article of manufacture, a lining for ladies' dresses or other garments having the patterns of the dress or garment for which it is to form such lining printed or stamped upon it, together with lines inside of the pattern-line, for the purpose substantially as specified.
