

CIGAR-MAKER'S TABLE.

SPECIFICATION forming part of Letters Patent No. 248,589, dated October 25, 1881.

Application filed March 7, 1881. (No model.)

To all whom it may concern:

Be it known that we, CHRISTOPHER HAK, of Newport, in the county of Campbell and State of Kentucky, and George D. Wood-5 WORTH, of Cincinnati, in the county of Hamilton and State of Ohio, have invented a new and useful Improvement in Cigar-Makers' Tables, which improvement is fully set forth in the following specification and accompanying

10 drawing, in which—

Figure 1 is a perspective view of the case. It is well known to manufacturers of cigars that tobacco-leaves contain a large amount of sand; hence it is necessary before being made 15 up to free the leaves from this impurity by sifting or otherwise. Owing to the fact that the leaves are not manipulated separately during this process only a portion of the sand is removed. During the manipulation of the 20 wrapper and filler preparatory to making each cigar this sand can be worked out to the best advantage, and it is found that the table where the filler and wrapper are worked will in a short time be covered with the sand, which is occa-25 sionally brushed off, to prevent it from passing into the cigar and damaging the quality.

The object of this invention is to provide a portable sifting case for eigar-makers, which is constructed of a form to be easily handled by 30 the workman and of such a character as to absolutely prevent the sand from entering the cigar after it is once separated from the leaves.

To this end it consists in an oblong case having a drawer beneath, and provided with a per-35 forated sheet-metal screen above, the rear end of the case having a back and sides, and also a partition for receiving different qualities of wrappers or of fillers, as will be more fully described hereinafter.

Referring to the accompanying drawing, A represents an oblong case having in the forward end a drawer, B, and at the rear end, above the drawer, a floor, C. The rear end of the case has a back which projects a suitable !

distance above the floor C, and the rear ends 45 of the side pieces also project above the floor C. A perforated metal sheet, D, forms the floor for the forward end of the case, and this reaches back to the floor C. A movable piece, E, forming a partition, is placed diagonally 50 across the rear end of the case and held in position by a cleat, F, as shown. This partition may be extended across the case in any other manner, but the position shown is the most convenient.

In operation the wrappers are placed on the floor C on both sides of the partition-piece E. The wrappers are then taken separately therefrom and manipulated on the metal screen D. The sand thus falls through into the drawer B 60 below, and the operator is not constantly compelled to free the space before them, and the careless workman is enabled to keep his cigars

free from sand and grit.

We are aware that it is not new to employ 65 a wire-gauze or a screen of perforated tin for the purposes herein named; but our design is to construct a portable case which may be used on the ordinary cigar-maker's table and then removed, as herein stated. We therefore dis- 70 claim, broadly, the use of a screen.

Having described our invention, what we claim as new, and desire to secure by Letters

Patent, is—

In a portable sifting-case for cigar-fillers, 75 the combination of the case A, having a drawer, B, beneath, and a screen, D, the rear end of the case projecting above the floor C, and provided with a movable partition, E, as and for the purpose herein set forth.
