






COMBINED POCKET-CASE AND CIGAR-CLIPPER.

SPECIFICATION forming part of Letters Patent No. 256,093, dated April 4, 1882.

Application filed January 18, 1882. (No model.)

To all whom it may concern:

Be it known that I, ARTHUR P. YATES, of Syracuse, in the county of Onondaga, in the State of New York, have invented new and useful Improvements in Combined Pocket-Case and Cigar-Clipper, of which the following, taken in connection with the accompanying drawings, is a full, clear, and exact description.

The object of this invention is to provide a simple and convenient device for clipping the end of a cigar, and which shall be compact and easily carried in a person's pocket and readily

brought into use when required.

Cigar-clipping devices have been combined with match-safes in various ways; but in every instance, so far as has come to my knowledge, the combination and arrangement of parts has been such as to require an opening in the side 20 of the case and cause the clippings to drop inside of said case, and thus necessitated either frequent emptying of the case or extra outlets from the same. All of these objections I overcome by combining with the case or safe a 25 rigid blade projecting outward from the end thereof, and provided with the usual aperture for the reception of the end of the cigar to be clipped, and a cutting-blade, also projecting outward from the end of the case and sliding 30 over the fixed blade, all as hereinafter more fully described, and specifically set forth in the claims.

The accompanying drawings fully illustrate my invention. Figures 1 and 2 area face view and vertical transverse section, respectively, of a pocket match-safe embodying my invention; and Figs. 3 and 4 illustrate the invention embodied in another style of match-safe, and showing the same in two of its operative positions.

Similar letters of reference indicate corresponding parts.

A represents a case of any desirable form, adapted to contain either matches or cigars, and to be convenient to carry in a person's pocket. To the end of the body or frame of the said case I permanently affix a knife-blade, a, which projects outward therefrom, and is provided with an eye or aperture, e, of proper size to receive the mouth end of a cigar re-

quired to be trimmed or clipped, the edges of |

said aperture being properly sharpened for that purpose. b is another knife-blade, connected with the case A and adapted to slide over the knife-blade a, and thereby clip the end of 55the cigar protruding through the eye e. The knife-blade b, I prefer to attach to guide-rods c, which slide in tubular bearings fixed to the case A, and are held yieldingly in an outwardprojecting position by means of a spiral spring, 60 s, pressing on the end of said rods, as illustrated by dotted lines in Fig. 1 of the drawings. By making the two rods c c of one piece of wire bent U shape a guard is formed over the end of the fixed knife-blade a by the cross bar or 65 bow v of said wire, which prevents the wear of the pocket by the said knife, and also serves as a stop to the approach of the blade b to the case A, said blade being operated by forcing it toward the case, thereby causing it to slide over 70 the eye e of the blade a, and clipping the end of the cigar protruding through said eye.

If it is desired to dispense with the guiderods c c and the spring s, I make the case A of two longitudinal sections, r and r', one of which 75 constitutes the case proper, and the other being the cover fitted to slide over the former, the exterior surface of said parts being serrated or provided with a suitable thumb-piece to facilitate the manipulation of the device. 80

The end of the section r, I provide with a blade, a, which projects outward from the end of the case and has a sharpened eye, e, similar or like the eye of the fixed blade a shown in Fig. 1. The section r', I provide with a similar 85 blade, b, which also projects outward from the end of the case proper, and fits closely to the blade a, and has over the eye e a sharpened aperture, e', so that by inserting the end of the cigar through said two apertures e and e' and 90 sliding the section r' off the section r the protruding end of the cigar is sheared off.

If it is desired, the end of the blade b may be also sharpened, so that the cigar can be clipped by first opening the case, then, after 95 inserting the end of the cigar through the eye e of the blade a, pushing the cover or section r' over the case or section r, and thus causing the end of the blade b to sever the end of the cigar protruding through the eye e of the 100 blade a.

It will be observed that in both of the de-

scribed forms of the combined pocket matchsafe and cigar-clipper the clipping-blades are arranged on the end of the match-safe, and slide rectilinearly one over the other, and exclude the cigar-clippings from the interior of the match-safe with which said blades are combined.

It will be observed that by my improvements I maintain the case or safe intact, and the ci-10 gar-clippings are kept out of the case.

Having described my invention, what I claim as new, and desire to secure by Letters Pat-

ent, is—

1. The improved match-safe and cigar-clipper combined, consisting of a pocket matchsafe having projecting outward from its end a
fixed blade provided with an aperture for the
reception of the end of the cigar to be clipped,
and a cutting-blade, also connected to the end
of said match-safe, and adapted to slide rectilinearly over the fixed blade, all constructed
and arranged to operate on the end of the

match-safe and exclude from the interior thereof the cigar-clippings, substantially as shown

and specified.

2. The combination, with the pocket-case A, of the blade a, fixed to the end thereof and provided with the eye e, the combined guard and guide-rods c, having a cross bar or bow, v, over the end of the fixed blade, the blade b, attached to the guide-rods c, and the spring s, applied to the end of said rods, all substantially as described and shown, for the purpose set forth.
