




POCKET-BOOK FRAME.

SPECIFICATION forming part of Letters Patent No. 262,482, dated August 8, 1882.

Application filed April 24, 1882. (No model.)

To all whom it may concern:

Be it known that I, SIMON SCHEUER, of the city, county, and State of New York, have invented certain new and useful Improvements in Pocket-Book Frames, of which the follow-

ing is a specification.

This invention has reference to an improved frame for pocket-books of that class in which coin received in change may be readily inserted through an auxiliary opening of the frame to the interior of the book after it has been closed; and the invention consists of a pocket-book frame of that class which is provided with movable jaws and a guard-piece extending over the jaws, said guard-piece having a slotted opening, and a hinged or sliding cover for opening or closing the slot of the guard-piece.

In the accompanying drawings, Figure 1 corpresents a top view of pocket-book with my improved frame, showing the auxiliary slot open for inserting change. Fig. 2 is a side view, partly longitudinal section; and Fig. 3 is a vertical transverse section of the same.

Similar letters of reference indicate the cor-

responding parts.

In the drawings, A represents a pocket-book frame of that class which consists of an exterior V-shaped guard-piece, a, to which the clos-30 ing flap or flaps of the book are applied, and of two jaws, b b, that are pivoted to the lower ends of the guard-piece a, and prevented from closing entirely by means of inwardly-projecting stops d of the same. The jaws b b are pre-35 vented by the stops d from coming in contact with each other when the book is closed, so as to leave a narrow longitudinal space between them. In the middle part of the guardpiece a is arranged a longitudinal slot, a', which 40 may be opened or closed by means of a sliding cover or lid, e, that is guided in side grooves, e', of the guard-frame a. The lid or cover e may also be hinged to the guard-piece a, so as to be thrown up when the slot is to be 45 opened and down when the slot is to be closed.

A stud or button, e^2 , at one end of the lid or cover e, serves to operate the same, while a suitable catch, e^3 , or other fastening retains it in closed position, as shown in Fig. 2.

When a bank-note or gold coin has been 50 taken out of the book the same is closed and the change dropped afterward into the book through the auxiliary opening in the guard-piece of the frame A, for which purpose the lid is drawn back, so as to clear the slot. The 55 coin received in change is conducted between the jaws b b to the middle portion of the book. The lid e is then placed over the slot again, and thus a very cheap and simple means provided whereby change can be inserted into a 65 pocket-book without reopening the same.

I am aware that pocket-books having a separate opening for the insertion of coins, besides the usual flap and other locking device, have been patented heretofore, and I therefore do 65

not claim this feature broadly.

Having thus described my invention, I claim as new and desire to secure by Letters Patent—

1. A pocket-book frame provided with an exterior guard, to which the closing flap is ap-70 plied, jaws that are pivoted to the lower ends of the guard, guideways on the upper part of the guard, and the sliding cover for opening or closing the slot, substantially as described.

2. A pocket-book frame provided with an exterior guard, to which the closing flap is applied, jaws that are pivoted to the lower ends of the guard, inwardly-projecting stops d to prevent the jaws from closely uniting, guideways on the upper part of the guard, and the 80 sliding cover for opening or closing the slot, substantially as described.
