

## SUIT-HANGER.

SPECIFICATION forming part of Letters Patent No. 267,623, dated November 14, 1882.

Application filed June 30, 1882. (No model.)

To all whom it may concern:

Be it known that we, GEORGE NEWTON WERNTZ and HENRY LEGGITT LEMERT, both of Dresden, in the county of Muskingum and State of Ohio, have invented a new and useful Improvement in Suit-Hangers, of which the following is a full, clear, and exact description.

This invention consists in a suit-hanger of novel construction with attached devices for hanging or carrying if necessary an entire suit of clothes, and for keeping them in perfect shape, free from all breaking down, substantially as hereinafter described.

Reference is to be had to the accompanying drawings, forming a part of this specification, in which similar letters of reference indicate corresponding parts in both the figures.

Figure 1 is a front perspective view of my improved suit-holder with certain articles of a suit thereon, and Fig. 2 a sectional side view of an entire suit carried by said holder.

A indicates a suit-hanger made to conform in shape to the chest and shoulder portion of a man or youth, and which may be constructed of sheet metal, with a turret or neck part, b, projecting up from it, having at its top a hook, c, by which the whole device may be suspended.

Secured to the interior of the opposite end portions of the hanger A, and arranged to project below said hanger, are two close bent wire pantaloon-hangers, dd, constructed with contracted necks, so as to receive down through them from their inner sides and retain in place opposite side buttons, ee, on the waist portion of pantaloons B, whereby the pantaloons are hung in a spread condition and prevented from coming off the hanger during the transportation or shipping.

The body part of the hanger A serves to re-

ceive over it the vest C, coat D, and, it may 40 be, overcoat E, of the suit, all of which may be secured on or be prevented from falling off the hanger by buttoning them by their upper buttons thereon. Thus arranged on the holder A, these several garments may be kept smooth 45 or unbroken in their original and proper form, and the shoulders of the coats and the entire suit, in fact, be retained in shape till worn out.

Fastened to the bottom of a filling, within the neck part b, is a hook, f, for suspending a 50 pair of shoes belonging to the suit, and attached to the front of said neck part is a bracket, g, constructed to form a hook, h, for hanging on a hat, G, and a smaller hook, i, for receiving within it a collar, H, and necktie I. 55

In using the holder the pantaloons are first hung to their place thereon, and the other garments or articles afterward hung or arranged in their places. Such suit form or holder is inexpensive, neat in appearance, readily port-60 able, and may be suspended from any convenient place for use either by the dealer or wearer of the suit.

Having thus described our invention, we claim as new and desire to secure by Letters 65 Patent—

The combination, with the body part of the suit-hanger A and its neck b, having an attached suspension-hook, c, of the shoes-hanging hook f, the pantaloon-hangers d, and the 70 hat, collar, and necktie bracket g, constructed to form double hooks h i, essentially as shown and described.
