


POKE-BONNET.

SPECIFICATION forming part of Letters Patent No. 284,511, dated September 4, 1883.

Application filed June 18, 1883. (No model.)

To all whom it may concern:

Be it known that I, Julia Stern, a citizen of the United States, and a resident of the city of Brooklyn, in the county of Kings and State of New York, have invented a new and useful Improvement in Poke-Bonnets, of which the following is a specification.

My invention relates to the style of bonnet called "poke-bonnet;" and it consists of a back to cap, of lace, worsted, or other material, with a poke-front part, and suitably trimmed with ribbon and ruffle of lace or ruche.

The object of my improvement is to provide the French pattern style cap, of worsted or other goods, with a poke-front suitably trimmed, to obtain thereby a poke-bonnet, so that by this means the article may be worn suitably as a French cap or as a poke-bonnet. I attain this object by the article illustrated in the accompanying drawings, in which—

Figure 1 represents my improved poke-front, made in the style according to my invention, and detached. Fig. 2 represents the so-called "French pattern style cap," of worsted or suitable material. Fig. 3 is the combination of the French style cap, with my improved poke-front, suitable for being worn as a fashionable poke-bonnet.

A represents the body of the French pattern 30 style cap, made of worsted or other suitable goods. It has a ruffled front and bottom edge or ruche, B, with silk tipping and scalloping, and is trimmed with ribbon.

D represents the poke-front, which may be made of worsted or lace or other suitable 35 goods. Its rear portion, E, is a cap, over which the French pattern style cap A is fitted loosely. It is shown smooth and plain, but may have plain trimming. To its front is attached, in a neat and strong manner, the front 40 portion, F, having full pokes G toward the top of the same, which gradually lessen their fold downward and terminate finally by flat ears HH. The outside of the portion E has its pokes trimmed with silk scalloping, which 45 reduces toward the ears H. The front edge is tipped with silk, and the inside is lined at I I with suitable bonnet-lining, and is trimmed with the lace and ribbon ruffle or ruche J.

What I claim as my invention, and desire to 50 secure by Letters Patent, is—

In poke-bonnets, the combination of the French (pattern style) cap with the detached poke-front D, for the purpose and in the manner substantially as herein shown and set forth. 55
