

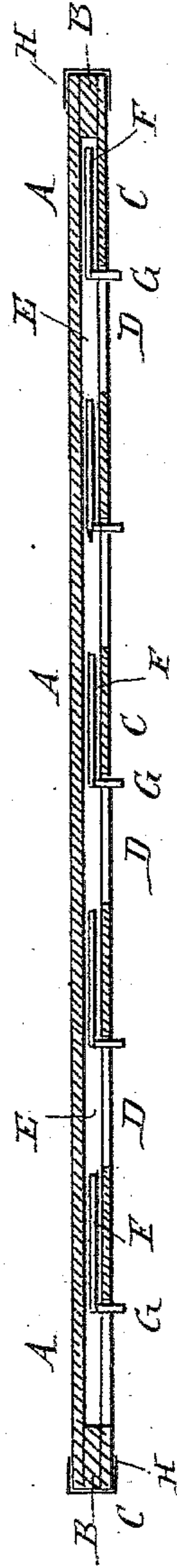
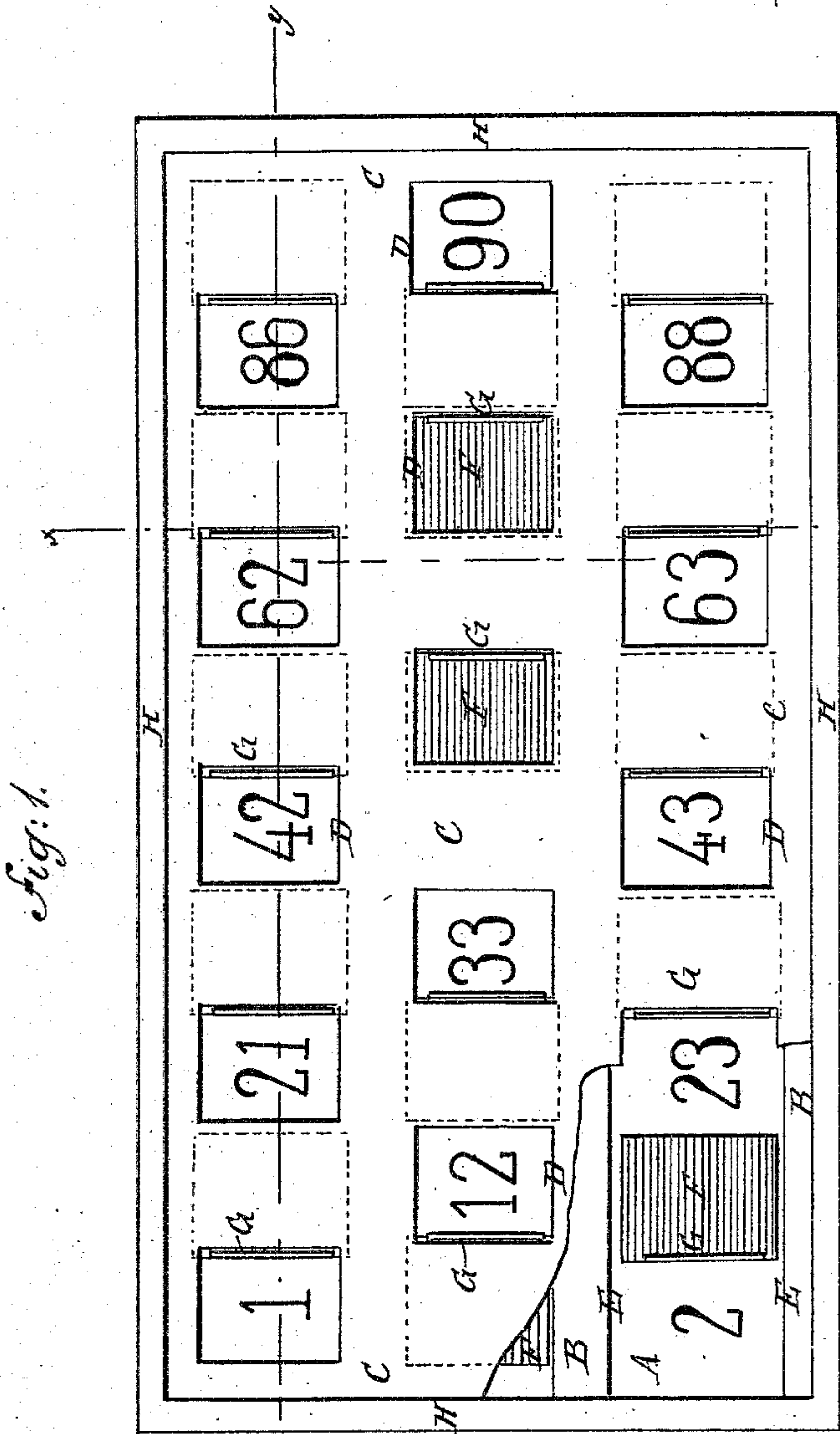
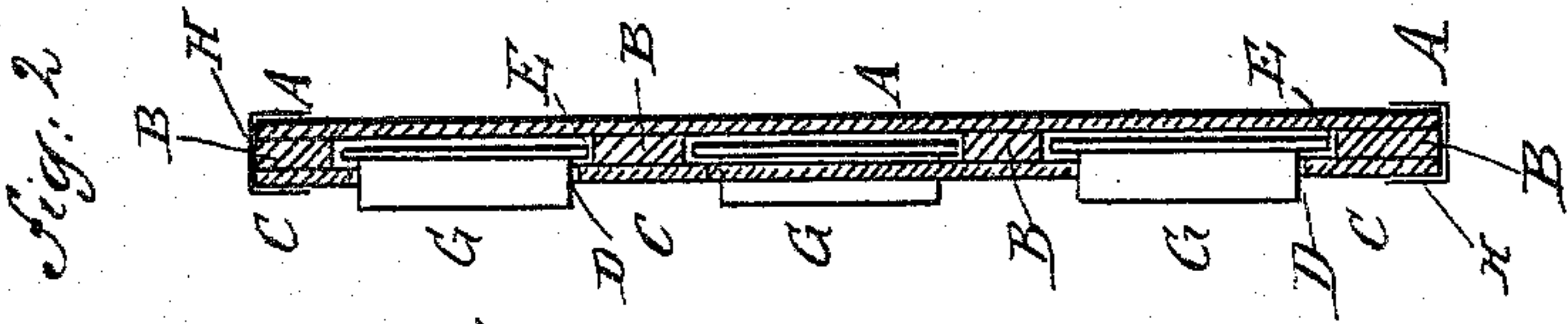

## CARD FOR PLAYING LOTO AND OTHER GAMES.

SPECIFICATION forming part of Letters Patent No. 295,388, dated March 18, 1884.

Application filed January 5, 1884. (No model.)

*To all whom it may concern:*

Be it known that I, HENRY HELLER HARRISON, of the city, county, and State of New York, have invented certain new and useful  
5 Improvements in Cards for Playing Loto and other Games, of which the following is a full, clear, and exact description.

Reference is to be had to the accompanying drawings, forming part of this specification,  
10 in which similar letters of reference indicate corresponding parts in all the figures.

Figure 1 is a plan view of one of my improved cards, part being broken away. Fig. 2 is a sectional end elevation of the same,  
15 taken through the line *x x*, Fig. 1. Fig. 3 is a sectional side elevation of the same, taken through the line *y y*, Fig. 1.

The object of this invention is to promote convenience in using cards for playing loto  
20 and other games.

The invention consists in a card for playing loto and other games, made with a base-plate having the numbers printed upon it, an intermediate plate having slots over the rows of  
25 numbers, a top plate having openings over the numbers, and slides for covering the numbers, as will be hereinafter fully described.

The body of the card is formed of three parts or plates—viz., the base or main plate,  
30 A, the intermediate plate, B, and the top plate, C. The numbers are printed or otherwise formed upon the base-plate A, and in the plate C, directly over the said numbers, are formed openings D, to allow the said numbers to be readily seen. In the intermediate  
35 plate, B, upon the lines of the numbers, are

formed slots E, to receive the slides F, which are made of sufficient size to close the openings D and cover the numbers. The slides F have flanges G upon one edge, which project through the openings D, and serve as handles for convenience in adjusting the said  
40 slides to cover and uncover the numbers.

The plates A B C may be cemented or otherwise secured to each other, and the card can  
45 have a light frame, H, attached to the edges of its front, to strengthen it and give it a finish.

Having thus described my invention, what I claim as new, and desire to secure by Letters  
50 Patent, is—

1. A card for playing loto and other games, made substantially as herein shown and described, and consisting of the base-plate A, having numbers printed upon it, the intermediate plate, B, having slots E over the lines  
55 of numbers, the top plate, C, having openings D over the numbers, and the slides F to cover the numbers, as set forth.

2. In a card for playing loto and other games, the combination, with the base-plate  
60 A, having numbers printed upon it, of the intermediate plate, B, having slots over the rows of numbers, the top plate, C, having openings D over the numbers, and the slides F to cover the numbers, and provided with handle-  
65 flanges G, substantially as herein shown and described, whereby the numbers can be readily covered and uncovered, as set forth.
