


PERFUMERY-STAND.

SPECIFICATION forming part of Letters Patent No. 297,235, dated April 22, 1884.

Application filed March 3, 1884. (No model.)

To all whom it may concern:

Be it known that I, VINZENT DEMUTH, of Brooklyn, county of Kings, and State of New York, have invented certain new and useful 5 Improvements in Perfumery-Stands, of which

the following is a specification.

This invention has reference to an improved perfumery-stand, made in the shape of a birdcage; and the invention consists of the per-10 fumery-stand in the shape of a bird-cage and made of a detachable wire body, a supporting-base, a perfumery-bottle corresponding in shape to the interior of the body, and means for retaining the body and bottle on the base.

In the accompanying drawings, Figure 1 represents a side elevation of my improved perfumery stand; Fig. 2, a vertical central section on a larger scale; and Fig. 3, a horizontal section of the same on line x x, Fig. 2.

Similar letters of reference indicate the same

parts throughout the several views.

A in the drawings represents a disk-shaped base, and B a detachable wire body of my improved perfumery-stand, which base and body 25 are made in imitation of a bird-cage. The detachable wire body B is made in any suitable design, and secured to the base A by catches a or other fastening devices. A perfumery-bottle, C, is supported at the interior of the wire 30 body B, and made to correspond in its general outline to the wire body B, the neck of the bottle C being extended through an opening

in the upper end of the wire body and closed by a stopper, D, having an ornamental metal cap. The neck projects slightly above the 35 open top of the wire body, so that the ornamental cap of the stopper D forms the cap of the entire device. A suspension-ring, b, is hirged to the upper part of the body B.

The device forms an ornamental stand for a 40 perfumery-bottle to be placed on the mantel-

piece, dressing-case, toilet-case, &c.

Having thus described my invention, I claim as new and desire to secure by Letters Patent-

1. A perfumery-stand formed of a support- 45 ing-base, a detachable wire body, B, a perfumery-bottle supported on the stand inside of the wire body, and means whereby the body is attached to the base, substantially as and for the purpose set forth.

2. The combination of a supporting-base, A, a wire body, B, having an opening in the top part, and a perfumery-bottle supported on the base in the wire body, the neck of said bottle being extended through the open top of the 55 wire body and closed by an ornamental stopper or cap, substantially as set forth.
