

WILLIAM STARRETT, OF NORTH MANCHESTER, INDIANA.

DOOR-SECURER.

SPECIFICATION forming part of Letters Patent No. 297,465, dated April 22, 1884.

Application filed December 18, 1883. (No model.)

To all whom it may concern:

Be it known that I, WILLIAM STARRETT, a citizen of the United States, residing at North Manchester, in the county of Wabash and State of Indiana, have invented certain new and useful Improvements in Door-Securers, of which the following is a specification, to wit:

This invention relates to an improvement in door-securers; and it consists in the peculiar construction of the same, substantially as will be hereinafter more fully set forth.

In order to enable others skilled in the art to which my invention appertains to make and use the same, I will now proceed to describe its construction and operation, referring to the accompanying drawings, in which—

Figure 1 is a transverse section of a door and its frame, with my device in practical use, and Fig. 2 is a perspective view of the device.

A represents a hook-shaped piece of metal, having upon one side, at right angles to its main body, a flange, a, and beyond this a half-cylindrical screw-threaded extension, a', formed on its flat side, with a socket, a^2 , as seen in the drawings.

B represents a half-cylindrical piece flanged and screw-threaded to correspond exactly with the extension a', and formed on its flat face 30 with a projection, b, which enters the socket in the opposite portion, and retains them in proper relation with each other. The parts a' B are easily separated, but are held from complete detachment by means of a bent wide loop, C, having an enlargement, c, at its outer 35 end, as shown. When the two parts a' B are in position, they are held as by a nut, D, screwed upon them, as seen in Fig. 1. In operation this nut is screwed off and back upon the wire C, and the hooked shank in-40 serted between the door and jamb. When the door is closed, the hook is forced into the jamb, and the piece B and nut D being placed in position, the door is firmly held.

The device is of great use to any one travel- 45 ing, and is easily carried in the pocket.

Having thus fully described my invention, what I claim as new, and desire to secure by Letters Patent, is—

In a door-securer, the hook-shaped piece A, 50 having a flange, a, screw-threaded shank a', and socket a^2 , in combination with the flanged part B, having projection b, nut D, and bent wire loop C, substantially as and for the purpose set forth.
