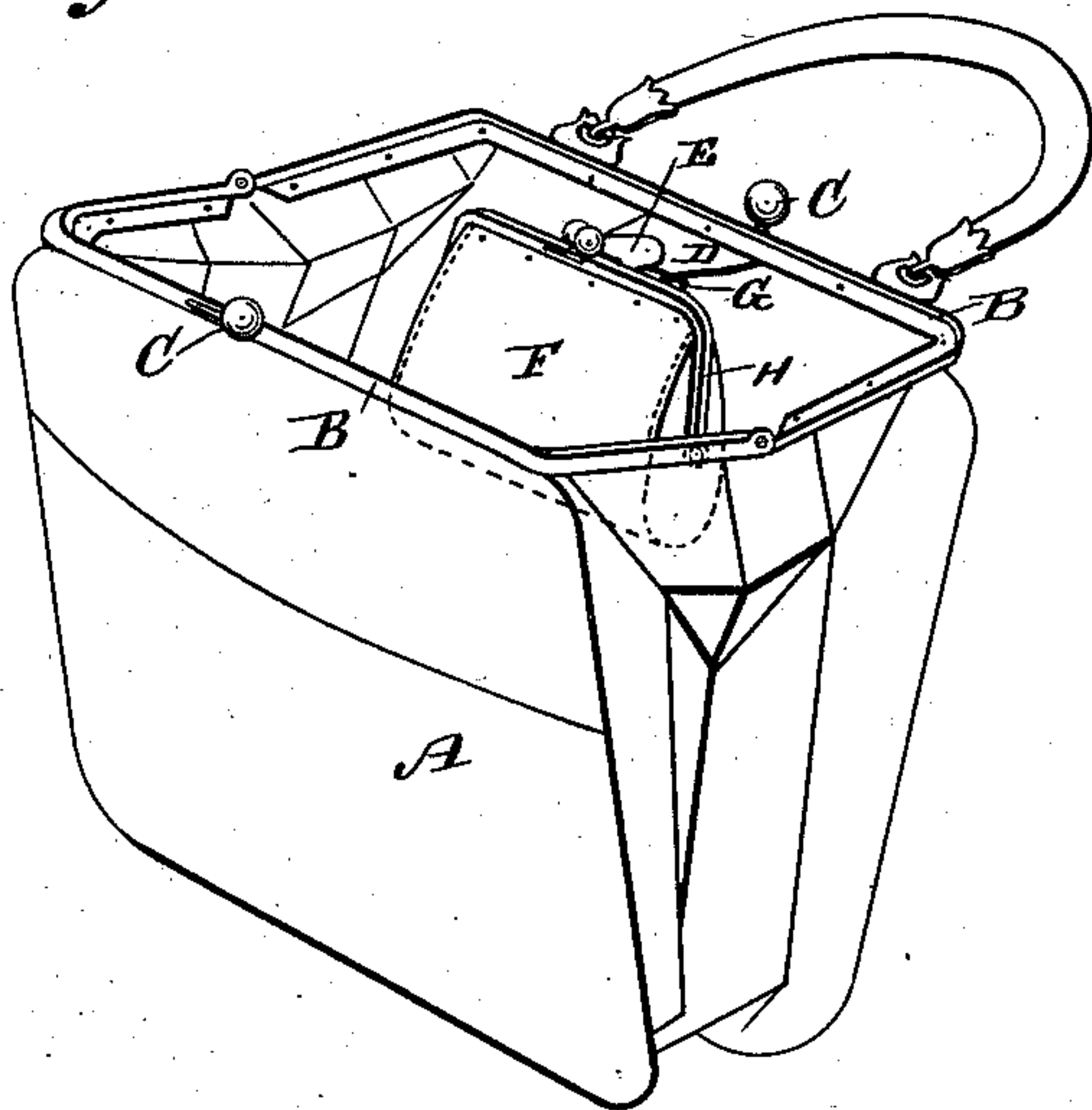

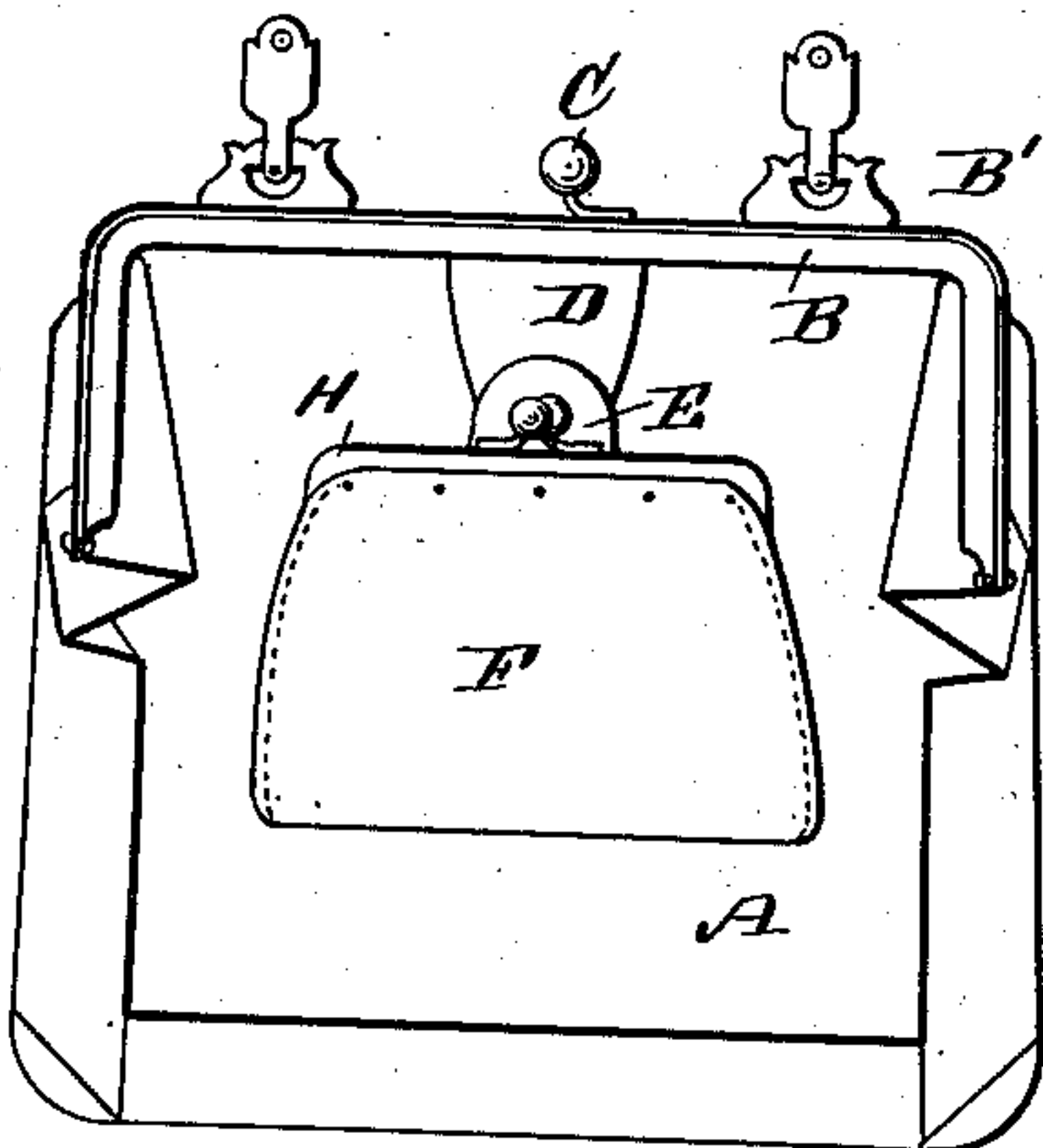

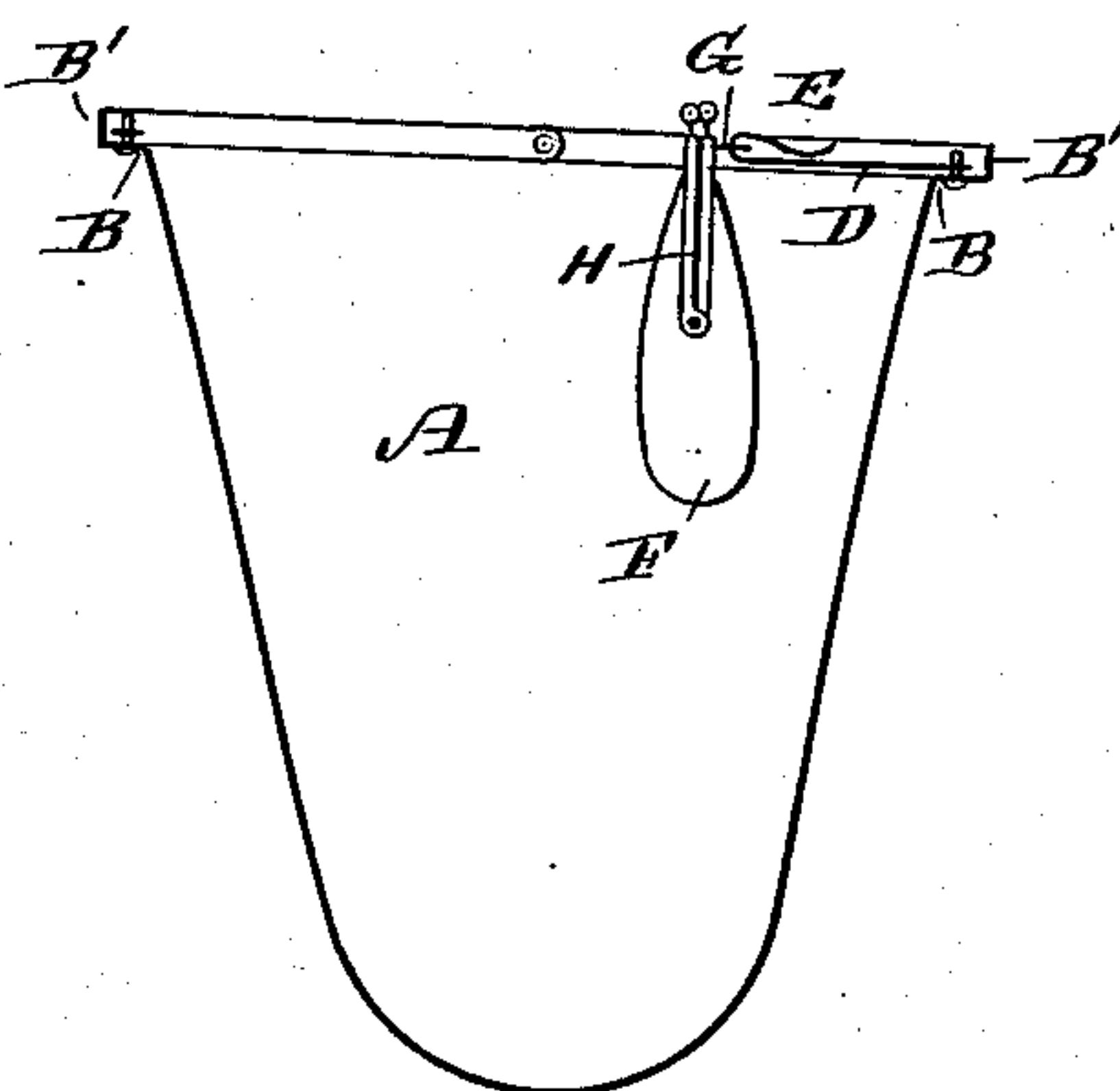
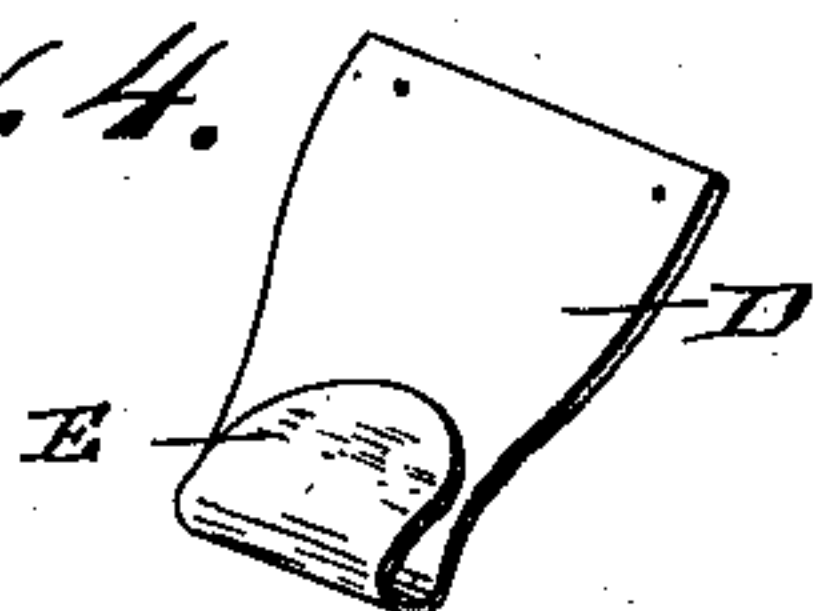


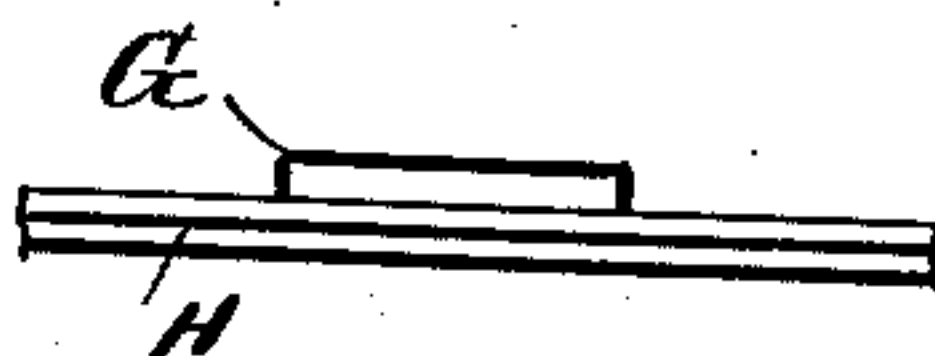

ROBERT WEINTRAUD, OF OFFENBACH-ON-THE-MAIN, GERMANY.

HAND-BAG.

SPECIFICATION forming part of Letters Patent No. 302,071, dated July 15, 1884.

Application filed May 23, 1884. (No model.)

To all whom it may concern:

Be it known that I, ROBERT WEINTRAUD, a person resident at Offenbach-on-the-Main, in the Empire of Germany, have invented new and useful Improvements in Hand-Bags, of which the following is a specification.

The object of my invention is to provide a hand-bag or satchel provided with a new and improved device for holding a purse, pocket-book, or like article in such a manner that the pocket-book or purse can easily be taken from the bag for use, is lifted out of the bag when the same is opened, and finally cannot become detached when the bag is closed and get mingled with the other articles in the bag, whereby the tedious search for the pocket-book or purse is avoided.

The invention consists in a plate or frame secured to the inner surface of one frame of a satchel or hand-bag in such a manner that it projects down into the bag when the same is closed, and over the opening of the bag when the same is opened, which plate or frame is provided on its free end with means for holding a purse, pocket-book, &c.

Reference is to be had to the accompanying drawings, forming part of this specification, in which similar letters of reference indicate corresponding parts in all the figures.

Figure 1. is a perspective view of a hand-bag or satchel provided with my improved attachment, the bag being opened and a pocket-book held by the attachment. Fig. 2 is a longitudinal sectional view of the bag, the same being closed. Fig. 3 is a cross-sectional elevation of the same, showing it opened. Fig. 4 is a perspective view of the hook-plate or attachment for holding the pocket-book. Fig. 5 shows a plan view of the frame of the pocket-book and the loop on the same.

The hand-bag or satchel A, or like article, is provided with two frames, B, of the usual construction, which are hinged to each other at their ends, and are provided with the locking-button C, or with other suitable locking devices. A piece or frame, D, of sheet metal, hard rubber, or any other suitable material, is secured to one of the frames B in such a manner that the said plate will be in the same plane with the frame, and at right angles to the flanges B', so that when the bag is closed the plate D projects down into the bag, and

when the bag is opened the plate D will project transversely over the opening of the same. A hook, E, is formed on the free end of the plate D, the hook being formed on that side of the plate opposite that side facing the side of the bag.

The purse or pocket-book F has a longitudinal loop, G, of wire, leather, cord, or any other suitable material, formed on its frame H, or on any other part, through which loop G the hook E is passed, thus holding the purse or pocket-book on the free end of the plate D.

When the bag A is opened and the frames B swung from each other as far as possible, the free end of the plate D is swung upward and the pocket-book, &c., raised out of the bottom of the bag, and can easily be removed from the plate D to be used. If the pocket-book is then again hung on the hook of the plate D and the bag closed, the pocket-book is swung down into the bag and cannot mingle with the other articles in the bag, and can be reached and found immediately upon opening the bag. The plate D holds the purse or pocket-book to one side of the bag, thus leaving sufficient space for other articles which can be reached easily.

Instead of forming the hook E on the plate D, it can be formed on the purse or pocket-book, and an eye or loop can be formed on the plate D.

Card-cases, note-books, toilet-cases, &c., can be held in hand-bags, satchels, reticules, &c., in the manner described.

Having thus described my invention, I claim as new and desire to secure by Letters Patent—

A satchel, hand-bag, or reticule having a plate or frame secured to the inner surface of one of the frames of the bag, to project down into the bag when the same is closed, and over the opening of the same when it is open, which plate or frame is provided on its free end with a loop or hook, substantially as herein shown and described.
