


ATTACHMENT FOR PANTS.

SPECIFICATION forming part of Letters Patent No. 312,033, dated February 10, 1885.

Application filed December 22, 1883. (No model.)

To all whom it may concern:

Be it known that I, ISIDOR STARK, of the city, county, and State of New York, have invented certain new and useful Improvements 5 in Attachments to Pants, of which the following is a specification.

This invention has reference to an improved attachment to pants which are specially de-

signed for children's use.

In the accompanying drawings, Figure 1 represents a perspective view of a pair of pants with my improved attachment. Fig. 2 is a detail side view and vertical transverse section of one of the suspension-straps.

Similar letters of reference indicate corre-

sponding parts.

A in the drawings represents a pair of pants, overalls, or drawers, and B the waistband of the same. A number of elastic suspension-loops, 20 C, are secured at the point of connection of the waistband with the body of the pants, said suspension-loops being provided at their upper ends with wire eyes or with button-holes cut into the loops and re-enforced by leather, webbing, 25 or other suitable material. The suspensionloops C are preferably made of rubber webbing, the loop being passed through the wire eye a. A band or tape, D, extends parallel to the waistband on the inner face thereof, and 30 is attached thereto at points between the loops distant from the edges thereof. This band passes through the upper ends of the suspension-loops, and serves to retain the loops in upright position, and at the same time affords 35 sufficient lateral play of the loops to enable them to be readily connected with the buttons on the waist with which the pants are de-

signed to be connected, whether said buttons be accurately adjusted or not. The eyes or button-holes a are held by the band D in po- 40 sition so as to be conveniently attached to the buttons of the waist.

My improved attachment for children's and other pants can be manufactured quickly and cheaply, as the parts can be put together and 45 connected on the sewing-machine without requiring special skill in attaching the suspension-straps to the pants. They give thereby a better fit to the body in sitting or stooping, and support the pants in a more comfortable 50 manner.

Having thus described my invention, I claim as new and desire to secure by Letters Patent—

The combination, with a pair of pants, overalls, or drawers, of a series of suspension-loops 55 provided at their upper ends with button holes or eyes, and attached at their lower ends to the pants or waistband, and a band passing through said loops near their upper ends, and secured to the waistband at points between said 60 loops distant from the edges thereof, whereby the upper ends of said loops are supported in upright positions and permitted to play laterally to conform to the locations of the fastenings to which said eyes or button-holes are 65 designed to be secured, substantially as described.
