











WATCH-CASE HINGE.

SPECIFICATION forming part of Letters Patent No. 313,448, dated March 3, 1885.

Application filed August 28, 1884. (Model.)

To all whom it may concern:

of Illinois, have invented certain new and use-5 ful Improvements in Hinge-Joints for Watch-Cases; and I do hereby declare that the following is a full, clear, and exact description thereof, reference being had to the accompanying

drawings, in which—

Figure 1 is a perspective view of a watchcase containing my improved hinge, the cover being opened. Fig. 2 is a like view of the parts of the hinge separated from each other. Fig. 3 is a perspective view of the cover por-15 tion of said hinge, with the pivotal pins in the positions occupied when said cover is connected with the case-center; and Figs. 4 and 5 are sections upon a line passing through the axes of said pivotal pins, and show, respectively, 20 the positions of the latter when engaged with and disengaged from the case-center portion of the hinge.

Letters of like name and kind refer to like

parts in each of the figures.

which is entirely within the case, and has for its object the ready connection or separation of the cover and case-center portions of the same; to which end said invention consists, principally, 30 in a hinge for watch-cases in which the pivotal pin is constructed in two sections that are contained within the axial opening of the center lug, and may be moved longitudinally outward from the same until their outer ends enter in-35 to and engage with the axial openings of the adjacent outer lugs, substantially as and for the purpose hereinafter specified.

It consists, further, in a hinge for watchcases in which the pivotal pin is constructed 40 in two sections that are contained within the axial opening of the center lug, and by means of a screw, which is arranged to pass between their inner contiguous ends, may be forced longitudinally outward until their outer ends en-45 ter into and are contained within the axial openings of the adjacent outer lugs, substantially as and for the purpose hereinafter shown.

In the carrying of my invention into effect two lugs, A and A, are secured within the re-50 cessed interior of a case-center, B, at a suitable distance apart, to permit of the insertion between their inner ends of a third lug, C, which is attached to a cover, D. Said lug C is se-

cured at one end to the inner side of said cov-Be it known that I, Frederick Rapp, of er, inside of the bearing-edge d of the latter, 55 Chicago, in the county of Cook, and in the State | and extends in a curve downward and outward, so as to bring its opposite outer end into position between said lugs A, while for its passage an opening, b, is formed within said case-center partly or wholly within the bear- 60 ing-face b', that is provided for said bearingedge d, the arrangement being such that the hinge-lugs are contained wholly within the case and are not seen when said case is closed.

Within each lug A is provided an opening, 65 a, which coincides axially with a similar opening, a, in the opposite lug A, and with a like opening, c, in the center lug, C, and in connection with said openings serves to contain the

pivotal or axial hinge-pins E.

In order that the pins E may be readily inserted, they have a united length which corresponds with the width of the center lug, C, and enables them to be contained within and just fill the opening c in and through the same. 75 A screw, F, having a rounded or pointed end, passes radially inward through said lug, and, My invention relates to a watch-case hinge | by being turned inward, passes between the contiguous inner ends of said pins, and, forcing each outward, causes its outer end to project 80 from said opening c.

> To connect the cover with the case-center, the screw F is withdrawn until the pins E can be pushed together and be wholly contained within the opening c. The lug C is then placed 85 in position between the lugs A, and said screw then turned inward until said pins are forced outward and the outer end of each caused to enter into and engage with the opening a of the contiguous lug A. In order that said pins 90 may not work outward farther than is desired, the said openings a have but slightly greater depth than is necessary to permit of the entrance of said pins. While the center lug of the hinge is preferably attached to the cover, 95 and the other lugs are attached to the casecenter, the positions of said parts may, if desired, be reversed.

I do not herein claim, specifically, pivotal pins arranged to move longitudinally outward 100 into engagement with the adjacent hinge-lugs, such construction being covered by another application for patent, Serial No. 141,648.

Having thus fully set forth the nature and merits of my invention, what I claim is—

1. A hinge for watch-cases in which the piv-

otal pin is constructed in two sections that are contained within the axial opening of the center lug, and may be moved longitudinally outward from the same until their outer ends enter into and engage with the axial openings of the adjacent outer lugs, substantially as and for the purpose specified.

2. A hinge for watch-cases in which the pivotal pin is constructed in two sections that are contained within the axial opening of the center lug, and by means of a screw, which is arranged to pass between their inner contigu-

ous ends, may be forced longitudinally outward until their outer ends enter into and are contained within the axial openings of the adjacent outer lugs, substantially as and for the purpose shown.
