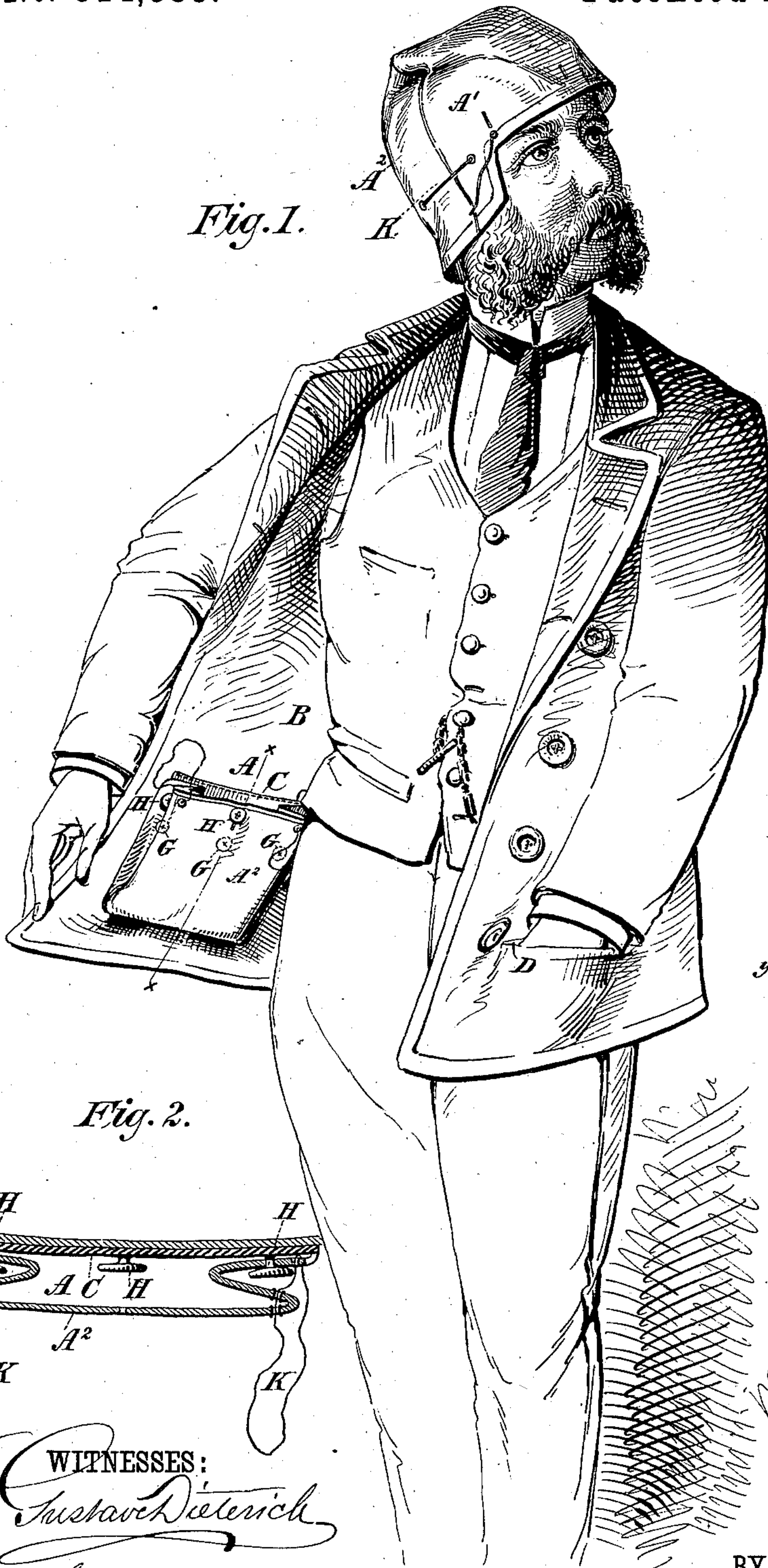
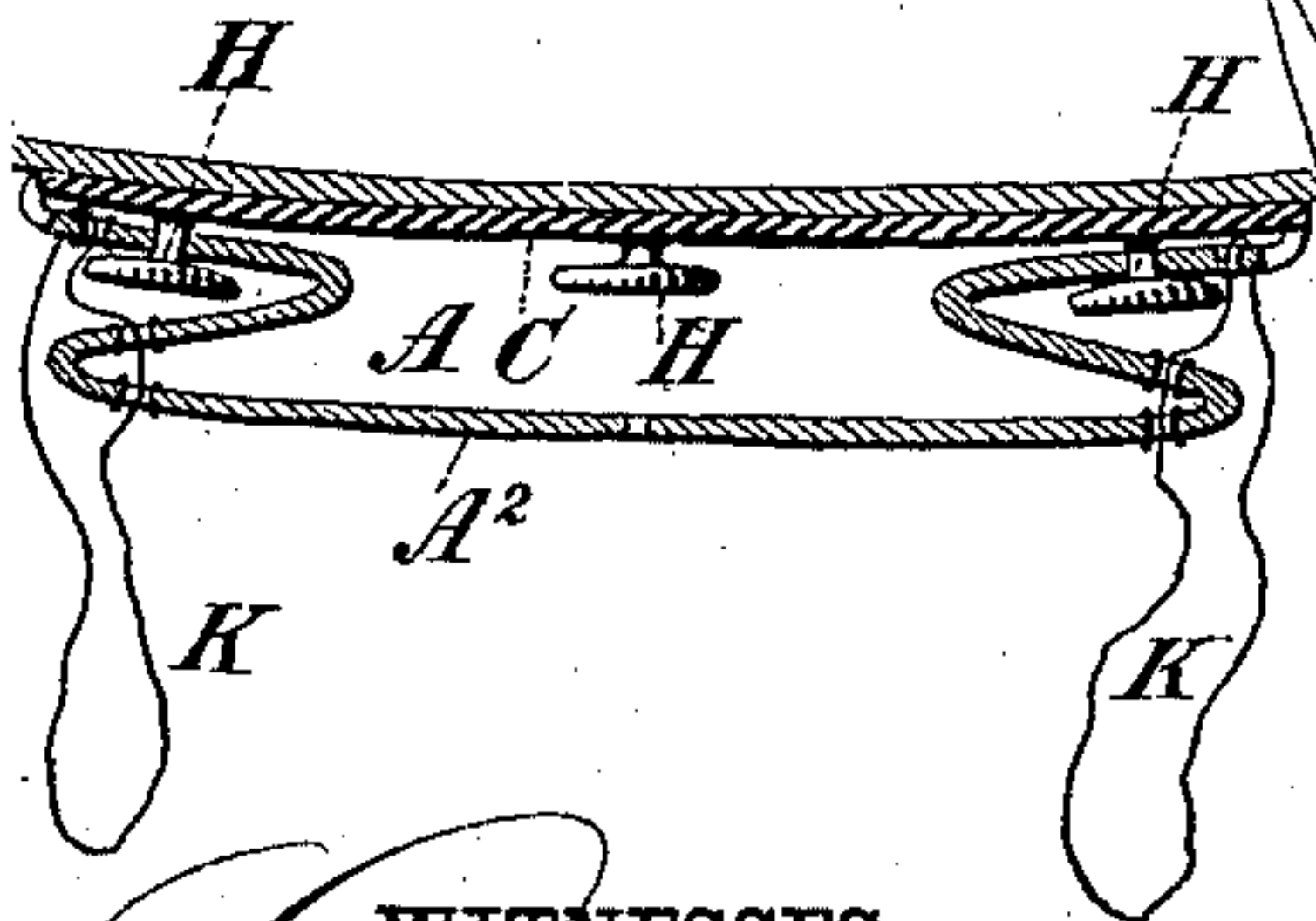


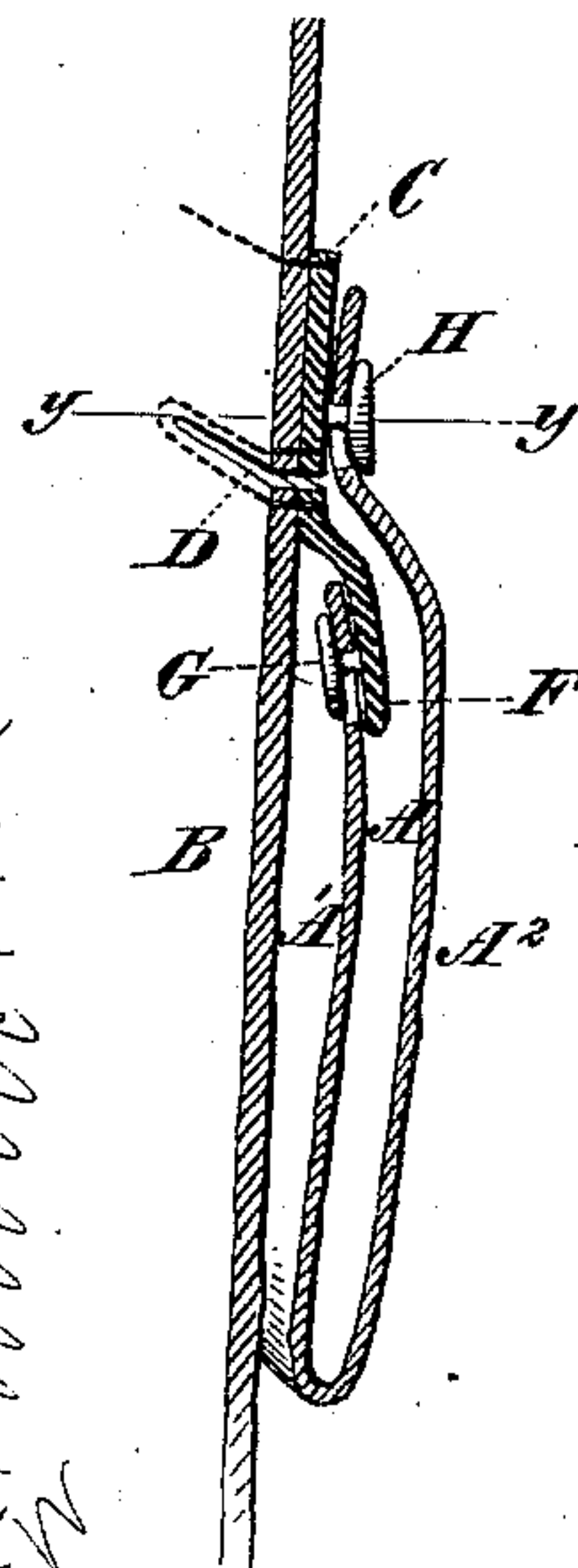

## COMBINED DETACHABLE POCKET AND CAP.

SPECIFICATION forming part of Letters Patent No. 314,333, dated March 24, 1885.

Application filed February 14, 1884. (No model.)

*To all whom it may concern:*

Be it known that I, ANDREW HELLER, of the city, county and State of New York, have invented a new and Improved Combined Detachable Pocket and Cap, of which the following is a full, clear, and exact description.

The object of my invention is to provide a new and improved combined detachable pocket for coats, which pocket can be detached readily and used as a cap.

The invention consists in the combination, with a coat, of a detachable pocket held on the same, which pocket can be worn as a cap.

Reference is to be had to the accompanying drawings, forming part of this specification, in which similar letters of reference indicate corresponding parts in all the figures.

Figure 1 represents a person wearing a coat provided with my improved combined detachable pocket and cap. Fig. 2 is an enlarged horizontal sectional view of the pocket and coat on the line *yy*, Fig. 3. Fig. 3 is an enlarged vertical sectional view on the line *xx*, Fig. 1.

A pocket, A, has the side A' resting against the inner surface of the coat B, and made shorter than the opposite side, A<sup>2</sup>, of the pocket.

To the inner surface of the coat B a piece of fabric, C, is sewed, which is provided with a slot coinciding with the pocket-slot D. The edges of the slot in the piece C are sewed to the coat at the edges of the slot D, and the upper edge of the piece C is sewed to the coat. The lower edge of the piece C is not sewed to the coat, but forms a downwardly-projecting tongue, F, on the inner side of the coat.

A series of buttons, G, is secured to that side of the tongue F facing the inner side of the coat, and a series of buttons, H, is sewed to the outer surface of the piece C.

The sides A' A<sup>2</sup> of the pocket are provided at their upper edges with button-holes for receiving the buttons G and H, respectively.

Cords K are passed through the upper corners of the pocket for the purpose of draw-

ing the sides of the pocket together at the upper corners when the pocket is held on the coat, or for holding the cap on the head.

When the pocket is secured on the coat, the tongue F projects into the top of the pocket, the upper edge of the side A' of the pocket being held to the inner side of the tongue F by the buttons G, and the upper edge of the side A<sup>2</sup> being held to the piece C by the buttons H. The side A<sup>2</sup> is folded to form the ends of the pocket, as shown in Fig 2.

The pocket can readily be detached and can then be worn as a cap, the long side A<sup>2</sup> covering the back of the head.

The cords K are untied before placing the cap on the head, to permit the mouth of the cap being opened sufficiently to pass the cap on the head.

The above-described pocket can be combined with any coat, and is very handy for travelers, soldiers, firemen, and others.

Having thus described my invention, I claim as new and desire to secure by Letters Patent—

1. The herein-described pocket A, having the sides A' A<sup>2</sup>, the side A' being shorter than the side A<sup>2</sup>, and each provided with button-holes in its upper edge for attaching the same to a coat above and below a pocket-slit, and provided with the strings K, passed through the upper corners for drawing the sides together, substantially as herein shown and described.

2. The combination, with a coat, of a piece secured to the inner side of the coat and provided with a slot coinciding with the pocket-slot in the coat, and of a detachable pocket adapted to be held on the said piece, substantially as herein shown and described.

3. The combination, with a coat, of a piece, C, secured to the inner side of the same and forming a tongue F, and of a detachable pocket adapted to be held on the said piece, substantially as herein shown and described.
