

HENRY ROSE, OF PRAIRIE DU SAC, WISCONSIN.

COMBINED WASH-STAND AND DRESSING-CASE.

SPECIFICATION forming part of Letters Patent No. 315,343, dated April 7, 1885.

Application filed July 26, 1884. (No model.)

To all whom it may concern:

Be it known that I, Henry Rose, a citizen of the United States, and a resident of Prairie du Sac, in the county of Sauk and State of Wisconsin, have invented certain new and useful Improvements in Combined Wash-Stand and Dressing-Case; and I do hereby declare that the following is a full, clear, and exact description of the invention, which will enable others skilled in the art to which it apertains to make and use the same, reference being had to the accompanying drawings, which form a part of this specification, and in which—

Figure 1 is a perspective view of my improved combined wash-stand and dressing case. Fig. 2 is a vertical sectional view taken on the line xx in Fig. 1, and Fig. 3 is a perspective detail view

spective detail view.

The same letters refer to the same parts in

20 all the figures.

This invention relates to an article of furniture comprising a combined wash-stand and dressing-case; and it has for its object to provide a device of this character which shall be convenient, ornamental in appearance, and inexpensive.

To this end my invention consists in the improved construction and arrangement of parts, which will be hereinafter fully described, and particularly pointed out in the claims.

In the drawings, A designates the body of my improved dressing-case, in which drawers Care suitably arranged. The back of the said body A is provided with upwardly-ex-35 tending standards D D, between which a mirror, E, is hinged or pivoted in the usual wellknown manner. One side of the body A is provided with lateral extensions F, which form the top and bottom of a case or compartment, 40 G, provided at the front with a door, H. The top of the side compartment, G, is provided with a casing, I, having a hinged door, J, the sides of which are provided with inwardlyextending flanges K K, between which a tow-45 el rack or roller, L, may be arranged, if desired, as shown in Fig. 2, and which is also provided at its lower end with an inwardlyextending shelf, M, upon which toilet articles—such as a soap-cup, tooth-brush holders,

50 and the like—may be conveniently arranged.

Shelves N N are also arranged between the

sides of the compartment G, upon which a water-pitcher and other articles may be placed, so as to be conveniently reached. The top of the side compartment is formed by a slab, O, 55 which may be formed with a recess, P, constituting a wash-basin, or a plate or slab, Q', may be used, upon which a wash-basin of ordinary construction may be placed. When the top slab is constructed with an integral 60 casing, I provide the waste-spout with a downwardly-extending tube, Q, through which the waste water may escape into a bucket, R, placed underneath, as shown in the drawings. The front side of the door of the compartment 65 G is provided with a rounded cover, R', between which and the base a board or inclined slab, S, is interposed, so as to form an inclined desk or surface for writing or other purposes.

The advantages of this invention will be 70 readily seen from the foreging description, taken in connection with the drawings hereto

annexed.

As an article of furniture it is simple and convenient, and when properly constructed it 75 will present a very ornamental and attractive appearance.

Having thus described my invention, I claim and desire to secure by Letters Patent of the

United States—

1. The combination, with the bureau and its wash-stand extension, of the upper casing, I, having a hinged door, J, provided with the outwardly-projecting rounded cover R', and inwardly-projecting shelf M, and having the 85 inclined slab S, as shown and set forth.

2. The combination of the casing I, having fixed shelves N N, and hinged door J, having the fixed horizontal bottom part or shelf, M, outside projecting cover, R', and inclined 90 board or slab S, so arranged that shelf M forms a top for the wash-stand, on which casing I is placed, when the door is closed, substantially as and for the purpose set forth.
