







HARNESS.

SPECIFICATION forming part of Letters Patent No. 336,494, dated February 16, 1886.

Application filed November 7, 1885. Serial No. 182,085. (No model.)

To all whom it may concern:

Be it known that I, Henry T. Richmond, of Malvern, county of Mills, State of Iowa, have invented a new and useful Improvement in Harness, of which the following is a specification.

My invention relates to improvements in harness; and it consists in the construction of a check-rein with a peculiar means for connecting the same to the other portion of the harness, as hereinafter fully set forth.

In the accompanying drawings, which are a part of this specification, Figure 1 represents a harness with my improvements embodied therein. Fig. 2 represents a plan view of the same. Figs. 3 and 4 are views of detached portions of the invention on an enlarged scale.

Similar letters refer to similar parts through-20 out the several views.

A A represent the lines of the harness, and are of the usual construction. B is the overdraw, and is at one end secured to the bit and at the other connected by the check-snap G to 25 the check-rein H, the latter having perforations therein, and passing through the checkfastener E, which is secured to the pad C by a screw, a, or other suitable means, and consists of a plate with side flanges, b, furnishing bear-30 ings for a weighted pivotal portion, c, having a pin or projection, d, on the under side thereof, the said pin being adapted to enter the perforations in the check-rein H. Secured to the said check-rein H is a snap carrying a 35 roller, F, which latter permits of the free play of the check ease or strap D, buckled or fastened at both ends to the reins A A, the latter having perforations, so as to admit of adjust-

The operation of the device is simple and can be readily understood, the elevation of the head of the horse being controlled at the will of the driver, and any jerking motion due to

ing the check ease and rein.

the connection of the overdraw with the backband being prevented. As can readily be 45 seen, the fastener can be easily released, thus permitting the horse's head to be lowered when desired. By using the roller F in connection with the check-ease D the pulling on either of the lines in the guidance of the horse 50 has no effect on the other parts of the device.

What I claim, and desire to secure by Letters Patent, is—

1. A check-rein adjustably connected to the overdraw at one end and the lines at the other, and devices, substantially as described, for adjusting said check-rein, as set forth, said parts being combined substantially as de-

scribed.

2. The lines A, having perforations, in com- 60 bination with check-ease D, snap with roller F, check-rein H, overdraw B, connected to bit, and check-fastener E, substantially as described.

3. An adjustable fastening device, in com- 65 bination with a check-rein connected to an overdraw, and by means of a snap with roller to a check-ease, the latter being secured to the lines, substantially as described.

4. The check-fastener E, having a pivoted 70 weighted portion with pin d, in combination with check-rein H, secured to the overdraw B and check ease D, and lines A A, substantially

as described.

5. The overdraw B, secured to the bit, in 75 combination with check-rein H, detachably secured to the overdraw, and having the check-fastener E, operating therewith, snap with roller F, check ease D, adjustably secured to lines A A, and lines A A, substantially as and for 80 the purpose set forth.
