

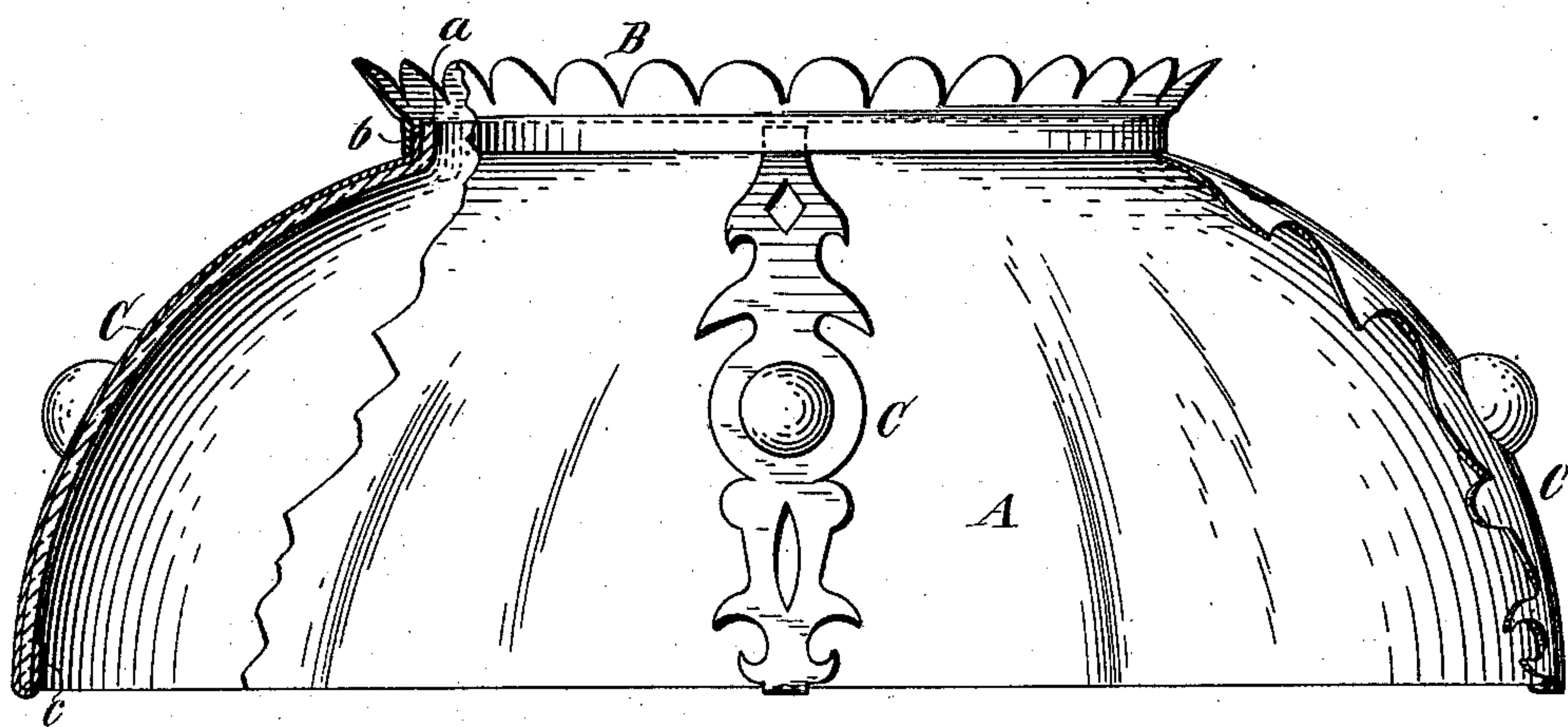

## ORNAMENT FOR LAMP-SHADES.

SPECIFICATION forming part of Letters Patent No. 351,700, dated October 26, 1886.

Application filed July 2, 1886. Serial No. 206,915. (No model.)

*To all whom it may concern:*

Be it known that I, WOLCOTT A. HULL, of New York, in the county and State of New York, have invented a certain new and useful  
5 Improvement in Ornaments for Lamp-Shades, of which the following is a specification.

My improvement relates to ornaments employed to decorate shades for lamps.

The improvement consists in the combination, with a shade, of a crown around the upper part of the shade and ornaments provided with hooks that engage the lower edge of the shade.

The accompanying drawing represents a  
15 shade provided with ornaments embodying my improvement, a portion of the shade being in section.

A designates a shade. It may be made of any desirable material and shape. At its upper  
20 edge it is provided with a rim or flange, *a*.

B designates a shade crown or ring adapted to be arranged on the shade outside the rim or flange *a*.

The ornaments C are made of any suitable  
25 material, preferably metal, and are disposed at intervals about the shade. They are provided near their lower ends with hooks *c*, here shown as integral with the ornaments. These hooks engage the lower edge of the shade,  
30 and tend to prevent displacement of the ornaments.

In the example of my improvement shown the ornaments are severally provided with lip-like portions *b*, which may be bent in such

manner as to extend between the rim *a* and the crown or ring C when the latter is in place. 35  
By this means the liability of the ornaments to displacement at their upper ends is lessened. Of course the ornaments might be provided with hooks at their upper ends—as, for instance, the lip-like portions *b* might be made  
40 long enough to be bent over the edge of the rim *a* of the shade, if desirable.

In the illustration of my improvement given the crown B is made in one piece; but it is obvious that the crown may be made in sections  
45 and secured with the ornaments in any desirable manner.

It will be seen that by my improvement the ornaments may be readily secured upon the  
50 shade, and when in position swinging or lateral movement is practically avoided. It is advantageous to secure them at top and bottom, because then both ends of the ornaments are effectually secured from displacement, even  
55 when carrying the lamp or dusting off the shade.

What I claim as my invention, and desire to secure by Letters Patent, is—

The combination, with a shade, of a crown  
60 around the upper part of the shade and ornaments secured with the crown on the shade, and provided with hooks that engage the lower edge of the shade, substantially as specified.
