

## POCKET WRITING-CASE.

SPECIFICATION forming part of Letters Patent No. 362,106, dated May 3, 1887.

Application filed October 23, 1886. Serial No. 217,014. (No model.)

To all whom it may concern:

Be it known that we, Ruben R. Pember and Edward B. Snedigar, citizens of the United States, residing at Maynard, in the county of Fayette and State of Iowa, have invented a new and useful Improvement in Pocket Writing-Cases, of which the following is a specification.

Our invention consists of a pocket-case so arranged as to contain in suitable compartments ink, (red and black,) pen-holder, pencil, extra pens, pins, erasers, pen-wiper, mucilage, ruler, stamps, postal-cards, envelopes, and paper.

Our invention is shown in the accompanying drawing, which is a perspective view of the case with the lid opened to show the interior. The cover to compartments a and b is removed to show more clearly the interior construction.

The case consists of two parts hinged together, one of them, A, being deeper than the other one, B, which serves as a lid. The case may be constructed of any suitable material, and is of the proper size to be placed in the pocket when closed. The lower part, A, is divided into compartments by the thin partitions c and c'. Ink-bottles i i are secured in two of the compartments in the two front corners of the case. A pen-wiper, d, is secured in a compartment adjoining one of the ink-bottles. The compartments a and b are intended for postage-stamps, pens, pins, and other small articles. A cover, e, (shown ly-

partments a and b, being hinged to the partition c runs longitudinally

ing beside the case,) fits closely on the com-

nearly across the remaining portion of the case. A ruler, h, (shown in cross-section at D,) fits in one of the compartments thus formed. One side of the ruler has grooves in 40 which pen holders and pencils may be placed. The space left at the end of the partition c'allows the ruler to be readily removed from its compartment when wanted for use. The rear compartment, f, may be used to contain a mu- 45 cilage-bottle or pencil. The rubber band g, or a pocket, if preferred, may be used to hold postal-cards, envelopes, blotters, or other papers. For fastening the lid we use a pin, m, which extends through a small hole in the 50 front of the case, as indicated by the dotted line. A small piece, n, is attached to the lid and fits into a hole, o, when the lid is closed. The pin m is then pushed into place, and the point enters into a hole in the piece n, securely 55 fastening the lid.

We do not claim this fastening as a part of our invention. Any other suitable fastening may be used, if desired.

Having thus described our invention, what 60 we claim as new, and desire to secure by Letters Patent, is—

In a pocket writing case, the combination of ink-bottles i i, pen-wiper d, compartments a, b, and f, grooved ruler h, cover e, and band g, 65 constructed substantially as and for the purpose specified.
