

TRUNK OR TRAVELING-CASE.

SPECIFICATION forming part of Letters Patent No. 417,440, dated December 17, 1889.

Application filed August 2, 1889. Serial No. 319,557. (No model.)

To all whom it may concern:

Be it known that I, FRANK J. PALICA, of Racine, in the county of Racine, and in the State of Wisconsin, have invented certain new and useful Improvements in Trunks or Traveling-Cases; and I do hereby declare that the following is a full, clear, and exact description thereof.

My invention relates to trunks or travel-10 ing-cases, and will be fully described herein-

after.

In the drawings, Figure 1 is a central crosssection of a trunk embodying my invention; Fig. 2, an end view, and Fig. 3 a detail.

A is the rear wall of a trunk, which is made with an overhanging portion B at its top that is joined by the sides, and from the inner termination of the portion B the sides are formed each with a short vertical shoulder a, and 20 from the bottom of these shoulders the sides are inclined down to the front wall of the trunk, which is lower than the rear wall. The top C is formed with sides C', that are deeper | in front than in the rear and fit the body, as 25 shown in Fig. 2, and the rear edge of the top is hinged to the upper part of the overhanging portion B, so that when the top is raised it will come within the vertical plane of the rear wall of the trunk, and hence the top may 30 be fully lifted without moving the trunk from the wall.

On the inside of each end of my trunk is arranged a cleat D, in which is formed a recess d, that, beginning with an abrupt shoul-35 der at about the center of the cleat, inclines upward toward the rear. These cleats are to support the tray E in a horizontal position, as shown in dotted lines, Fig. 1, or in a vertical position, as shown in full lines; and 40 that the tray may be supported when raised and to facilitate its raising and insertion I incline the lower portion of its rear edge, as at f, and the upper portion, as at g, so that the tray may be inserted by simply placing 45 its rear edge on the inclines d of cleats D, and then turning it down, when it will natu- | therein. rally ride back on the inclines and under the

act of lifting it will cause its rear edge to slide forward on the inclines until the abrupt 50 shoulders are reached, when it will tilt back just enough to stand on edge supported by the portion B. The corners of the overhanging portion B protect the hinges h, by which the top is connected to the trunk, and for 55 additional security may be provided with guards i, and the top when raised may be held up by the usual toggle-brace j.

In a trunk made according to my invention, when the top is raised full access is 60 gained to the inside on the removal of the tray, and even when the tray is only lifted the inside of the trunk is sufficiently exposed for ordinary purposes, and the form of the tray and supporting-cleats is such that the 65 tray can be easily tilted up, and when up there is very little danger of it falling acci-

dentally.

Having thus described my invention, what I claim as new, and desire to secure by Letters 70

Patent, is—

1. The combination, with a trunk-body having a rear overhanging portion and sides shouldered to correspond and inclined downward to the front of the trunk, of a top hinged 75 to said overhanging portion and provided with downwardly-inclined sides registering with the said inclined sides of the trunk-body, substantially as set forth.

2. The combination, in a trunk, of tray-80 cleats having inclined and shouldered recesses, and a tray having inclined rear edge,

substantially as described.

3. The combination, with the trunk having rear overhanging portion and top hinged 85 thereto, of the tray having inclined rear edge, and the tray-cleats having inclined and shouldered recesses.

4. The combination, with a trunk having a rear overhanging portion and a top hinged 90 thereto, of tray-cleats secured to the inside of the trunk and provided with shouldered recesses, and a tray adapted to be supported

5. In a trunk, the combination, with the 95 portion B, and when it is to be taken out the body made higher at the rear than at the

front, and provided with sides having vertical rear shoulders and downwardly-inclined top edges extending to the front of the trunk, of a top made shallow at the rear and deep in front, and having sides with inclined bottom edges registering with the inclined sides of the trunk-body, substantially as set forth.
