

WALL ORNAMENT.

SPECIFICATION forming part of Letters Patent No. 440,764, dated November 18, 1890.

Application filed June 18, 1890. Serial No. 355,812. (No model.)

To all whom it may concern:

Be it known that I, MALACHI E. CONEGAN, of Rochester, in the county of Monroe and State of New York, have invented a new and 5 useful Improvement in Wall Ornaments, which improvement is fully set forth in the following specification and shown in the accompanying drawings.

My invention consists of a pendent shelf 10 for the wall formed and designed to hold fans or fan-shaped parts spread or opened out, all parts together constituting a pleasing and useful ornament for the wall, the same being hereinafter fully described, and more particu-

15 larly pointed out in the claim.

Referring to the drawings, Figure 1 is a front elevation of the ornamental device with parts broken away and omitted; Fig. 2, a side elevation with the fans omitted, seen as indi-20 cated by arrow 2 in Fig. 1; and Fig. 3, a plan, seen as indicated by arrow 3 in Fig. 1, with parts omitted.

Referring to the parts, A is a vertical plate or part formed of wood, sheet metal, or other 25 material, constituting the back of the shelf, and B a horizontal part, rigid with A, forming a shelf.

G is a vertical brace serving to strengthen

the parts A and B.

a is an ornamental wire-hanger for the device formed with a loop b at its upper end to pass over a nail or screw driven in the wall.

D D and E E are fans ordinarily constructed or ornamental fan-shaped parts held by the 35 device, respectively, above and below the shelf B.

The hanger α is formed with lateral extensions c and d, and in putting the upper or large fans in place the bars e of the fans are 40 bent so as to be in front of the extensions cand back of the extensions d, as shown. The hinges or joints of the fans are back of the shelf, and the bending of the bars e in front and back of the extensions c and d, respect-45 ively, as stated, causes the fans to hold to their places on the device. The lower bars f of the fans are turned down horizontally, as shown, the two fans together forming a semicircle.

The small fans E E are also put in place, so as to form a semicircle beneath the shelf, as shown. The bars g of these fans are pressed I

under or back of spring clasps or holders h, rigid with the shelf and bent near to the part A. The brace G is formed with an opening 55 i, Fig. 2, in which to receive the parts of the fans near the joints p, by means of which and the spring-clasps h the small fans are held to place on the device. The four fans thus arranged form a symmetrical figure, and, with 60 the shelf, an attractive ornament for the wall, the fans selected being pictorial, highly colored, gilded, &c.

The hanger α is offset from the shelf, as shown in Fig. 2, for the purpose of making 65 room for the thick parts of the large fans at

their joints.

k is a horizontal bar rigid with the part A at its rear surface to bear against the wall F to aid in supporting and steadying the de- 70 vice. It also acts as a spacer and relieves the hanger by holding it slightly away from the wall. The hanger a is secured to the shelf, preferably by being bent under the latter, as shown, an opening l being formed in 75the part A to allow the wires to pass through.

An overhanging ledge or part n is secured to the upper surface of the shelf partly to give finish to the shelf and also to aid in steadying the large fans. The lower bar f of 80 the right-hand fan rests under the narrow part of the ledge, while the more extended part o of the ledge is intended to meet the bar f of the left-hand fan. The bar f of the left-hand fan corresponds with the bar e of 85 the right-hand fan, and is on the farther side or next the wire or hanger.

What I claim as my invention is—

An ornament for the wall, consisting of a shelf and fans arranged thereon, in combina- 90 tion with a hanger for the device formed with lateral extensions c and d above the shelf, the fans having rests at the back of the shelf with said lateral extensions bearing on opposite sides of the fans, substantially as de- 95 scribed.
