


## LABEL-HOLDER.

SPECIFICATION forming part of Letters Patent No. 472,248, dated April 5, 1892.

Application filed December 8, 1891. Serial No. 414,362. (No model.)

To all whom it may concern:

Be it known that I, HENRY F. BENTE, of the city of St. Louis and State of Missouri, have invented certain new and useful Improve-5 ments in Devices for Securing Cards to Boxes, especially Cigar-Boxes, of which the following is a full, clear, and exact description, reference being had to the accompanying drawings, forming a part hereof.

My invention relates to improvements in devices for securing cards to boxes, especially cigar-boxes; and it consists in the novel arrangement and combination of parts, as will be more fully hereinafter described, and des-

15 ignated in the claims.

In the drawings, Figure 1 is a perspective view of a box having my invention applied thereto. Fig. 2 is a cross-section of the same. Fig. 3 is a perspective view of one of the 20 clasps detached, and Fig. 4 is a perspective view of the blank from which the device or

clasp is formed.

The device that I am about to describe in detail is adapted to temporarily support a dis-25 play-card, upon which card is printed the name of the cigar or tobacco, the firm or person's name who manufactures or handles the cigars or tobacco, and the price of said cigars or tobacco. The device or clasp for support-30 ing said display-card is so constructed as to temporarily secure the same between the box and the lid, or, namely, the hinged portion of the box containing the cigars or tobacco.

My invention is especially applicable to 35 boxes containing tobacco, but preferably that

of cigars.

Referring to the drawings, 1 represents a box, which is of the ordinary construction and constructed to hold eigars, and 2 a lid or 40 cover hinged to the same by means of the ordinary fabric or linen, such as 3. Between said box or cover or through said hinged portion my invention is easily inserted temporarily.

4 represents a clasp, which is formed from a single piece of metal of such a thickness as to be easily conformed to the shape de-

sired.

Referring to Fig. 4 of the drawings, in which | 50 is shown the blank from which my device is

divided into three parts, as shown by dotted lines in the said figure, portion 5 tapering from the dotted line to the terminal end thereof. The opposite end 6 of said blank 4 is pro- 55 vided with a V-shaped end 7, the sides of said V-shaped end converging to a point 8, by which means the plate 4 can easily be inserted through the hinge 3 of the box.

Before proceeding further with the detail 60 description it will be well to state that by preference I employ two of the devices whereby the display-card is held rigidly to the box. However, I do not limit myself to the number of said devices, as this is only a matter of 65

convenience.

Having given the construction of the blank, I shall now proceed to describe the formation of said device after the same has been completed and is ready to be applied to the box 70

containing the cigars or tobacco.

From the dotted line (referring again to Fig. 4) the plate or blank 4 is slightly bent, forming two arms 6 and 9 at an obtuse angle of about one hundred and thirty-five degrees. 75 From the dotted line adjacent to the portion 5 the blank 4 is again bent and folded upon itself, forming a clasp, between which the display-card 10 is inserted.

Owing to the formation of the device or 80 plate 4, the device or devices when attached to a box of cigars, as shown in Fig. 1 of the drawings, the display-card 10 will be slightly inclined from the rear side of the box 1, in order that the letters or words printed thereon 85 may be easily read from the show-case within

which said box is placed.

The surface of the display-card is preferably divided off, as shown in Fig. 1 of the drawings, the center of which displays the 90 name of the cigar, the left-hand corner the name of the manufacturer of said cigars or the name of the person or firm handling said cigars, and the price of the cigars at the righthand end of said display-card.

Having fully described my invention, what

I claim is—

1. The herein-described device for securing cards to boxes, especially eigar-boxes, consisting of a blank 4, having a tapering end 5 and 100 the opposite end provided with a point 8, and formed, I will conceive that said blank is I an intermediate portion 9, upon which the

tapering end 5 is folded, substantially as set forth.

2. The herein-described device for securing cards to boxes, especially cigar-boxes, comprising a portion 6, a portion 9, bent at an obtuse angle relative to said portion and having its tapering terminal portion 5 bent upon itself, thus constituting an elastic clasp, and

between said portions 5 and 9 a card is adapted to be interposed, substantially as set forth. In testimony whereof I affix my signature in presence of two witnesses.
