



DETACHABLE SHIRT-BOSOM.

SPECIFICATION forming part of Letters Patent No. 604,970, dated May 31, 1898.

Application filed November 10, 1897. Serial No. 658,058. (No model.)

To all whom it may concern:

Be it known that I, JOHN W. COOPER, a citizen of the United States, residing at Cherry Hill, in the county of Bergen and State of 5 New Jersey, have invented certain new and | useful Improvements in Detachable Shirt-Bosoms; and I do hereby declare the following to be a full, clear, and exact description of the invention, such as will enable others 10 skilled in the art to which it appertains to make and use the same.

My invention relates to improvements in shirt-bosoms; and its primary object is to provide a novel false or detachable bosom having 15 two fronts, either one of which is adapted to

be exposed at will.

A further object is to provide a bosom of this character having a body portion in semblance of a closed bosom-front and two side | 20 flaps adapted to be folded over upon the back of said body portion to expose the closed bosom-front or over upon the front thereof

The detailed objects and advantages of the 25 invention will appear in the course of the sub-

joined description.

With the accomplishment of these ends in view my invention consists in a shirt-bosom embodying the novel construction of parts 30 hereinafter more fully described and claimed.

In the accompanying drawings, illustrating the invention, Figure 1 is a front view of a shirt-bosom embodying my invention, showing the side flaps folded over upon the inner 35 or closed bosom-front. Fig. 2 is a longitudinal section of same. Fig. 3 is also a front view, but shows the side flaps folded back to expose the closed bosom-front. Fig. 4 is a back view showing the side flaps outspread; Fig. 40 5, a cross-section of the shirt-bosom on the line 44 of Fig. 1, and Fig. 6 is an enlarged detail view of the neckband and cape.

Referring now more particularly to the drawings, 1 represents the main body portion 45 of the bosom, formed of two or more plies of fabric united by the continuous line of stitching a and having the neck-opening 2. In the present instance this body portion is shown formed by two plies, a back ply 3 and a front 50 ply 4. This front ply 4 has the semblance of a closed bosom-front and is provided with a central plait 5, having stud-holes 6. At the

lower end of the said front is a tongue or flap 7, formed with a buttonhole 7', whereby it may be buttoned to the drawers to hold the 55 lower end of the bosom in place. The material of the main body portion is extended at each side to form a folding flap 88', and the plies of each flap are united by a continuous line of stitching b. Each folding flap is cut 60 away at its upper end to form a neck-opening, and the flap 8' is provided at its lower end with a tongue 9, having a transverse opening 9' and a buttonhole 92. These two flaps are adapted to be folded over upon the 65 closed bosom-front 4 to conceal the same and form the semblance of an open-front shirtbosom and to be folded back upon the back ply 3 to expose the said front 4. One flap is made a little wider than the other in order 70 that their edges will overlap when folded, and said flaps are provided with coinciding stud-holes 10 for the passage of a stud or studs to hold them folded. The front plies to form the semblance of an open bosom-front. Fof the flaps may be plaited, if desired, to re- 75 semble a plaited shirt-bosom proper.

When the flaps 88' are folded over upon the bosom 4, as shown in Fig. 1, the tongue 7 is passed through the opening 9' of the tongue 9 to the front and buttoned to the drawers; 80 but when the flaps are folded back, as shown in Fig. 2, the tongue 7 is passed through said opening to the rear and the tongue 9 is buttoned to the drawers. By this means the lower ends of the flaps are prevented from 85 spreading open, the lower end of the bosom is held in place, and at the same time the drawers are supported. Although the folding flaps are shown in the present instance as being formed by extending the material of the 90 main body portion 1, it will be understood that they may be made independent of said body portion and united thereto by stitching.

The bosom is adapted to be supported upon the body of the wearer by neckband-pieces 11 95 11', which in practice extend around the collar or neckband of the shirt. Each neckbandpiece is preferably formed of a section of fabric 12 and an elastic section 12', said sections being provided at their meeting ends with 100 buttonholes for passage of a button to secure them together. Each elastic section is also formed at its outer end with a buttonhole for engagement with the button which unites the

neckband-sections of the shirt at the placketopening. The said elastic sections are adapted to yield or give to adapt the neckbandpieces to shirt-bands of different sizes. Cape-5 bands 13, adapted to be buttoned together, may be used, if desired, to aid the neckband

in supporting the bosom.

From the above description, taken in connection with the accompanying drawings, the 10 construction and mode of use of my improved false or detachable shirt-bosom will be clearly understood. This false bosom may be used in connection with either stiff or soft bosomed shirts without inconvenience or annoyance 15 and is capable of being readily and conveniently put on and taken off. It provides a simple and effective means whereby two different patterns or styles of shirt-fronts may be combined in a single shirt-bosom and a 20 clean bosom-front exposed after the bosomfront in use has become soiled.

Having thus fully described my invention, what I claim as new and useful, and desire to secure by Letters Patent of the United States, is—

A false or detachable shirt-bosom, consisting of a body portion in the form of a bosomfront and provided at its lower end with a tongue having a buttonhole, and side flaps adapted to be folded over upon the face of 30 the body portion, one of said flaps being provided at its lower end with a tongue having a buttonhole and an opening through which the tongue on the said body portion is adapted to be passed, substantially as described.
