

BUST-PAD AND CHEST-PROTECTOR.

SPECIFICATION forming part of Letters Patent No. 626,589, dated June 6, 1899.

Application filed October 11, 1898. Serial No. 693,259. (No model.)

To all whom it may concern:

Be it known that I, MAURICE FREDERICK BUCHNER, gentleman, a resident of 2 Higher Parade, New Brighton, in the county of Ches-5 ter, England, have invented new and useful Improvements in Bust-Improvers and Chest-Protectors, (for which an application for patent has been filed in Great Britain, dated March 15, 1898, No. 6,351,) of which the fol-10 lowing is a full, clear, and exact description.

My invention relates to a bust-improver and chest-protector for ladies and others, and has mainly for its object to provide a light, cool, and easily-adjusted substitute for pads 15 as a means of improving the figure of the wearer by imparting a natural appearance of fullness at the chest and preventing unsightly creases in the outer garment and a contracted or stooping appearance, especially in the 20 case of flat-chested figures. The device is also eminently suitable for use as a chest-protector by persons having delicate organs of respiration.

Reference is to be had to the accompanying 25 drawings, forming part of this specification, wherein—

Figure 1 represents a front view of the bustimprover; and Fig. 2 shows, to an enlarged scale, a central vertical cross-section of the

30 same on line 22, Fig. 1.

The device (which may be worn separately or be combined with a vest, bodice, corset, or other undergarment) is adapted to cover the region of the chest and is made, preferably, 35 of a light, airy, and open fabric—such, for instance, as fine horsehair cloth, sateen, muslin, or other gauze (including metallic gauze) ---but it may be made of other material.

The improver is formed of an outer fabric 40 a and a backing b, shaped to suit the position which the improver is intended to occupy upon the chest and around the base of the neck of the wearer, the outer fabric a being cut rather larger in depth than the backing 45 b and the two being united or bound together at the edges, so that while the backing b lies comparatively flat and fits close to the natural figure of the wearer an inflated or puffy form, whose fullness diminishes gradually from the 50 center to the sides, is necessarily imparted to

the outer fabric a, this fullness of appear ance and the elasticity of the improver being maintained by flexible stiffening-ribs $c\ c'$ of light whalebone, (whether real or imitation,) horn, steel, or other stiffeners used as sub- 55 stitutes for whalebone in corsets and bodices. These stiffening-ribs are contained within sheaths of suitable fabric attached to the back of the outer fabric a, as indicated in Fig. 2, and they extend from the top to the bottom 60 edge of said fabric, and thus are constrained by the difference of dimensions of the two parts a and b to assume an outwardly-curved form and to hold the outer fabric correspondingly distended, as shown. The center rib 65 c' is secured to the backing b by stitching for a distance of about two inches from its upper end, as shown at c^2 , in order to impart the proper curved form to the lower part of said rib, as shown in Fig. 2. The backing b may 70 also be stiffened, if necessary, in the transverse direction by means of one or more flexible ribs, as d, of similar material to the ribs c and contained in a sheath or sheaths attached to the inner surface of the backing b, 75 so as to extend from side to side thereof. By providing the upper fabric a with inextensible tapes or other means of maintaining the curvature of the stiffeners or by giving the stiffeners a permanent set or curvature it 80 would be possible to dispense with the backing b, and such a bust-improver is comprised within the scope of this invention.

The device if combined with a bodice, corset, or other undergarment may be attached 85 thereto in any way suited to the requirements of individual taste or special circumstances, and if worn as a separate article (which is the form more particularly illustrated in the drawings) may be secured in place by 90 means of any suitable fastenings. The fastenings shown consist of shoulder straps or loops e, a neckband f, and a central tab g in front, all preferably of elastic cord or the like material, although bands or tapes of silk, 95 sateen, or other suitable material may be used and would be fastened to the improver by means of hooks, buttons, clips, or buckles. The shoulder-straps instead of being fastened each by both ends to the same side of the im- 100 prover may be crossed at back, each being carried (from its upper point of attachment) across the back and under the opposite arm and being made fast by a tab at i by means of a hook, button, clip, or buckle.

The device if intended to be worn for the protection of the chest in cold weather would preferably be lined with flannel or what is

known as "Jaeger" material.

I claim—

1. A bust-improver and chest-protector for ladies and others consisting of front and back portions of porous or other fabric united at their edges and curved to fit around the front 15 of the neck, the front portion being cut larger in depth than the back portion, light flexible ribs or stiffeners radiating from the neck curve and secured to the front portion, the back portion being so much smaller than the 20 front portion in the direction of the length of the ribs or stiffeners as to act as a tie therefor whereby the said ribs or stiffeners are constrained to assume a curved form so as to keep the front portion elastically distended, 25 the central rib or stiffener, for a portion of its length from the neck curvature downward being secured to the said back portion, the said upper portion of the rib being straight, a transverse stiffener secured to the lower 30 part of the back portion and extending from side to side thereof, and means for securing

the article in place on the wearer, substan-

tially as specified.

A bust-improver and chest-protector for ladies and others, consisting of an outer fab- 35 ric and a backing united at their edges and shaped to fit around the neck, flexible stiffening-ribs contained in sheaths secured to the back of the outer fabric, the said stiffening-ribs extending radially from the neck 40 curve to the lower edge of the fabric, the said backing being of less depth than the outer fabric, thereby causing the ribs to assume an outwardly-curved form, the central stiffeningrib for a portion of its length from the neck 45 curvature downward, being secured to the said backing, whereby the proper curvature is given to the lower part of said rib, a transverse stiffener contained in a sheath attached to the inner surface of the lower portion of 50 the backing and extending from side to side thereof, the article being provided with shoulder-straps, a neckband, and a central tab at its lower edge, for fastening the device in place, substantially as specified.
