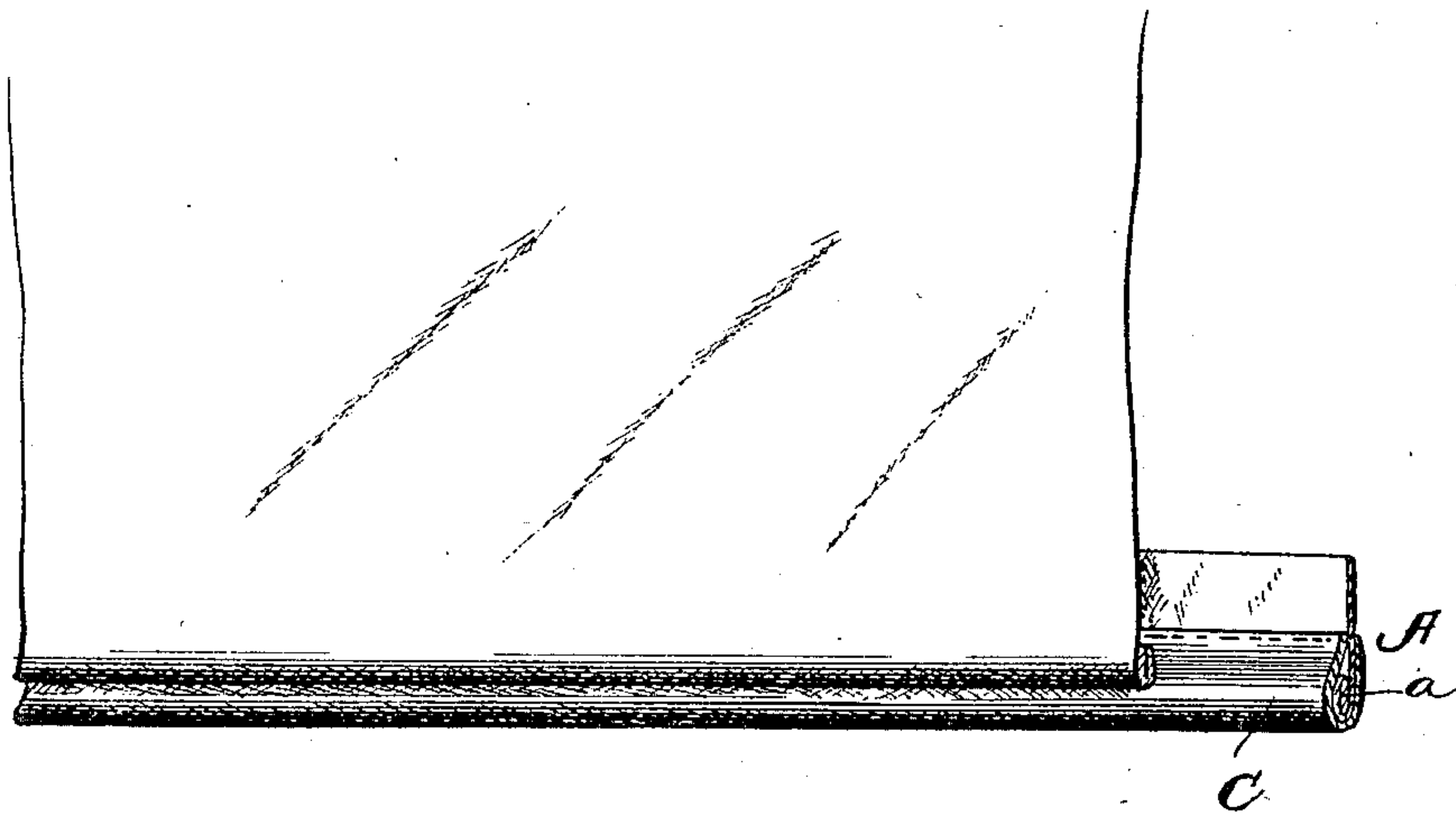

## DRESS BINDING AND FACING.

SPECIFICATION forming part of Letters Patent No. 632,383, dated September 5, 1899.

Application filed April 14, 1899. Serial No. 713,027. (No model.)

*To all whom it may concern:*

Be it known that I, AARON M. WEBER, a citizen of the United States, residing at Oshkosh, in the county of Winnebago, State of Wisconsin, have invented certain new and useful Improvements in Dress Bindings and Facings, of which the following is a description, reference being had to the accompanying drawings and to the letters of reference marked thereon.

My invention relates to improved dress bindings and facings; and the object is to provide a double binding for garments.

The invention therefore consists in an outer and an inner binding, so that when the outer binding is worn out it can be cut off clean to the edge and there will still remain the inner binding, giving the same finish to the skirt as it had before.

The invention is illustrated in the accompanying drawings, in which—

Figure 1 is a front view of a portion of a garment provided with my improved double binding, and Fig. 2 is a cross-section of the same.

To make the double binding, I first preferably take a bias strip of either plain or rubber-treated material suitable for a skirt-binding and wide enough to make a binding and a facing, this being indicated in the drawings

at A. On one edge I form a roll or coil and, if desired, may insert a cord *a*. This is preferably stitched on in a manner so that the stitches will not show and, it will be seen, forms a finished binding and facing. I then stitch over this inner facing or binding a strip of rubber-treated velvet or other suitable material, so as to cover the first binding, forming a second binding and facing, this being indicated at C.

Having thus described my invention, what I claim, and desire to secure by Letters Patent, is—

As a new article of manufacture, a binding for garments and the like, comprising a strip of material adapted to be secured to the garment, and provided on its lower inner edge with a fold or roll, and a second strip of material inclosing the fold or roll of the first strip and secured to the first strip above the fold-line, whereby the outer binding may be removed when worn, and yet leave a new binding at the bottom of the garment; substantially as described.
