



TROUSERS-HANGER.

SPECIFICATION forming part of Letters Patent No. 654,340, dated July 24, 1900.

Application filed November 18, 1899. Serial No. 737,467. (No model.)

To all whom it may concern:

Be it known that I, CHATTIN BRADWAY, a citizen of the United States, residing at Philadelphia, in the county of Philadelphia and State of Pennsylvania, have invented new and useful Improvements in Trousers-Hangers, of which the following is a specification.

My invention relates to a trousers-hanger, and has for its object to provide a device which is adapted to hold four pairs of trousers and which is at the same time small and compact.

The several novel features of construction and combination of parts will be hereinafter more fully described, reference being had to the accompanying drawings, in which—

Figure 1 is a perspective view of the invention. Fig. 2 is a plan view thereof. Fig. 3 is a side view showing the hanging hook turned down and the leaves clamped.

Similar numerals correspond to similar parts in the several views.

The device consists of two strips of metal. At suitable points the ends of the strips are bent oppositely, forming the leaves 1 and the central leaf 2. The numeral 3 represents the enlargement or eye formed at the point of bend. 4 is a rivet securing together the double thickness of the strip and serving as a stop for the clamping-ring 5, the enlargement 3 serving a similar purpose. The clamping-

30 stop for the clamping-ring 5, the enlargement 3 serving a similar purpose. The clamping-rings 5 are adapted to move between the eyes 3 and the stops 4 and engage the end of the leaves 1. The two strips are similarly posi-

tioned and have pivotally secured between 35 them the hanging-hook 6, which turns down between the strips when it is desired to obtain greater compactness, as for traveling purposes.

The trousers hang from the bottom, a pair 40 being inserted between each of the leaves 1 and 2, which latter are clamped.

Having thus described my invention, what I claim as new, and desire to secure by Letters

Patent, is—
1. A trousers-hanger consisting of strip metal, the ends bent oppositely forming three leaves, an enlargement at the point of bend, a rivet approximate said enlargement, a clamping-ring confined between said rivet 50 and said enlargement, a hanging-hook pivotally secured to said strip metal, as and for the purpose specified.

2. A trousers-hanger of two strips of metal, the ends of each being bent oppositely forming three leaves, an enlargement at the points of bend forming a stop, a rivet approximate said enlargement adapted as another stop, a clamping-ring confined between said stops, the said strips similarly positioned, a 60 hanging-hook pivotally secured between them as and for the purpose specified.
