





## GRAVE-COPING.

SPECIFICATION forming part of Letters Patent No. 654,860, dated July 31, 1900.

Application filed May 2, 1900. Serial No. 15,269. (No model.)

To all whom it may concern:

Be it known that I, GEORGE P. TENNANT, a citizen of the United States, residing at Frostburg, in the county of Allegany and State of 5 Maryland, have invented a new and useful Grave-Coping, of which the following is a

specification.

This invention relates to grave-copings, and has for its object to provide an improved 16 frame structure for surrounding and protecting the mound of a grave, so as to hold the mounded earth in place and prevent it from becoming washed down by rains, thereby preserving the shape of the mound and effecto tually marking the site of the grave. It is furthermore designed to provide a device of this character which may be conveniently placed in position without requiring any degree of skill and to provide means for con-26 taining cut flowers.

With these and other objects in view the and arrangement of parts, is will be hereinafter more fully described, shown in the ac-25 companying drawings, and particularly pointed out in the appended claims, it being understood that changes in the form, proportion, size, and minor details may be made within the scope of the claims without de-30 parting from the spirit or sacrificing any of

the advantages of the invention.

In the drawings, Figure 1 is a perspective view of a grave-coping constructed in accordance with the present invention. Fig. 2 is a 35 central longitudinal sectional view thereof. Fig. 3 is a transverse sectional view taken on the line 3 3 of Fig. 2.

Corresponding parts in the figures of the drawings are designated by like characters of

40 reference.

Referring to the accompanying drawings, 1 and 2 designate the respective opposite sides, and 3 and 4 the head and foot pieces, which connect the sides and form the ends, of the sub-45 stantially-rectangular frame or coping, which is made of metal. The side and end pieces may be cast integral or otherwise connected and may be flat blank strips, as shown, or ornamented in any desired manner. This frame 50 is placed over the site of the grave and may be filled with sand, or the grave may be mound- !

ed and sodded, as usual, and inclosed by the coping, so as to hold the mound in shape and prevent its being washed away by rain or otherwise damaged, thus effectually preserv- 55 ing a mark for the site of the grave. Each side piece is provided with one or more inwardly-directed ears or flanges 5, which are flush with the lower edge of the frame and are designed to form anchors to hold the cop- 60 ing in place by the weight of the sand or earth inclosed by the latter. At the head of the frame there is provided a transverse brace or plate 6, which fits snugly in the angles between the side and end pieces and has its op- 65 posite ends provided with pendent ears or wings 7, which are welded, riveted, or otherwise secured to the inner sides of the side pieces. The upper face of this brace-plate is substantially flush with the upper edges of 70 the frame and is provided with any suitable inscription in raised characters, as illustrated present invention consists in the combination | in Fig. 1 of the drawings. The foot of the frame is also provided with a similar braceplate 8.

> The general shape of the coping may be that of a coffin, as shown in Fig. 1, and at the greatest width thereof, which is adjacent to the head of the frame, the latter is braced by means of a pair of inclined brace-rods 9, which have 80 their lower ends provided with upstanding attaching ears or lugs 10, which are removably connected to the inner faces of the respective side pieces of the frame by means of suitable detachable fastenings 11. The lower 85 ends of these braces are flush with the lower edges of the frame and incline inwardly and upwardly in opposite directions, so as to support a tapered cup or receptacle 12, which is located intermediate of the opposite sides of 90 the frame and substantially flush with the upper edge thereof and is also provided with an outer annular flange 13 to rest upon the mound. Besides connecting and bracing the opposite sides of the coping these inclined 95 braces are buried in the mound, so as to form anchors for the frame and also support the receptacle or cup for containing cut flowers.

What is claimed is—

1. A grave-coping, comprising an inclosing 100 frame, a transverse brace connecting opposite sides of the frame, and inclined inwardly

and upwardly from its opposite ends, which are connected to the lower portion of the frame, and a cup or receptacle carried by an

intermediate portion of the brace.

2. A grave-coping, comprising an inclosing frame, a cup or receptacle located intermediate of the sides of the frame, opposite braces connected to the cup, inclined downwardly and outwardly in opposite directions, and pro-10 vided at their outer ends with upstanding attaching-ears fitted against the inner faces of the respective sides of the frame, and detachable fastenings securing the ears of the frame.

3. A grave-coping comprising opposite side 15 and end pieces, opposite end plates connecting the upper edges of the side pieces, in-P.O. RAUSKE.

wardly-directed flanges at the lower edges of the side pieces, an intermediate cup or receptacle, opposite downwardly-inclined braces extending from the cup to the lower edges of 20 the respective side pieces, the lower ends of the braces having upstanding attaching-ears fitted against the inner faces of the respective side pieces, and removable fastenings connecting the ears to the side pieces.
