

INTERCHANGEABLE ADJUSTABLE BOOK-LOCK.

SPECIFICATION forming part of Letters Patent No. 662,700, dated November 27, 1900.

Application filed June 13, 1900. Serial No. 20,131. (No model.)

To all whom it may concern:

Be it known that I, Joseph W. Sheppard, a citizen of the United States, residing in the city, county, and State of New York, have invented a new and useful Improvement in Interchangeable Adjustable Book - Locks, of which the following is a specification.

My invention relates especially to the construction and arrangement of locks for books, and has for its object the provision of an interchangeable lock that shall be adjustable to books of different thicknesses, firmly locking their covers together, so that their contents will be as secure from undesirable scrutiny as though the book wherewith the lock is employed was placed within a safe.

To attain the desired end, my invention consists, essentially, in a lock-body having a fixed and a movable jaw, said jaws being provided with holding-surfaces, the bolt of the lock being arranged to adjustably engage a catch-piece upon the movable jaw, all of which will be hereinafter first fully described and then pointed out in the claims.

25 In the accompanying drawings, forming a part hereof, Figure 1 is a plan view of the front of a lock embodying my invention. Fig. 2 is a side view of the lock reversed in position from Fig. 1, the jaws being open. 30 Fig. 3 illustrates the lock as secured to the

cover of a book.

Similar numerals of reference indicate cor-

responding parts in all the figures.

1 is the front plate of the lock, having a por-35 tion cut out, leaving projecting arms 2 and a cross-bar 3 at the outer extremities of the arms. This cross-bar is serrated or corrugated or provided with a corrugated rubber face 4.

5 is a bar hinged to the body of the lock at 6 and having at its outer extremity a cross-bar 7, corresponding to the cross-bar 3, and a corrugated face 8, corresponding to the face 4.

9 is a serrated block securely fastened to

45 or formed with the bar 5.

10 is the bolt of the lock, the face whereof

is serrated the same as the block 9.

12 is the keyhole of the lock, the interior parts whereof may be arranged at pleasure, 50 as they form no part of my invention.

In applying my invention to use a book, such as 11, is placed between the jaws, said jaws being pressed together thereon by the fingers, and when the serrated bolt 10 is forced

outward by turning the key in the lock the 55 serrations thereon engage the serrations in the block 9, drawing the jaws more tightly together, thus firmly securing the lock to the book.

Memorandum-books, check-books, ledgers, 60 &c., are sometimes made with a permanent lock secured to the covers. Such lock is often in the way in handling and using such books. Also the book may only be needed at intervals when an extra important matter 65 is being recorded therein. In my invention the lock is made separable from the covers of the book and in no way permanently attached thereto. It does not, therefore, cause inconvenience to the user of the book at any 70 time, and while being adjustable to books of varied thicknesses need not be applied to the book excepting when occasion requires.

My invention gives great security to those who having books of memoranda it is desired 75 to keep private yet possess no safe to protect their books from the inspection of the curious, and it allows the book to be exposed on the desk or table yet safe from scrutiny.

Having now fully described my invention, 80 what I claim as new therein, and desire to se-

cure by Letters Patent, is—

1. An interchangeable, adjustable booklock in which are comprised a lock-body having a fixed jaw and a movable jaw, said jaws 85 being provided with holding-surfaces, the bolt of the lock being arranged to adjustably engage a catch-piece upon the movable jaw accommodating the lock to different thicknesses of books, and means for locking the 90 jaws in different positions.

2. In a lock of the character herein specified, a body having grasping and holding jaws, in combination with means for locking the jaws in different closed positions.

3. An interchangeable, adjustable booklock in which are comprised a lock-body provided with a serrated bolt, a fixed jaw having a grasping-surface; a movable jaw having a grasping-surface and a holding-block serrated correspondingly to the lock-bolt and means for locking said jaws in place.
