

GARMENT.

SPECIFICATION forming part of Letters Patent No. 700,674, dated May 20, 1902.

Application filed September 4, 1900. Serial No. 28,988. (No model.)

To all whom it may cencern:

Be it known that I, James H. Burt, a citizen of the United States of America, residing in Springfield, in the county of Hampden and State of Massachusetts, have made new and useful Improvements in Garments, of which the following is a specification, reference being had to the accompanying drawings and letters of reference marked thereon.

My invention relates to an improved com-

bination coat and shirt.

The object of my invention is to provide a construction of garment which while being simple, light, and inexpensive may be worn either as a coat alone or as a coat and shirt combined.

I accomplish the objects of my invention

by the construction herein shown.

In the accompanying drawings, in which like letters of reference indicate like parts, Figure 1 is a perspective view illustrating the garment as seen from the front when worn as a combined shirt and coat, a portion of the flap being elevated to more clearly disclose the construction. Fig. 2 is a like view of the device as seen from the back. Fig. 3 is a like view showing the operation of the garment as ordinarily worn as a combined coat and shirt; and Fig. 4 is a side view, with parts broken away, disclosing more clearly the detail of construction.

In detail, a indicates the front of the body portion of the garment, b the back portion, and c the supplementary front shirt portion. 35 The construction will be readily understood on reference to the drawings. The body portion of the garment at both front and back is formed like an ordinary light-weight coat, it being made, by preference, of a material which 40 is adapted for both a shirt and light-weight coat. The lower portion of the front is cut away, as shown in Figs. 1 and 3, forming in appearance a garment of the style known as a "cut-away coat." The front shirt portions 45 c are secured to the inner face of the front portion of the garment intermediate of the neck and waist, substantially as shown in dotted lines in Fig. 1, the opening of the gar-

ment or line of separation being continuous at the front from the neck to the bottom, so 50 that the line of buttoning extends not only through the body portion a, but also through the shirt portion c. The coat-front a is intended to be kept normally closed from the neck downward, as shown, and the edges of 55 the divided shirt portion c are also to be united by suitable fastening means when the garment is worn. The shirt portion c is for an abdominal covering only and need not extend above the breast-line or even as high as 60 this line in some cases.

When the garment is worn as a shirt and coat combined, the portions conly are tucked into the pants, the remaining portion hanging outside of the pants, as is usual with a 65 light-weight coat. When the garment is worn as a shirt alone, all garments below the waist-line are tucked into the pants, and when it is desired to present the appearance of a shirt-waist under a coat the garment may be 70 worn in either way with a coat arranged outside the combination-garment.

To conceal the suspenders, I provide the front portions c with suitable openings, through which the suspender-straps may pass 75 and be attached to the pants, these openings being covered by the lower front outer portion of the garment, so that the suspenders are entirely concealed when the garment is worn as shown in Fig. 3.1

Having therefore described my invention, what I claim, and desire to secure by Letters Patent, is—

A coat comprising a portion a, arranged to be normally closed over the breast from the 85 neck downward a depending back portion b, two complemental front flaps formed by cutting away the lower part of the front portion a, and an abdominal shirt portion c secured

at its upper edge to the inside of the front 90 portion a, and adapted to be worn inside of the trousers, substantially as described.
