

MUSTACHE-GUARD.

SPECIFICATION forming part of Letters Patent No. 702,790, dated June 17, 1902.

Application filed November 29, 1901. Serial No. 83, 956. (No model)

To all whom it may concern:

Be it known that I, EDMUND C. GLADWIN, a citizen of the United States, residing at Oakland, county of Alameda, State of California, 5 have invented a certain new and useful Musfollowing to be a full, clear, and exact description of the same.

The object of the present invention is to pro-10 vide a simple and effective protector whereinto contact with food during eating, it being more especially designed for wear with the eating of soup or drinking of beverages dur-15 ing the meal.

Figure 1 is a view disclosing the application of the guard. Fig. 2 is a rear view of the 25 guard. Fig. 3 is a front view of the guard, and Fig. 4 is a side view of the same in elevation.

In the drawings the letters A A' are used to indicate two comb-like members, which 30 members are united at their inner ends by a central hinge A2. Each member A A' is slightly curved, preferably, so as to partially partake of the shape of the lip over which it. is to fit. However, should the members be 35 constructed of pliable material the same will readily shape itself. The teeth of each comb member gradually increases in height from the inner tooth 1 to outer tooth 2.

To the front of each comb member there is 40 attached by hinge B a guard or cover plate. B'. These guard or cover plates are preferably shaped to conform to the shape of the comb members to which they are hinged. It is not required that the guard or cover plates 45 be constructed of the same material as the comb member, for the same may be made much lighter and more finished than the said members.

To the outer side edges of each guard or 50 cover plate is hinged a temple B2, the free end I

of the temples being curved, so as to fit over the ears of the wearer in order to hold the guard or mustache-protector in place. The lower edge a of each guard or cover plate is inwardly flanged and serrated.

As the cover or guard plates are closed upon the comb members, the serrated edges thereof engage with the mustache. By hinging the members the same may be closed or folded over to fit within a small case.

The essential features of the present invention reside in the employment of the comblike members for holding the mustache out of the way, combined with guard or cover plates attached thereto and provided with 80 means for holding the protector to the wearer thereof.

Having thus described the invention, what is claimed as new, and desired to be protected by Letters Patent, is—

A device of the character described comprising two comb members flexibly connected together at their inner adjacent ends, and guard-plates, of approximately the same size as the comb members, flexibly connected to 90 the bottoms of said comb members and adapted to fold upwardly thereupon; substantially as described.
