

COMBINED ADVERTISING MATCH-BOX AND CIGAR-TIP CUTTER.

SPECIFICATION forming part of Letters Patent No. 706,987, dated August 12, 1902.

Application filed December 2, 1901. Serial No. 84,346. (No model.)

To all whom it may concern:

Be it known that I, WILLIAM R. MOORE, a citizen of the United States, residing at | Eden, in the county of Erie and State of New 5 York, have invented certain new and useful Improvements in a Combined Advertising Match-Box and Cigar-Tip Cutter; and I do declare the following to be a full, clear, and exact description of the invention, such as will 10 enable others skilled in the art to which it appertains to make and use the same, reference being had to the accompanying drawings, and to the letters of reference marked thereon, which form a part of this specification.

My invention relates to improvements in a combination advertising match-box and cigartip cutter; and the object of the invention is to provide a match-box having a threefold purpose-namely, first, a receptacle for hold-20 ing matches; secondly, a provision for cutting off the tips of cigars, and, thirdly, an | advertising medium for whatever may be desired to display upon the sides thereof.

With these ends in view the invention con-25 sists in the construction and arrangement of. parts, as will be more in detail described, and particularly pointed out in the claim.

In the accompanying drawings, to which reference is had and which fully illustrate 30 my invention, Figure 1 represents a side elevation of my match-box closed, and Fig. 2 a similar view with the lid raised or open. Fig. 3 is a side view showing the holding-strips.

Similar letters of reference indicate corre-35 sponding parts in the several figures.

Referring by letter to the drawings, A designates a rectangular match-box having the usual top flange a and provided with a spring-

catch B and a push-pin C, secured to the 40 lower portion of the catch B and passed through an aperture c at the front portion

and top of the box.

D designates a short arm of curvilinear form secured to or formed integral with the 45 box upon one side and near the rear portion of the same, having an aperture d in its free end for a purpose which will be hereinafter explained.

E designates a lid or cover hinged to the 50 top and rear portion of the box by means of a hinge-pin e in the usual manner, this hingepin having secured thereto or provided with

a coiled spring F, through the medium of which the cover or lid is opened and closed as desired.

G designates a slot corresponding in form to the short arm D and which is formed in and upon the same side of the cover as the short arm D upon the box and within which the short arm engages, the arm serving as a 60 guide for the slot.

H designates a double cutting-blade secured to the inner side of the cover and arranged at right angles to or across the slot G. so that the opening or closing of the lid of 65 the box clips off the tip of the cigar when it is passed through the aperture of the curvilinear short arm, as shown clearly in Fig. 1 of the drawings.

Secured to the side of the box or formed in- 70 tegral therewith are vertical strips I I, the lower ends of which are closed and the upper ends are open for the insertion of advertising-cards. The opposite side or face may be duplicated, if necessary.

From the foregoing description, taken in connection with the accompanying drawings, the operation of my device will be obvious, and further description herein is deemed unnecessary.

Having thus described my invention, what I claim as new, and desire to secure by Letters Patent, is—

In a match-box of the character described, the same being provided with the curvilinear 85 short arm integral with the wall thereof having an aperture in its free end, the cover having a corresponding slot therein adapted to be closed by said arm, a double-edged cutting-blade secured to the inner side of the go cover and located across said slot, whereby the tip of a cigar may be clipped off when passed through the aperture in the arm by said blade, in opening or in closing the cover, and vertically-arranged strips secured to the 95 side of the box, substantially as and for the purpose set forth.
