

FRANK AUGUSTUS DANIELS, OF HAVERHILL, MASSACHUSETTS.

CHALK-HOLDER.

SPECIFICATION forming part of Letters Patent No. 730,237, dated June 9, 1903.

Application filed August 6, 1902. Serial No. 118,673. (No model.)

To all whom it may concern:

Be it known that I, Frank Augustus Daniels, a citizen of the United States, residing at Haverhill, in the county of Essex and State of Massachusetts, have invented certain new and useful Improvements in Chalk-Holders; and I do declare the following to be a full, clear, and exact description of the invention, such as will enable others skilled in the art to which it appertains to make and use the same.

My invention is an improved chalk-holder adapted for use by billiard-players for holding the chalk employed for use on the cues; and it consists in the peculiar construction and arrangement of devices hereinafter described and claimed.

The accompanying drawing is an elevation, partly in section, of my improved chalk-

My improved chalk-holder comprises a single plate of spring metal 14, bent in inverted-V shape to form a pair of downwardly-diverging spring-arms 13, having their lower ends bent inwardly at substantially right angles to form toothed clamping-jaws 15, between which the chalk is inserted and held in place. The said plate is provided at its apex with an opening for the supporting-cord, as shown, and is provided with a set-screw 16, which connects the spring-arms together near their upper ends, and is adapted when ap-

propriately turned to draw the said arms together to securely clamp the chalk between the jaws thereof or to release the said jaws 35 from the chalk.

From the foregoing description, in connection with the accompanying drawing, it is thought the construction, mode of operation, and advantages of my improved chalk-holder 40 will be readily understood without requiring a more extended explanation.

Having thus described my invention, what I claim as new, and desire to secure by Letters Patent, is—

A chalk-holder comprising a single plate of spring metal bent in inverted-V shape to form a pair of downwardly-diverging spring-arms having their lower ends inturned to engage opposite sides of a piece of chalk, said 50 plate being provided at its apex with an opening for the supporting - cord and being provided with a set - screw connecting the spring-arms together near their upper ends for the purpose set forth, substantially as de-55 scribed.
