

BOOK-COVER.

3PECIFICATION forming part of Letters Patent No. 737,969, dated September 1, 1903.

Application filed June 12, 1903. Serial No. 161,176. (No model.)

To all whom it may concern:

Be it known that I, BARBARA E. SCHRENK, a citizen of the United States, residing in the city and county of Philadelphia, State of 5 Pennsylvania, have invented new and useful Improvements in Book-Covers, of which the following is a specification.

My invention consists of a book-cover which I denominate a "slip-cover," the same being o adapted to be readily applied to and removed from the covers of a book, the construction of the same being hereinafter set forth.

It also consists in providing a cover of the character stated, with means for holding a 15 marker, pencil-carrier, &c., therein.

Figure 1 represents a perspective view of a book-cover embodying my invention. Fig. 2 represents a perspective view showing the cover in position on a book. Fig. 3 repre-20 sents a rear view of the cover in position. Fig. 4 represents a section on line x x, Fig. 1.

Similar letters of reference indicate corre-

sponding parts in the figures.

Referring to the drawings, A designates a 25 book-cover composed of the pockets B and C, adapted to receive the covers of a book, and the back D, which connects said pockets and is adapted to rest against the back of the book. In practice said parts B, C, and D 30 are formed of a continuous piece of fabric or material, properly shaped, producing the exterior walls E E and interior walls F F of said pockets B C on opposite sides of said back D, said walls being united along the 35 lines of stitches G G so as to close the tops, bottoms, and outer sides of said pockets, leaving the inner sides H open, so that when the covers of the books are pressed rearwardly or otherwise properly manipulated they may 40 be presented to the open sides H of the pock-

ets, and so pushed or slipped into the latter, whereby both the outside and inside of said covers may be fully enveloped by said pockets, thus preserving the book and serving to 45 keep both faces of each of its covers and the

exteriors of its back clean, with other advantages resulting from the use of the article. When removal of the cover is desired, the

pockets may be readily slipped from the book, leaving the cover intact for further and re- 50

peated use.

The back D has a piece of material attached thereto extending in the longitudinal direction of said back and partly separated therefrom, thus channeling said back. A 55 line K of stitches is then passed through the two thicknesses of material producing separate channels or compartments J, into each of which is placed a book-marker, pencil-carrier, &c., as at L, it being noticed that in the 60 present case the markers or carriers are composed of a doubled piece of ribbon or other material, each length of which occupies one of said pockets, the bend M of said piece being adapted to be drawn against and engage 65 the adjacent end of the stitch-line K as a stop, whereby the markers, &c., cannot be withdrawn or improperly displaced while the portion of the markers, &c., outside of the channels are introduced between and occupy 70 the leaves of the book, said markers, &c., being readily removable when so required by properly pulling them through and from the channels.

Having thus described my invention, what 75 I claim as new, and desire to secure by Let-

ters Patent, is—

1. A slip book-cover formed of pockets to receive the cover of a book and a back connecting said pockets, said back having a 8c channel therein adapted to receive a bookmarker, &c.

2. A slip book-cover of the character stated formed of pockets to receive the cover of a book, and a back connecting said pockets, 85 said back having a channel therein adapted

to receive a book-marker, &c.

3. A slip book-cover consisting of pockets and a back uniting the same, said pockets being composed of exterior and interior walls '90 which are closed at top, bottom and outer sides and open at their inner sides, said parts being formed of a continuous piece of material and a supplemental piece connected with said back forming a channel adapted to 95 receive a book-marker, &c.

4. A slip book-cover formed of pockets to receive the cover of a book, a back connecting said pockets, a piece connected with said back forming a channel therewith and a line of stitches intermediate of the sides thereof forming a plurality of channels in said back adapted to receive different lengths of a

book-marker, &c., the end of said stitches acting as a stop for the bend of said lengths.
