

PIN.

SPECIFICATION forming part of Letters Patent No. 778,353, dated December 27, 1904.

Application filed April 12, 1904. Serial No. 202,751.

To all whom it may concern:

Be it known that I, SIMON DANCYGER, a citizen of the United States, residing at Dayton, in the county of Montgomery and State of Ohio, have invented a certain new and useful Improvement in Pins; and I do hereby declare that the following is a full, clear, and exact description thereof, which will enable others skilled in the art to which it appertains to make and use the same, reference being had to the accompanying drawings, and to the numerals of reference marked thereon, which form a part of this specification.

My invention relates to improvements in pins described in Letters Patent issued to me July 3, 1894, Serial No. 522,290, which will be fully hereinafter described and claimed. The original has two circular loops forming the head, with the terminals bent over the central portion between said loops, the object of the present invention being the formation of a head of three symmetrical parts, the added part being used to attach a metallic charm, ticket, bouquet, or other article. The construction is illustrated in the accompanying drawings, in which—

Figure 1 is an elevation of the improved pin. Fig. 2 is a side view of the same.

Like numerals designate like parts in the 3° two views.

The pin is formed of a single piece of wire. The circular loops 1 and 2 are formed, and the shaft portion 4 is bent over the central

portion in position at a right angle to the portion joining said loops. The end is formed 35 into the loop 3, which is bent to the rear of the said joining portion and upward, forming an arc of size like the former loops and the end abutting the central curve, or nearly so. The several loops are formed of like 40 size, thus forming a symmetrical head.

The improvement consists alone in the added loop in line with the shaft and is used for the support of bouquets, charms, or other articles. In attaching a charm it is necessary 45 to bend the end to one side, that the same may enter the orifice of said charm.

What I claim is—

As a new article of manufacture, the pin bent from a single piece of wire to form a 50 shaft pointed at its lower end, two loops having their centers in line at a right angle to said shaft, and a central portion joining said loops, said shaft having its upper end bent over said central portion and joining one of 55 said loops, and the other of said loops being extended upward to form a terminal loop having its center in line with said shaft, substantially as described.
