

SPECIFICATION forming part of Letters Patent No. 794,087, dated July 4, 1905.

Application filed February 20, 1905. Serial No. 246,412.

To all whom it may concern:

Be it known that I, Herman Englander, a citizen of the United States, residing in the city and county of Philadelphia, State of Pennsylvania, have invented a new and useful Attachment for Suspenders, of which the following is a specification.

My invention consists of a suspender-end having a tab for supporting an undergarment, said tab being integral with said end and constituting portion of the end removed from the same by the formation of the required button-hole therein, thus producing a strong article and saving material in the manufacture of the same and avoiding exposing said undergarment.

The figure represents a rear view of a suspender-end embodying my invention.

Similar letters of reference indicate corre-

20 sponding parts in the figure.

In the drawing, A designates a suspenderend, which, excepting the feature of my invention applied thereto, is of usual form.

Bdesignates tabs, which are formed by making proper incisions in the sides and bottom of the buttoning members C of said end, whereby portions of said members are separated from the adjacent portions excepting at what may be termed the "tops" thereof as at D, where they remain connected, whereby the buttonholes, and consequently said tabs, are produced, while the tabs remain integral with the members C. To the lower ends of said tabs are secured the clips or fastenings E for the supports of the undergarment, such as drawers, it being evident that the suspenders may be buttoned to trousers, as usual.

In order to prevent downward displacement or slipping of the fastenings E, the lower ends of the tabs are enlarged, forming the shoulders F, against which the stationary or affixing portions of the fastenings abut. It will

also be seen that the clips or fastenings E form downward continuities of the tongues B, whereby said fastenings may pass behind the belt of 45 the trousers and extend below the same, thus avoiding the elevation of the top or band of the drawers or undergarment which is held by said fastenings, and consequently concealing said band or preventing exposure thereof. 50 In the present case for the purpose of clearness one of the tabs is shown without a fastening, although both may be so provided, if desired.

Various changes may be made in the details of construction shown without departing from 55 the general spirit of my invention, and I do not, therefore, desire to be limited in each case to the same.

Having thus described my invention, what I claim as new, and desire to secure by Letters 60 Patent, is—

- 1. A suspender-end having a buttonhole therein and an attaching-tab integral with said end and comprising the portion of said end partly separated therefrom to form said but- 65 tonhole.
- 2. A suspender-end having an integral attaching tab and a buttonhole in said end formed by the partial separation of the said tab from the end, said tab having on its lower 7° portion a shoulder which is also separated from said end.
- 3. A suspender-end having a portion of the same partly separated forming a buttonhole and an attaching-tab, the latter being confined 75 within the boundaries of said end composed of the partly-separated portion which produces said buttonhole, and an attaching device on said tab.
