

GARMENT.

To all whom it may concern:

Be it known that I, LAURA REED, a citizen of the United States, residing at Fremont, in the county of Dodge and State of Nebraska, 5 have invented certain new and useful Improvements in Garments, of which the following is a specification.

My invention relates to garments, and especially to that class of garments particu-

10 larly adapted for women's wear.

The object of my invention is to provide a garment adapted for supporting various other garments and various parts of the person.

With this and other objects in view the present invention consists in the combination and arrangement of parts, as will be hereinafter more fully described, shown in the accompanying drawings, and particularly 20 pointed out in the appended claims, it being understood that changes in the form, proportion, size, and minor details may be made within the scope of the claims without departing from the spirit or sacrificing any of 25 the advantages of the invention.

In the drawings, Figure 1 is a front perspective view of my improved garment. Fig. 2 shows my improved garment in perspective

as seen from the rear.

supporters 7.

Like characters of reference designate corresponding parts throughout both the views. In its preferred embodiment my improved garment consists of a pair of armpit-shields 1, suspended by straps 2, passing over the 35 shoulder of the wearer and secured by straps 3, passing about the arm. The armpitshields 1 are secured to the body by means of a separable strap 4, passing about the front, and straps 5, preferably composed of elastic, 40 passing across the back toward the middle and connected to a back-support 6 and adapted to serve as shoulder-braces. The backsupport 6 is composed of several thicknesses of fabric and between which are disposed 45 "bones" or stiffening devices. To the front edges of that section of the armpit-shield 1 which rests against the body are secured bust-supporters 7, preferably composed of a fabric and detachably joined at their inner ends. To make the garment more firm, brace-straps 8 are secured to the shoulder-

straps 2 and to the upper edges of the bust-

An abdominal supporter 9 is provided with buckles 10, adapted to be removably secured 55 to a belt 11. The belt 11 is secured to the lower end and forms a continuation of backsupporter 6 and is so formed as to set down over the hips and serve as a skirt-supporter. To the lower edges of abdominal supporter 60

9 are secured hose-supporters 12.

From the foregoing description the operation of my garment will be clearly and easily understood without a more extended description in relation thereto, and it will be readily 65 understood that this garment will serve the purpose accomplished by a corset, especially in supporting the skirts and busts. The abdominal supporter, with its attached hosesupporters, is adapted to give the desired 70 "erect form."

It is obvious that numerous changes may be made in the form and construction of my improved garment without departing from the spirit of the invention or the scope of 75

the claims.

Having thus described my invention, what I claim as novel, and desire to secure by Let-

ters Patent, is—

1. A garment comprising a stiffened back- 80 supporting member, shoulder-braces secured to the upper portion thereof, armpit-shields secured at the front and back portions thereof to the said shoulder-braces, elastic bands connecting the lower back portion of the arm- 85 pit-shields to the stiffened back portion, bustsupporters secured at either side thereof to the said armpit-shields, a belt member secured to the lower end portion of the backsupporting member, an abdominal supporter 90 secured to the said belt member and hosesupporters secured to the said abdominal supporter.

2. A garment comprising a stiffened backsupporting member, means for supporting 95 said member about the body, armpit-shields connected to the upper portion thereof, shoulder-straps connected therewith and adapted to secure the same in position, and bust-supporters secured to the front edges of 100

the armpit-shields.

3. A garment comprising a stiffened backsupporting member, shoulder-straps connected therewith at the upper portion thereof, armpit-shields secured at their front and 105 rear portions to the said shoulder-straps,

bust-supporters secured to the said shoulderstraps and to the front edges of the armpitshields, straps connecting the back-supporting member with the rear portion of the armpit-shields, a belt secured to the lower portion of the back-supporting member and an abdominal supporter secured to the said belt.
