



ARTICLE OF NECKWEAR.

To all whom it may concern:

Be it known that I, WILLIAM H. HART, Jr., a citizen of the United States, residing in the city and county of Philadelphia, State of 5 Pennsylvania, have invented a new and useful Article of Neckwear, of which the follow-

ing is a specification.

My invention consists of an article of neckwear composed of a neckband formed of members integral with and foldable on each other, tie portions continuous of the ends of one of said members, and attaching-tabs continuous of the ends of the other member and independent of the tie portions, said tabs be-15 ing separate from the inner ends of said portions of the member of which the latter is continuous.

It also consists of an article of neckwear comprising bands foldable on each other, one 20 of said bands being provided with means for attachment to the band of a garment, and tie portions continuous of one of said bands and extending in opposite directions therefrom and of a length to be tied to form a bow, said 25 tie portions being formed of the material doubled and independent of the portion having said attaching means and disconnected from the inner band at points opposite said moans

of attachment in the latter.

Figure 1 represents a perspective view of an article of neckwear embodying my invention. Fig. 2 represents a section on line x x, Fig. 1. Fig. 3 represents a section on line y y, Fig. 1. Fig. 4 represents a face view of the 35 same, taken from the interior thereof. Fig. 5 represents a similar view showing the neckband in a different position from that shown in Fig. 4. Fig. 6 represents a face view of a modified construction of that shown in Fig. 40 4. Fig. 7 represents a section of a modified

construction of that shown in Fig. 2. Similar letters of reference indicate corre-

sponding parts in the figures.

Referring to the drawings, A designates 45 my new article of neckwear, the same being composed of the bands B C, which are adapted to be folded on each other on the line Dafter the manner of a collar, and the tie portions E E, which are continuous of the band 5° C and extend, respectively, in opposite directions therefrom.

On the ends of what may be termed the "inner" band B are the tabs F which are

separate from the band C and in which are buttonholes G, and at the center of said 55 band B is the buttonhole H, by which provision the neck portion may be secured to the band of a shirt, shirt-waist body, or other garment, the tie portions E E then depending from the front ends of the band C, as 60 plainly shown in Fig. 1, it being evident that when the neck portion is adjusted and secured in position the tie portion may be. made up into various forms of bows or knots, the device when worn being prevented from 65 slipping in any direction. It will also be seen that the bands B C, the portions E E, and the tabs F are composed of a single piece of material, as most plainly shown in all of the figures excepting Fig. 7, where the 7c opposite faces or sides of the device are formed of separate pieces of material.

In Fig. 6 the band C is cut away at intervals to form sections C' C' C', in each of which is a buttonhole, without, however, 75 producing different results from those here-

inbefore stated.

Having thus described my invention, what I claim as new, and desire to secure by Letters Patent, is-

1. An article of neckwear composed of a neckband formed of members integral with and foldable on each other, tie portion continuous of the ends of one of said members and attaching tabs continuous of the ends of 85 the other member and independent of the tie portions, said tabs being separate from the inner ends of said portions and the member of which the latter are continuous.

2. An improved article of neckwear com-, 90 prising bands foldable on each other, one of said bands being provided with means for attachment to the band of a garment, and tie portions continuous of one of said bands and extending in opposite directions therefrom 95 and of a length to be tied to form a bow, said tie portions being formed of the material doubled and independent of the portion having said attaching means and disconnected from the inner band at points opposite said 100 means of attachment in the latter.
