


ADJUSTABLE OUTLET-BOX.

To all whom it may concern:

Be it known that I, Max D. Baron, a citizen of the United States, and a resident of the borough of Manhattan, in the county and 5 State of New York, have invented certain new and useful Improvements in Adjustable Outlet-Boxes, of which the following is a specification.

In modern practice 20 these boxes are installed during the construction of the building and necessarily before the finish or decorations can be accu-

rately determined.

In many types of boxes the outlet open-25 ing or receptacle socket of the box is fixed relatively to the body portion or at best is capable of but slight adjustment relatively thereto. Thus, as a result, when the installation is complete and the walls of the build-30 ing are subsequently finished the exposed outlet opening or receptacle socket is frequently offset a considerable amount from its proper position relatively to the finish of the walls and consequently the electric in-35 strument when attached is offset an unsightly distance. A readjustment with this type of box would involve great inconvenience and expense. The slight degree of adjustability sometimes provided in boxes 40 is quite inadequate in most instances as the offset of a box is frequently as much as an inch in both vertical and horizontal directions. The box also may be several degrees askew.

The advantage of a box with an adjustable outlet opening or socket has long been recognized and many more or less unsuccessful attempts have been made to provide such a box. Their chief defects have been a pro-50 lixity of complex and inexpensive parts which at best furnished inadequate adjust-

ment.

An object of the present invention is to provide an inexpensive box which shall have 55 an outlet opening or receptacle socket pos-

sessing a wide range of lateral and rotary adjustability and which shall possess a closed interior for all adjustments of the receptacle opening.

A preferred embodiment of this invention 60

is illustrated in the drawings forming part of this specification and in which like numerals designate corresponding parts and in

which:—

Referring now more particularly to the drawings,-1 designates the body portion of the box of any approved construction, provided with knock-out portions 2 to provide for the entrance of conduits. The outer face 3 of the box presents a somewhat restricted circular opening 4 giving access to the interior of the box. The corners of the box are tapped to form screw receiving holes 5.

The adjustable cover portion 6 of the box comprises a cross shaped plate 7 with projecting parts 8 and a receptacle or fixture

socket 9 providing an opening 10.

11 illustrates a fixture support attached to the socket 9.

The opening 10 is smaller than the opening 85 4 and may be adjusted in any position within its confines and be fixed in position to give access therethrough to the interior of the body portion 1. To accomplish this, the cover portion 6 is located upon the body portion 1 with the plate 7 in contact therewith so that the portions 8 project laterally between the corners of the body portion. A clamping member 12, illustrated as a ring, although it may be of any suitable form, clamps the cover portion 6 to the body portion by means of serews 13 entering the holes 5. This clamping member 12 serves also to retain the cover portion 6 attached to the body portion 1 even though the same is not acc tightly clamped thereto, thus retaining the various parts in assembled relation.

As may be seen in the drawings the screws 13 permit a considerable play of the projecting portions 8 of the plate 7. This play provides for a lateral adjustment of the socket 9 in all directions within the confines of the opening 4 as well as for a limited rotary ad-

justment.

stment. The contour of the plate 7 should be deter-

mined by the relative size of the openings 4 and 10 and should be such as to employ a minimum amount of material and always cover the opening 4 no matter what the ad-5 justment of the cover and its socket 9 may be. That is the cover 6 must always be in closing position for all adjustments. A preferred contour of the plate 7 is illustrated in Fig. 3.

The box may be made by any approved process, such as casting or stamping, and may be of any suitable material, such ar iron.

Although the embodiment of the invention, as illustrated and described, is preferred, the 15 invention is capable of much modification in detail. It is not essential that the openings 4 and 10 be circular or that the body portion 1 be square as illustrated, as any convenient shape may be employed. Furthermore, it is 20 not essential that the face 3 of its body portion 1 be integral therewith.

Many other modifications are within the scope of my invention as, for example, the proportioning of the openings 4 and 10, and 25 the various parts of the box might be such as to allow the opening 10 to overlap the sides of

the opening 4.

What I claim and desire to secure by Let-

ters Patent, is:-

30 1. A wall box, comprising a body portion, an adjustable cross shaped cover portion, and a clamping member secured to the corners of said body portion to clamp said cover portion in position.

35 2. An outlet box, comprising a body portion having a restricted front opening, an adjustable cross shaped cover portion having a centrally located open throat piece, and a clamping member secured to said body por-.40 tion to clamp said cover portion in position.

3. An outlet box, comprising a body portion, an adjustable cross shaped cover portion, and a clamping member secured to the corners of said body portion to clamp said 45 cover portion in position, said cover portion having a wide range of lateral and rotary ad-

justability.

4. An outlet box, comprising a body portion having a restricted front opening, and adjustable cross shaped cover portion having 50 a centrally located open throat piece, and a clamping member secured to the corners of said body portion to clamp said cover portion in position, said cover portion having a wide ranguof lateral and rotary adjustability. 55

5. An outlet box, comprising a body portion, an adjustable cross shaped cover portion, and a clamping ring secured to the corners of said body portion to clamp said cover

portion in position.

6. An outlet box, comprising a body portion having a restricted front opening, an adjustable cross shaped cover portion having a centrally located open throat piece, and a clamping ring secured to the corners of said 65 body portion to clamp said cover portion in position.

7. An outlet box, comprising a body portion, an adjustable cross shaped cover portion, and a clamping ring secured to the cor- 70 ners of said body portion to clamp said cover portion in position, said cover portion having a wide range of lateral and rotary adjust-

ability while in closing position.

8. An outlet box, comprising a body por- 75 tion having a restricted front opening, and adjustable cross shaped cover portion having a centrally located open throat piece, and a clamping ring secured to the corners of said body portion to clamp said cover portion in 80 position, said cover portion having a wide range of lateral and rotary adjustability while in closing position.
