

SKIRT-SUPPORTER.

To all whom it may concern:

Be it known that I, Gertrude Gromer, a citizen of the United States, residing at New York, in the county of New York and State 5 of New York, have invented new and useful Improvements in Skirt-Supporters, of which

the following is a specification.

This invention is an improved device to be worn about the waist and employed to lift a 10 skirt from the ground and which when not in use is not likely to become lost as hereinafter described in the following specification set forth in the claims and illustrated in the drawings, where like reference numerals are 15 used to designate the same parts in the several figures.

Figure 1 is a view illustrating the use and operation of the device. Fig. 2 is a side elevation of the device. Fig. 3 is a modified

20 form of the same.

Serious inconvenience is experienced by the users of these devices in consequence of the liability of loss and for the purpose of overcoming this difficulty the skirt holder 25 which is shown in the drawings is provided with a belt or band 5 having a ring 6 at one end while its other end is secured to the head 7 of the holder. This band is designed to be worn around the waist of the user and the 30 ring 6 is caught over a hook 8 attached to the head.

Depending from the head 7 is a shank 9 carrying at its lower end two spring members 10 having on their lower ends knobs 11 which 35 are designed to grasp the dress without tearing or otherwise injuring the dress. The upper ends of the members 10 are toothed or serrated as at 12 and embracing these upper ends is a ring 13 which is engaged by the 40 teeth as the knobs 11 are pressed inward and it is designed to adjust them to the thickness of the material grasped.

The head 7 and the shank 9 may be ornamented or decorated so as to present a neat 45 and tasty appearance and be a means of ornament to the dress of the wearer. It may be made of metal and decorated and chased to consist of an ornament of value.

In the modifications shown in Fig. 3 the 50 spring members are made of one continuous piece and the upper end or point of union

may consist of a coil 14 to be secured to the shank 9 while the lower ends cross each other as at 15 and carrying on their lower ends their knobs for the protection of the skirt of 55 the wearer.

The device may be made of spring steel in order to secure a resilient action by the knobs while the upper portion may be made of softer metal or other material and to the 60 modified form is also secured a cord or band by which the device may be hung from the waist of the user.

It is obvious that various other modifications may be resorted to in the construction '65' of the device without departing from the essential features above described.

What I claim as new and desire to secure

by Letters Patent is:

1. A skirt holder comprising a head with 70 one end of a supporting cord or the like secured thereto, means on the head for attaching the other end of the cord, a shank depending from said head, and spring arms having their upper ends connected together 75 and attached to said shank, the lower ends of said spring arms being normally pressed together to enable a skirt to be grasped between them, for the purpose set forth.

A skirt holder comprising a head with 80 one end of a supporting cord or the like secured thereto, means on the head for attaching the other end of the cord, a shank depending from said head, spring arms having their upper ends connected together and 85 attached to said shank, the lower ends of said spring arms being normally pressed together to enable a skirt to be grasped between them, the upper portions of said spring arms being provided with teeth on their 90 outer sides, and a band connecting the upper portions of said arms and coacting with said teeth to press the lower ends of said arms against the skirt to secure the same between them.
