

COMBINED SHIPPING-TAG AND STAMP-PROTECTOR.

To all whom it may concern:

Bernheim, residing in Louisville, in the county of Jefferson and State of Kentucky, bave invented a new and Improved Combined Shipping-Tag and Stamp-Protector, of which the following is a specification.

This invention has for its purpose to provide an improved tag especially designed for use on the stamp head of whisky barrels to protect the stamp from mutilation and at the same time expose the serial numbers thereof to view, as is required, and which will also serve as the shipping tag for the barrel or other object to which it may be applied.

My invention comprises a tag of card board, or other suitable material, formed and arranged in the manner hereinafter described, pointed out in the appended claims and illustrated in the accompanying drawing, in which:—

Figure 1, is a view that illustrates the manner in which my tag is generally applied for use. Fig. 2, is a detail view of the tag.

In the use of revenue stamps, it is required that the same be not mutilated and further that the number or numbers are always in sight.

To protect the stamp from mutilation, I have provided a tag, A, of suitable shape, preferably elongated as shown, which, in use, is nailed or otherwise fastened over the stamp B to extend entirely over the length and width of the same.

At one end the tag is formed with an opening a, relatively so disposed in the tag as to

come over that part of the stamp having the serial number or numbers, whereby to positively expose the said numbers to view at all times, as illustrated in Fig. 1.

At the lower end, the tag or card is divided off as at a^2 and lined up to receive the name and address of the shipper.

The space between the part a^2 and the open ing in the tag is lined off as at a^3 to receive 45 the name and address of the consignee or customer to whom the barrel or other package of goods has been sold.

By reason of providing a shipping tag of the character described, an economical sim- 50 ple and effective means is provided for protecting the revenue stamps of whisky barrels, and yet expose them as required by law with practically no expense, since the tag is necessary for shipping and it carries the 55 name of the customer and the shipper.

The advantages of its use will be readily apparent to those skilled in the art to which my invention relates.

Having thus described my invention, what 60 I claim is:

The combination with an article of merchandise and a revenue stamp thereon, of a tag covering such revenue stamp, said revenue stamp having a serial number, said tag 65 having an elongated aperture exposing said serial number, and means for securing said tag to the article of merchandise.
