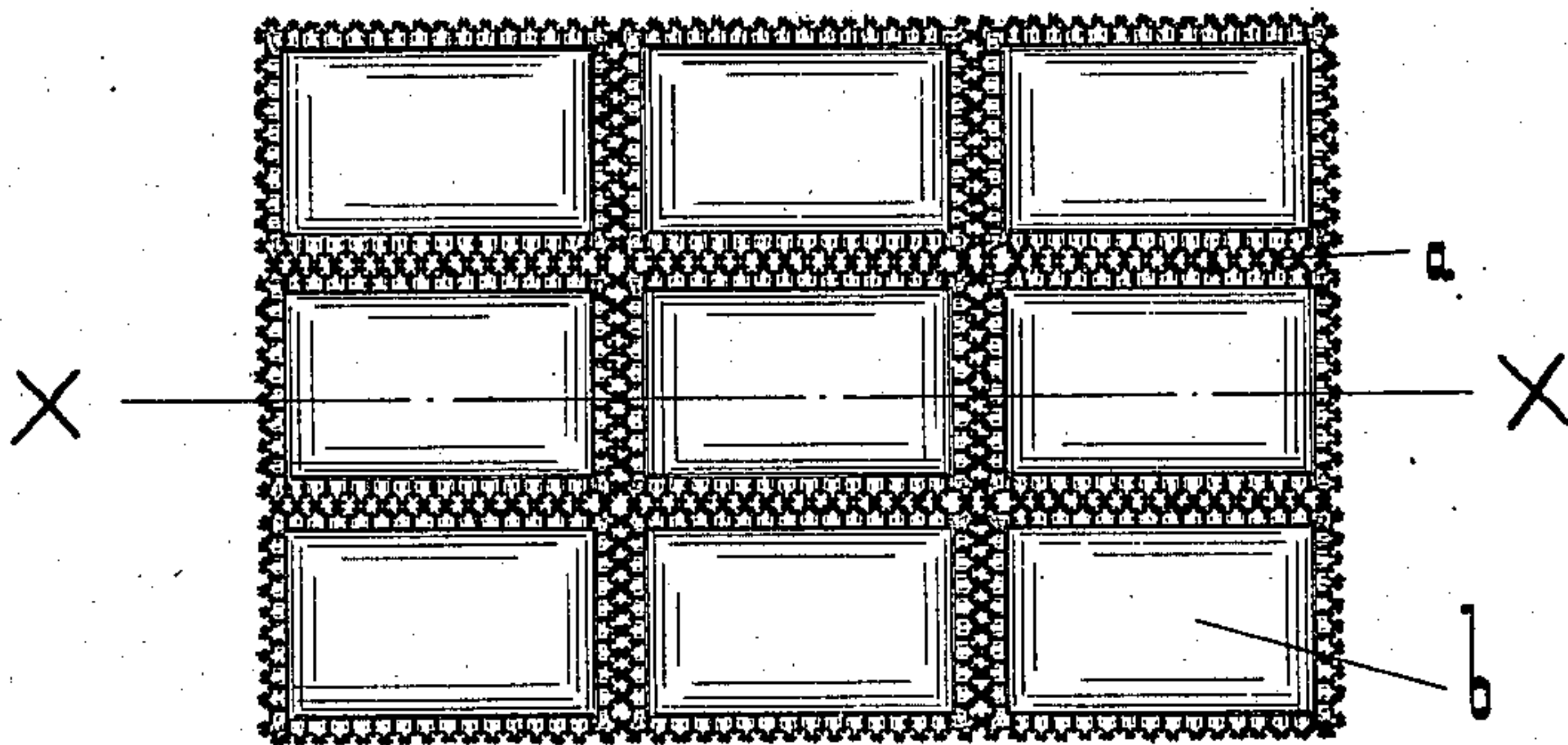
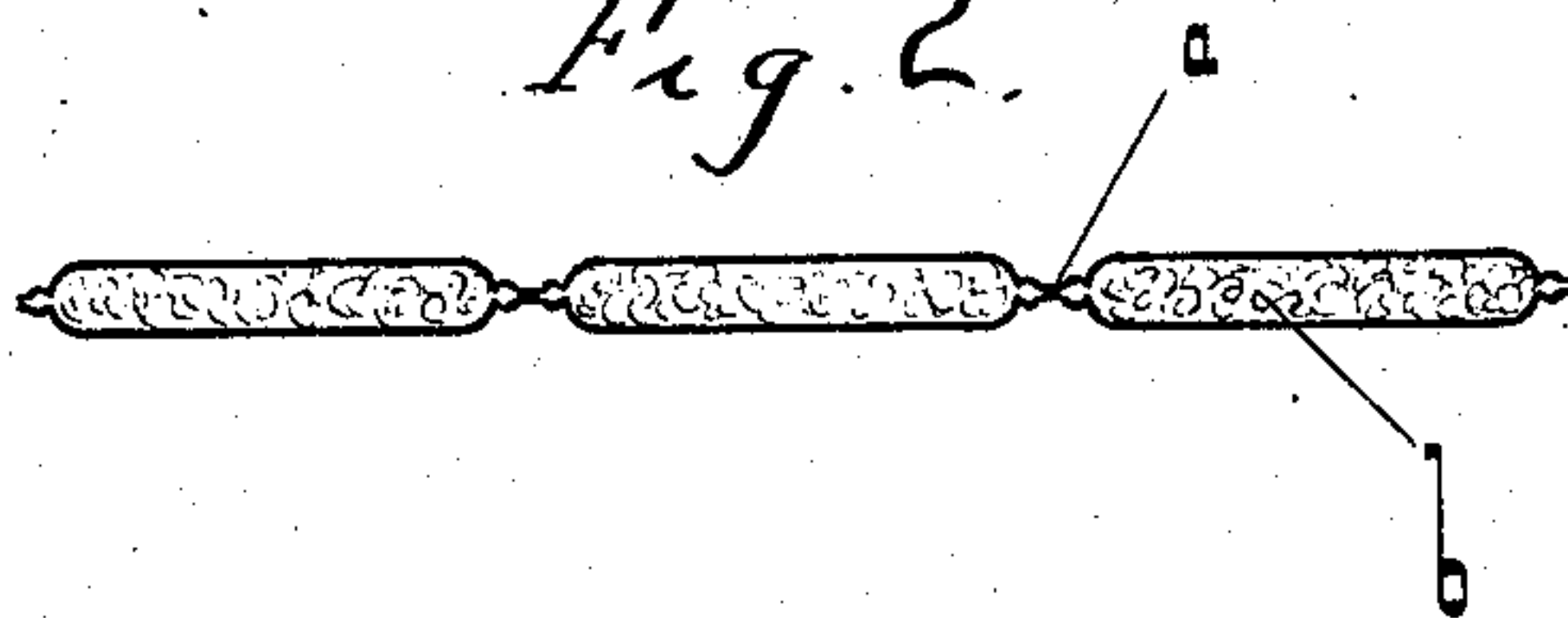

PAD.

To all whom it may concern:

Be it known that I, OTTO NEUBERGER, a subject of the Emperor of Germany, and resident of Frankfort-on-the-Main, Germany, have invented a certain new and useful Improvement in Pads, of which the following is a specification.

This invention relates to pads and the improvement consists in a pad comprising two breadths of fabric carrying between them a filling and said pad is divided by means of parallel seams into a number of small sachets for the purpose of being able to separate the parts readily from one another and to use each part separately.

The pad may be produced by stuffing one large cushion or pad corresponding in size to the number of small sachets, the stuffing material of which is preferably perfumed. The pad is then divided by a number of seams to form small sachets such as scent sachets. For instance a number of hollow or hem-stitch seams may be formed crossing one another by means of a hem-stitch sewing machine, the cross threads being partly interlocked and also connected by threads with the edge or border of the pad, so that each sachet forms a complete and separable part. An interstice is formed between the sachets which can be readily severed from one another.

The hollow seam presents the advantage that the cut edges remain clean and do not

form fringes. The cost of production is considerably lessened in this way as the difficulty of sewing small sachets in the machine is thus avoided. The dealer also benefits by being able to stock the pads in large pieces of which he can give a greater or smaller number of parts to his customers according to requirements.

The invention is shown in the accompanying drawings in which:

Figure 1 is a plan view and Fig. 2 a section on line X—X of Fig. 1.

In these drawings *b* represents the small individual pads and *a* the seams connecting the pads together.

Having described my invention what I claim and desire to secure by Letters Patent of the United States is:—

A cushion comprising two breadths of fabric carrying between them a filling and connected together by hollow seams that cross one another, so as to produce separate small cushions that can easily be separated from each other, the point of separation being sewed so that it will not ravel out.
