

## CIGAR-TIP PERFORATOR.

To all whom it may concern:

Be it known that I, Augustus W. Ste-PHENS, of Waltham, in the county of Middlesex, and State of Massachusetts, have in-5 vented certain new and useful Improvements in Cigar-Tip Perforators, of which the following is a specification.

This invention relates to cigar tip perforators, adapted to be carried in the pocket, 10 and provided with a cavity to receive one end of a cigar, and with a perforating pin projecting into said cavity, and adapted to

perforate a tip inserted therein.

The invention has for its object to provide 15 a cigar tip perforator of this character, with a handle portion which enables it to be readily manipulated, and is at the same time adapted to serve as a storage receptacle for another article, such as a cork screw, the 20 whole being adapted to be carried in the pocket of the user.

The invention consists in the improved device which I will now proceed to describe

and claim.

25 Of the accompanying drawings, forming a part of this specification,—Figure 1 represents a perspective view of a cigar tip perforator embodying my invention. Fig. 2 represents a longitudinal section of the same. 30 Fig. 3 represents a view similar to a portion of Fig. 2, showing a different form of cigar perforating or cutting device.

The same letters of reference indicate the

same parts in all the figures.

35 My improved device comprises a solid body portion a', which is preferably made of wood, and has at one end a longer extension a, and at the opposite end a shorter extension  $a^2$ , the body with its two extensions 40 preferably forming a cylinder, of suitable size to be conveniently carried in a pocket. The shorter extension  $a^2$  has a cavity e open-

ing at one end of the cylinder.

f represents a perforating device or pin, the 45 shank of which is firmly embedded in the body a', the pointed outer end of the pin projecting into the cavity e, so that it is adapted to penetrate a cigar tip inserted in said cavity. To enable the pin f to be firmly and 50 durably engaged with the body a, I find it !

highly desirable to drive the pin entirely through said body, as shown in Figs. 2 and 3. To avoid excessive resistance to the insertion of the pin in the body, I reduce the length of the body to the minimum required 55 for a sufficiently firm engagement of the pin with the body, the length of the body being such that it would be too short without the extension a to be conveniently manipulated by the operator in perforating the cigar. 60 The extension a provides a sufficient length of grasping surface to enable the device to be conveniently manipulated as a cigar tip perforator. The extension a is further utilized as a storage receptacle for a cork screw  $c,\ 65$ said extension being provided with a cavity b adapted to receive the spiral portion of the cork screw, as shown in Fig. 2.

The extension a may be used for holding toothpicks or other articles usually carried 70 in the pocket, a suitable stopper being provided for closing the mouth of the cavity b.

It will be seen that the body portion a' is made of such length that the pin f may be readily forced through it, and that the exten- 75 sion a compensates for the reduced length of the body  $a^7$ , so that the device is adapted to be conveniently manipulated as a cigar perforator, the extension a also serving as a holder for another article or articles.

I claim:

A cigar perforator composed of a rod of penetrable material, having a solid body portion, and longer and shorter extensions at opposite ends of the body portion and inte- 85 gral therewith, said extensions having oppositely opening cavities, and a perforating pin having its shank driven into the penetrable material of the body, and its point projecting from the body into the cavity of the 90 shorter extension, the said shorter extension and pin serving as a cigar perforator, while the longer extension serves as a handle for the perforator and also as a storage receptacle.
