


SHOULDER-PAD.

To all whom it may concern:

Be it known that I, DAVID W. BARTRAN, a citizen of the United States, residing at Carson, parish of Calcasieu, Louisiana, have in-5 vented a certain new and useful Improvement in Shoulder-Pads, of which the following is a full, clear, and exact description, such as will enable others skilled in the art to which it appertains to make and use the same, ref-10 erence being had to the accompanying drawings, forming part of this specification, in which—

Figure 1 is a front elevation of a portion of a person's body showing my improved shoul-15 der pads in operative position, one of the pads being shown in section; and Fig. 2 is a perspective view of the pads.

This invention relates to pads such as are placed underneath a garment for the purpose 20 of building out the garment and thus improving the appearance of the person wear-

mg same.

It has heretofore been the practice to insert layers of wadding or padding in the 25 shoulders of a coat at the time the coat was being made so as to build out the garment and thus produce a broad shoulder effect.

The object of my invention is to provide a pair of shoulder pads that are not connected 30 to or embodied in a coat but which are adapted to be worn underneath the outer shirt or shirt-waist of a person.

One advantage of my pads is that they will give a person a broad shoulder effect 35 even when the person's coat is removed.

Another advantage is that the shoulders of the person wearing the pads will always look the same no matter what particular coat he may have on. And still another 40 advantage is that they reduce the cost of manufacturing coats for they overcome the necessity of placing padding in coats at the time they are made.

Referring to the drawings which illustrate 45 the preferred form of my invention, A designates a pair of shoulder pads which are joined together preferably by means of an elastic strap 1 that passes across the back of the person wearing the pads and an elastic 50 front strap 2 which passes over the chest of

with a buckle 2a. Each shoulder pad consists of several layers of padding or wadding that are carried by a sleeve portion 3 and a shoulder portion 4 which are connected to- 55 gether by one or more rows of stitches that also pass through the layers of padding, said shoulder and sleeve portion being formed of any suitable kind of cloth or pliable material.

The padding consists of a number of thin 60 layers 5 of material of gradually increasing dimensions lapped one upon the other and cut to follow the lines of the shoulder so that a gradual broadening effect is produced. The pads are adapted to be worn underneath 65 the outer shirt or shirt-waist of a person so that they give a broad shoulder effect even when the person's coat is removed. They, of course, build out the shoulders of a person's coat and thus impart to the coat a 70 finished and well-tailored appearance. The pads also change the natural contour of the outer points of the shoulders of the person wearing the pads and as they are not subjected to the weight of the sleeves or body of 75 the wearer's coat they will not be drawn or forced out of shape. Consequently they prevent a coat from breaking or crushing down at the shoulders. The pads do not shift or slip out of place because they are held in po- 80 sition by the elastic bands 1 and 2 which permit free movement of the arms and shoulders of the person wearing the pads.

Having thus described my invention, what I claim as new and desire to secure by Letters 85 Patent is:

1. As a new article of manufacture, a pair of shoulder pads adapted to be worn underneath the outer shirt or shirt-waist of a person and each consisting of a tubular-shaped 90 sleeve portion and shoulder portion which carry several layers of padding, and members adapted to pass across the back and chest of the person wearing the pads for connecting said pads together; substantially as de-95 scribed.

2. As a new article of manufacture, a shoulder pad adapted to be worn underneath an outer shirt or shirt-waist and consisting of several layers of padding of gradually in- 100 creasing dimensions lapped one upon the other and cut to follow the lines of a person's said person, the front strap being provided

shoulder, a tubular-shaped sleeve portion and shoulder portion connected together and joined to said layers of padding, and elastic members connecting said pads together and adapted to pass across the back and chest of the person wearing the pads; substantially as described.
